MEMBER DOUGHERTY: Mr. President, Public Property Capital Improvement will also meet Monday, 5:30.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks Open Forum, City Business Only. We have 1 person signed up to speak, Theodore Hunter.

MR. HUNTER: Good evening, first of all, I'd like to thank you for giving me the opportunity to speak tonight.

PRESIDENT DENCZAK: State your name and address please.

MR. HUNTER: My name is Theodore Hunter; I now live at 1601 - 4th Street NE, Canton, Ohio.

PRESIDENT DENCZAK: Okay, Mr. Hunter, according to Council Rules, you have to state your specific subject matter and you have just simply said "city of Canton, Ohio." Can you tell me what your specific subject matter is going to be?

MR. HUNTER: My specific subject matter is the demolition of my home and the breaking-in of my home.

PRESIDENT DENCZAK: Okay.

MR. HUNTER: Okay, January 10th, my sons and I were coming from Mt. Union College watching a wresting match. I told them to drop me off at home at 1901 - 4th Street SE. The utilities at that home, the taxes are paid up; utilities are paid up. They've never been turned off; I've had them on for more than 5 years. I'm living in that home; that home is furnished. It's not the neatest home, but my tools were in that home. My sons and I worked extremely hard and spent a lot of money working on that home. Over the summer, I decided to move in. We put a new roof on the homes, my sons and I climbed that building, we put the roof on. We tuck-pointed the basement. We put a floor in the basement. We put windows in the house. We did extensive dry wall in the house. We invested a great deal of money in that house; my family did. This was a house that we were all supposed to move into. This house was 80 to 90% completed. The City Code Department promised a lawyer that I had asked to have an injunction to stop the City from tearing down my home. This lawyer told me that Gary Baker, the Code Enforcement Officer, told him he would allow at least one more date, at least one more date, so we could get this injunction. That injunction was overridden by the Safety Director. I went to talk to Mr. Hunt and Mr. Hunt was very indignant with me. He asked me why do you have 2 houses. It would matter if I had a thousand houses; Mr. Hunt would not have asked that question to anyone else. I don't believe he would have. He was very indignant. I went to talk to the Mayor; I left her my number. I asked her secretary to call me. The Mayor has not responded to me yet. On the Martin Luther King Day celebration, the Mayor said and I quote, some of her goals were to build and not destroy, to help and not to hurt. The following day, I watched my bedroom fall into my basement. I was writing a letter to the Mayor at that particular time. I was at DeHoff Library. A friend of mine came in and said do you realize they're tearing down your house right now. How would you feel if you invested your money, your time, your children's time, how would you feel if someone took all that you can leave to your children? See black men are always ostracized for not doing what they're supposed to do. I have raised 4 children, 3 of my children are in college at this present time. The 4th son is on the honor roll at Timken High School. People know me from the community. Mr. Hart, you know me from Crenshaw, I was the wrestling coach. I was the one that went 10 and 0. And nobody has done that since.

PRESIDENT DENCZAK: Mr. Hunter, I'm sorry, but under Council Rules, your 3 minutes are up.

MR. HUNTER: I understand, sir.

PRESIDENT DENCZAK: I'm going to ask the Mayor...are you aware of this situation?

MAYOR CREIGHTON: Mr. President, I was made aware of this situation.

PRESIDENT DENCZAK: What is being done...was your house torn down?

MR. HUNTER: Yes, sir, it was on the 17th.

PRESIDENT DENCZAK: And it was 80 to 90% complete....

MR. HUNTER: Yes, sir.

PRESIDENT DENCZAK: And you're remodeling it....

MR. HUNTER: Yes, sir, we were.

PRESIDENT DENCZAK: Mr. Hunt, are you aware of this?

SAFETY DIRECTOR HUNT: Mr. President, I have spoken to Mr. Hunter at length about this home and about other homes that he owns in the City. Any action taken by the City of Canton Building Department is legal. We provided the proper notice and unfortunately I can't speak any further because it's my understanding that Mr. Hunter has an attorney and we may be involved in litigation in this matter.

MR. HUNTER: Mr. Denczak, people of Council, I was not given a notice. January 10th, my home was broken into, my water was turned off and the water meter was taken. Now I was responsible for that water meter. I went and called the Water Department around midnight and they told me that the Code Department had told them to go in the house. As I further talked to the Water Department, they told me that the man told them, it looks like someone lives here, this house is locked up. They told him to break into my house anyway. How would anybody feel if someone broke into their house and took something out of it.

PRESIDENT DENCZAK: Mr. Hunter, just a moment please. Was this home listed on the tear-down sheet?

SAFETY DIRECTOR HUNT: That's correct.

MR. HUNTER: I was living in the home. One of the Code Officers came to the home during the summer. I took her through the home and my sons can witness this. I took her through the home, I showed her where we were going. She stated, you basically have things done. The only thing you really need to do is some painting, a little more dry wall. I'm allergic to paint; I painted on the outside of the house. I cannot paint inside of a house. Now this is documented proof; you can call Aultman Hospital. I cannot, I'm allergic to paint. I cannot paint. That's the only thing that really needed to be done. Okay?

PRESIDENT DENCZAK: Well, sir, because I'm told now that you have a case pending against the City, I suppose sir, I don't think we can discuss this any further...

MR. HUNTER: Sir, I don't have a case...

PRESIDENT DENCZAK: I'm going to ask my Law Director to respond...

MR. HUNTER: I don't have a case pending again the City; I have not even made a formal complaint about the tearing down of my home. The only complaint, formal complaint, that I have made was that they broke into my home, invaded my privacy. That's what I complained about formally to the City. But I will make a complaint about the demolition.

PRESIDENT DENCZAK: Well, sir, I want to see where the city of Canton stands. Law Director Martuccio?... Are you familiar with this?

LAW DIRECTOR MARTUCCIO: Mr. President, I believe that a restraining order was attempted to be filed or had actually been filed last week on Tuesday or Wednesday...

MR. HUNTER: Yes, sir, I think so...no, it was Tuesday that it was supposed to be filed. As it was supposed to be filed, they were tearing down my house. When I called the young lawyer, he said that Craig Chessler had informed him that the house was being demolished at that particular time.

LAW DIRECTOR MARTUCCIO: Mr. Hunter, I would probably recommend for your own benefit that if you have indeed retained Mr. Morris...?

MR. HUNTER: Yes.

LAW DIRECTOR MARTUCCIO: ...that perhaps he and I continue the conversation. You want to be careful about what you say here on the record if you do decide to file litigation or if there is a lawsuit pending, you want to be careful for your own sake...

MR. HUNTER: The only thing I asked Mr. Morris to do was to file an injunction to stop tear-down of my home; that's all that I asked him to do.

PRESIDENT DENCZAK: Okay, sir, thank you. (MR. HUNTER EXCUSED FROM MICROPHONE)

MR. HUNTER: Thank you.

PRESIDENT DENCZAK: Whose ward is this home in?

MEMBER ZACHARY: Mr. President, that's in the Fourth Ward and I am a bit concerned, because it seems like if we have a process for demolition or you're not or we don't contact the homeowner...there's a fundamental problem with that. Mr. Hunter, I do have to ask, were you at all contacted in any way, shape or form, and offered any options as far as getting this home off of the demo list, whether recently or in the past?...

PRESIDENT DENCZAK: Well, we can't do that now... (*REFERRING TO THE FACT THAT MR. HUNTER IS NOW SEATED IN THE AUDIENCE & IS NOT PERMITTED TO SPEAK*)

MEMBER ZACHARY: I'm sorry, Mr. President.

PRESIDENT DENCZAK: I'm going to ask that you meet with the gentleman after Council Meeting and see what you can resolve, okay?... You see the Councilwoman after the meeting.

MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under Miscellaneous Business. Is there any miscellaneous business?..

MEMBER CARBENIA: Mr. President, under Miscellaneous, I would like to ask, I mean, how can somebody

from the Water Department break in a door to go in and do something in a home? I mean if we're going to have to go into somebody's home, don't we use a police officer to go? I mean, that's what happened with some homes that I had there on Maple Avenue, I had to have police officers go there and escort the people in to clean the house and they had some things they had to do at this house. So I don't know how we would send me out to get into somebody's house and break their doors and get into their home; that is invasion of privacy. I mean I know that the Water Department, the guy just done what he was told to do, but it seems to me that it's not correct to do it that way.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER HAWK: Mr. President, I'd like to thank Director Hunt. On Friday, the 13th, it was a particularly nice day, very sunny, very warm. And there were prostitutes all over the corner of 6th & Shorb. I put in a call to Mr. Hunt. He immediately dispatched a cruiser which really helped in alleviating the problem. I think the bigger concern along these lines is the fact that I stood on that corner watching cars go past; I didn't know whether I should call for traffic department directions or vice department to chase the prostitutes. There were at least 2 new body style Chrysler 300s that circled continuously. One very nice BMW down there looking for, I don't know what they were looking for, but you don't go around that block 5 or 6 times without looking for...

PRESIDENT DENCZAK: Don't say a 2005 Sable. (REFERRING TO HIS OWN AUTOMOBILE)

MEMBER HAWK: No, sir, it was not. I would recognize that vanity plate. But...some of the folks actually did have vanity plates on the cars. So I think we might want to explore the fact that we need to begin looking into john-sweeps...just to try to alleviate some of this problem in order to pick up the, instead of the prostitutes, let's start looking to the people who frequent the prostitutes. I thank Mr. Hunt for his very expedient remedy for meeting that problem. Thank you.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER WEST: Mr. President, just a quick question to Safety Director Bernie Hunt. Again, once again, the community has applauded the efforts of Council putting up security cameras but now that we got one up, we would like to know when the others are coming?

SAFETY DIRECTOR HUNT: Mr. President, I met with representatives of Barco Security last week; they showed me the latest in technology for the wireless camera. So I'm hopeful that at some point in time, we'll be able to bring that in and show Council how that works.

MEMBER WEST: Thank you so much; our community is definitely desperately needing it.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER ZACHARY: Mr. President, if I could just ask Safety Director Hunt as well, when you bring in people to do their demonstration, could we make this a public meeting because I've had numerous questions from constituents who want to know how it works and what the follow up will be from the Police Department.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn; roll call vote please.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN ROLL CALL: 12 YEAS, 0 NAYS

PRESIDENT DENCZAK: This meeting is adjourned.
