I'm not unhappy with the payment scheduled; I'm unhappy with the number of sergeants and lieutenants that are included in this ordinance. I thought several years ago when the FOP negotiated to reduce the number of lieutenants and sergeants due to attrition, I was thrilled. I believe that the number of officers versus patrolmen, that if anybody ran their business that way, they would be out of business. I wholeheartedly believe that we do need working supervision and my concern is, is that when we are paying detectives sergeant rank and they're not supervising anybody, then why are we paying them sergeant rank? My concern is the number of sergeants, lieutenants, majors, chief...for the non-bargaining personnel is at a ratio of at least 3 to 1. If you take out some of the sergeants that are detective, it's 5 to 1. I will vote for this, but I believe that we ought to have more CPPA, more patrolmen in the streets, than having...and having less officers. Thank you.

LAW DIRECTOR MARTUCCIO: Mr. President, while I'm not a member of, nor do I head a committee, I apologize for not having been in Caucus, but if you recall, we wanted to have—we being the Law Department and the Administration—at some point wanted to have an informational session with Council about the dozen or so gas wells that are on the Water Pollution Control Center's property. Bringing in experts to talk about what's there, the infrastructure, the price we can get and renegotiate and so on and so on and so on. Did the Environmental and Public Utility want to meet next Monday at 5:30? I believe that was the last communication we had—if that's Council's pleasure?

LAW DIRECTOR MARTUCCIO: If that's Council's pleasure, yeah.

MEMBER GRIFFIN: Fine. I'm sorry, 5:30.

LAW DIRECTOR MARTUCCIO: And I'm sorry I forgot to bring that up again.

# PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks Open Forum; we have two people signed up this evening. The first

one is Mohammad Rashidioun...am I pronouncing that right?---- (INAUDIBLE RESPONSE) Right there to that microphone on your left.

MR. RASHIDIOUN: Thank you for the opportunity given to me tonight. This is my first experience being here.

PRESIDENT DENCZAK: State your name and address please.

MR. RASHIDIOUN: First name is Mohammad...M-O-H-A-M-M-A-D...Rashidioun...R-A-S-H-I-D-I-O-U-N. I'm a case manager by profession...worked in social services around this are for the last 15 years.

PRESIDENT DENCZAK: For the record, state your address.

MR. RASHIDIOUN: 813 - 18th Street NW, Canton, Ohio, 44703.

PRESIDENT DENCZAK: Okay, go ahead.

MR. RASHIDIOUN: I am here to present to you a project that a group of local businessmen have worked on to bring the professional indoor soccer back to Canton. We believe that after 10 years of absence of The Invaders, the market for soccer has dramatically increased. We see a great number of small kids starting to play soccer, girls and boys. Particularly in Jackson Township, North Canton and in Canton itself. There are a group of very good, qualified soccer clubs around here locally, such as BOCA (UNSURE OF SPELLING) United, North Canton Strikers, and other feeder programs that are producing great soccer players to the local high schools and hopefully to the colleges around the country. We believe by bringing the professional indoor soccer back, we will provide a very healthy environment where exercise and good sportsmanship is very essential. We believe that we can create an environment where the entire family can get together and spend quality time together while watching a competitive soccer game. Our hope is that the City will accommodate for us since we are very small business people to have some kind of financial capacity to be able to play at the Civic Center because we believe that's the most appropriate place where people are used to coming and watching soccer from all parts of northeast Ohio. We believe that the market is so vast at this time that there is only one competition and that's in Cincinnati, it's called Cincinnati Excite. The rest of the northeast Ohio actually is pretty much out of any type of professional indoor or outdoor soccer team. We believe that by being able to provide this environment, we can bring outsiders to Canton city and help Canton city by those outsiders spending their tax dollars in here and visiting all the sites in the Canton area and enjoy the city and its people.

PRESIDENT DENCZAK: Sir, I'm sorry but under Council Rules, your 3 minutes are up. So bring your remarks to a close.

MR. RASHIDIOUN: Three minutes? Okay. As I mentioned, one more point I'd like to make here is that probably is something to add to what The Invaders were all about is that we are committed, personally, as a social worker and the rest of the members of this club, are absolutely committed to be intimately connected to the community, to the children, to the schools, by providing a healthy environment, by coaching and mentoring the children around the county, especially in the Canton area. As I mentioned earlier, our problem is financial and we appreciate any help that you can provide or direct us to...whether is be through a grant or direct help, assistance from the City. We appreciate that and I think it would be beneficial to the entire community.

PRESIDENT DENCZAK: Thank you, sir.

MR. RASHIDIOUN: I'd like to submit a copy of this to the Mayor....(HANDING SOMETHING TO MAYOR CREIGHTON) Thank you very much.

SERVICE DIRECTOR CONCATTO: Mr. President, for Council's information, we are meeting with the Canton Crusaders soccer team on February 8<sup>th</sup> at 1:00 in the Mayor's Office to discuss rental options at the Civic Center and to see what their plan is for 2006. I believe Councilman Casar has agreed to join us at that meeting for Council representation.

PRESIDENT DENCZAK: The next speaker is Darnell Austin.

MR. AUSTIN: Mr. President, my name is Darrell Austin, I live at 1427 Sycamore Avenue SE, Canton, Ohio, 44707 is the zip code. I'm here in regards to the EPA's most recent approval of a solid waste rail transfer station and it's located at 1800 Allen Avenue SE. And the EPA seems somehow or another wants to disregard those individuals who live in that residential area. And as a board member on those committees for building a better community, I stand here today in shock because no one knew about it. And this is how they try to sneak attack these things in on you as a City. Respectfully, I immediately called the Mayor and left a message with her, as well as Commissioner Regula, who both have corresponded with me as well. This permit approval authorizes the construction of a proposed JMW solid waste rail transfer station and allows JMW to increase the amount of solid waste transferred at the transfer facility. Those individuals in the southeast end community as a matter of fact are disapproving of such an action. We would hope that this great city would stand behind us just as God promised Jacob, Isaac and Abraham, the land, we deserve it as well in the southeast end community. Thank you, Mr. President.

PRESIDENT DENCZAK: Is this in your ward, Member Zachary?

MEMBER ZACHARY: Yes, it is, Mr. President. I had spoken with Darrell Sunday, I believe it was, and he had mentioned that he was going to be meeting with the Mayor. I just want to ask, is the City of Canton going to go through the formal appeal process to appeal this decision?...or Mr. Service Director?...Law Director?...

LAW DIRECTOR MARTUCCIO: Mr. President, Member Zachary. I would like to invite myself to that meeting if possible. The problem is I understand it was clearly stated by the speaker that it is something not welcome here. It is something perceived as a threat. I know there are other cities around Ohio fighting these very things as we speak. My old home town of Girard included. I understand that Mr. Hagan has recently introduced some legislation regarding the future tighter control of these areas. Unfortunately for we legal officers of cities, we're sworn to uphold the law. If the law is currently Constitutional, if our local Health Department says it has met with the standards they are sworn to enforce, then I'm not sure we can appeal ourselves. For example, if it is has met the muster of the Health Department, I'm not sure that we can appeal against our own clients at the Health Department. What I do want to do is find out more about it. Certainly the facts are very crucial to the issue. Look into the law a little more and see if there is some remedy here that we can pursue. Without knowing more, that's what we intend to do at this point.

MAYOR CREIGHTON: Mr. President, I just got the e-mail this afternoon, Kelly, from the Health Department. Darrell had called over the weekend and I did return the call to him yesterday actually. And so we're going to get something together and Joe and I just talked about it tonight. So we just got the information today.

MEMBER ZACHARY: I'd like to invite myself to that meeting as well.

### **MISCELLANEOUS BUSINESS**

PRESIDENT DENCZAK: We're now under Miscellaneous Business. Is there any miscellaneous business?..

MAYOR CREIGHTON: Mr. President, if I may, I would just like to extend my appreciate to City Council this evening. What you did tonight was momentous in the fact that you passed the EGI and that is so important to give our Economic Development Department an additional tool that we can continue to grow this city. And I would also like to publicly thank Joe Carbenia; he was part of the committee that worked along with City Council and the Administration once again showing that there is a cooperation. And I mean it sincerely, what you did tonight is a step forward for this city and I know that we will be thanking you again in the future.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

SERVICE DIRECTOR CONCATTO: Mr. President, first, we have a public works committee meeting on February 1<sup>st</sup>, 2006 at 2:00 at the Engineer's Office. I invite Council, if they wish to attend. These are our meetings that we have monthly to talk about storm sewers, to talk about water problems, to talk about street problems. We try to cover all of the issues that we have. That's at 2:00 at the Engineer's Office so anybody, any Councilmember wishing to attend, may do so. That's Wednesday...what is today, I have trouble with today, I've been in mediation all day. The second thing I would like to say is that we now have an agreement with the Urban Housing Foundation to transfer to them the money necessary to purchase enough lots in the Summit area to build 14 market-rate housing. They have purchase agreements with the necessary number of properties to build these 14 houses. Those purchasing agreements will probably go into effect tomorrow because I think the deadline was the 31<sup>st</sup>. They will use our, the City's money, to do that. And they are on their way to begin this project that was defined almost a year ago.

PRESIDENT DENCZAK: Is there any other Miscellaneous Business?...

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn; roll call vote please.
