PRESIDENT DENCZAK: ...move. Member Carbenia.

CHIEF OF STAFF ALLEN: You did that to me once Joe, you're not gonna do it again. If I could....

PRESIDENT DENCZAK: Member Carbenia, are you asking for the floor?

MEMBER CARBENIA: No.

PRESIDENT DENCZAK: Any other miscellaneous business?

CHIEF OF STAFF ALLEN: Mr. President.

PRESIDENT DENCZAK: Chief of Staff, and remember, since you're a Notre Dame graduate, you just get one

minute.

CHIEF OF STAFF ALLEN: One hour? Thank you.

PRESIDENT DENCZAK: One minute.

CHIEF OF STAFF ALLEN: First I want to thank the Mayor for giving me the opportunity to sit in this chair for the last 6 months and I have learned a lot. I learned about city government, learned a lot about dealing with and working with people who maybe don't have the same, I don't wanna say beliefs, maybe that's not the right words but the same of gettin' to the same end. Working with Bernie and Joe's been a delight and I'll save my comments to them personally. The Council, you know, I'll go around the room. Butch, you know, I admired you for the way you ran in your election. You ran hard, you worked hard, you got elected. I see that carrying through in your first two months. Keep it up. You're working hard and you're helping move Canton forward. Richard, if you ever bring me Ohio State underwear (*LAUGHTER*) to wear again, I will not get you any more tickets to Notre Dame games. Okay? It's as simple as that.

CHIEF OF STAFF ALLEN: But, I've enjoyed working with ya and keep going on your recycling program. David, they told me you were grumpy, moody, hard to work with. They were right. (*LAUGHTER*) They were right. Actually, I found you very easy to work with, a great input on things, I enjoyed it very much and I'm, I'm gonna miss my dealings with you. Terry, what can I say? We're the two best rib-eaters and judges in the City of Canton. I look forward to dealing with that in the future and keep your same energy. You brought a lot to City Council. Kelly, ya can't scheduled the Zachary Dachary nights on the nights of Notre Dame football games. Okay? I expect another invitation. (*LAUGHTER*) I've enjoyed workin' with you. Good luck in all your endeavors. Grif, you got me into the K of C, but it's not good to just get into it. Ya gotta get me active. Okay? Monday nights, I'll be available on Monday nights. Some of the time. Okay? So, I'll look forward to get a little more involved there. RA I'm gonna skip. Cindy, best of luck. I was in your shoes 13 months ago, 14 months ago. You're doing great. Keep that smile going. It's a friendly smile. It welcomes people and they look forward to that. Deb, I beat ya outta here. (*LAUGHTER*) You know, ya thought you were gonna leave, but I'm

beatin' ya outt here and again, I appreciated your friendliness when I first came on board. Your helping me get those, those, those, communications in at just a minute before 9 and I appreciate all the help you gave and all the conveniences you gave me.

PRESIDENT DENCZAK: Your three minutes are up. (LAUGHTER)

CHIEF OF STAFF ALLEN: Thomas.....

MEMBER CARBENIA: I move we adjourn.

CHIEF OF STAFF ALLEN: Thomas, we had fun working on the O'Jays, I think. It was, it was a good thing and hopefully when we do this again this year, it'll be better for the citizens of the city. It was good for them last year, I hope we can make it better. Good luck in all your endeavors and your initiatives. Just keep going at it, you've got a lot of energy. Greg, what can I say? You made the best of what could have been a awkward situation. We worked well together and I appreciate your professionalism. Bill, I look forward to the debates about where the Ribs Burn-off should be. Okay? No, I respect you as a business man and unfortunately, I didn't get to work with you here at City Council and I did give ya, I gained a lot more respect for you the night you lost the election for Mayor and I called you and told you so. I thought you were a class act that night. Mary, I haven't got to know you very well, but you know what, the next time I go to Notre Dame, you'll fit in with that red hair out in at Notre Dame much better than Casar does with his gray hair. Okay. I'm gonna skip Joe for a second. Cas, I've enjoyed everything. You've been a good leader, you've been there when we asked you to get You and Joe in particular. You know, you've had an open mind. involved in things. I think we've accomplished things because of that. Papa Joe, what can I say? You know, this is like the west meeting the east ya know. Here's a guy whose ideas are totally different than mine. I'm as non-union as they become, as you can be, he's as union as they can be. But, ya know what? We got along, we respected each other, we accomplished some things together. You welcomed me to this city and I love him, he's a great man (VERY EMOTIONAL COMMENTS) Thanks Joe. Joe Martuccio, you welcomed me, you looked for my opinion at times. I'm not sure I gave you the right ones, but I gave them to you anyway. We had a great mutual respect for each other and, and I hope that'll continue and I've enjoyed being, workin' with you. Ray, yeah, I did buy all those drinks, I just never included you, but tonight Ray, I'll buy as many drinks as you want tonight.

SERVICE DIRECTOR CONCATTO: How many did he buy for you?

PRESIDENT DENCZAK: I'm gonna show you what kind of luck I got with you. He's gonna buy tonight and I gotta red eye.

CHIEF OF STAFF ALLEN: Ray, I'll give ya a ra.....

PRESIDENT DENCZAK: A rain check?

CHIEF OF STAFF ALLEN: I will give you a rain check.

PRESIDENT DENCZAK: I'll accept it. I'll accept it.

CHIEF OF STAFF ALLEN: RA, dear friend, you and Papa Joe made my, made working in City Hall fun. You opened the doors to the Auditor's office, there was a lot of things I didn't know. Your staff and you answered them, helped me through some things. This government accounting is a lot different than private accounting, trust me Chip. You should be taken RA and Gary Young to lunch for a number of times! But, your friendship,

you know, I know, we started out with me being a coach and you being a ball player in the southwest end, but you know what, you remember, you remember things from that and, and we've become very good friends and you've made, you've made, you and Papa Joe have made have made my stay in City Hall wonderful, and I'm not going away. I'm not going away. We'll continue to have lunch, but, thank you. You don't know how much it meant. Thanks. Thanks Ray.

MEMBER CASAR: Mr. President. I just wanna say that I'm glad he was only here 16 months cuz if he had four years, we'd be here 'till tomorrow. (*LAUGHTER*) Mr. President, I move we adjourn.

SERVICE DIRECTOR CONCATTO: Mr. President. I just want to ask Mr. Casar how much of that trip to Notre Dame he remembered?

MEMBER CASAR: Is that before or after the turnpike?

PRESIDENT DENCZAK: I'll tell ya what, let's ask RA Mallonn about that trip?

AUDITOR MALLONN: As an employee of the firm, I can't answer that question, sir.

MEMBER CASAR: Mr. President, I move we adjourn; seconded.

PRESIDENT DENCZAK: Moved and seconded that you adjourn; roll call vote please.

NO REMARKS PERMITTED ON THE MOTION TO ADJOURN ROLL CALL: 12 YEAS, 0 NAYS

PRESIDENT DENCZAK: This meeting is adjourned.
