Originally, the communication came from the Clerk of Council announcing she was taking her retirement and the matter was referred properly to the Personnel Committee. On several occasions when these issues came before Council, there's been various means of appointing a replacement. Now, it was referred to

the Personnel Committee. Somehow, this whole thing got outta whack and one member of Council has usurped the authority of Committee Chairman and has taken care of this and how this came in as the Council Of The Whole Resolution, I want to know how that can happen. Law Director.

LAW DIRECTOR MARTUCCIO: Mr. President. You asked a very good question. I'll try to answer it as best I can. We are a Statutory city and we are controlled largely by the Ohio Revised Code. From it, all authority flows into whatever body is using the law. In this particular case, the Ohio Revised Code Section 705.10 and 731.04 clearly say that it is the legislative authority or Council that chooses it's Clerk and 731.04 makes it very clear that it has to be a majority of the elected Members of Council as our Rule 8 stands parallel, the one that was read into the record just a short time ago. Being that, a majority of the elected members of Council has to make the appointment, that has been legally done tonight. Your question though goes to how it got here, if I understand it correctly. When the communication was referred to you, to the Personnel Committee, it probably appropriately said to the Personnel Committee, we have a vacancy to consider, however, our rules are unclear about how that particular process takes place if it's not a formal ordinance. Informal Resolutions, according to our Rule 24, can be brought forth by any Member or group of Members of Council. So, pursuant to Rule 24, an Informal Resolution did find it's way onto the agenda today, and it, our rules say that it can be used to confirm an appointment and so on. Rule #45 talks about whole Councils, but usually that takes place if it's an ordinance. If there had been an ordinance, I would say that it would, it would have and should have gone to the Personnel Chairperson and been, and would necessarily have been signed out by two of the three or all three of the three to make it to the floor as an Ordinance. Being that, a communication was referred to, the Committee, it may have been within the Chairperson's prerogative to allow the Majority Leader to conduct the process to present a candidate to this Council, because again, it all depends on what a majority of this Council does on the record. I can look at it further if you like, Mr. President, but for now, I believe that you have a valid election of a new Clerk of Council.

PRESIDENT DENCZAK: Yes, I understand that Law Director, but, I wish you would look into it further because that's a dangerous precedent. I want Council to be aware of that. It's a dangerous precedent. I have no problem with Cindy, she's an excellent worker. I have no problem with your decision and I'll abide by your decision, but be very careful of this one-man Council!

#### PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT DENCZAK: Public Speaks Open Forum, City Business Only. We have one person signed up to speak; Robert Fisher.

MR. FISHER: Mr. President, Mayor and Members of Council. My name is Robert Fisher. I reside at 2634 Gladiola NE. My business is 20 years old at 1010 Walnut Avenue NE and I come to talk about the public announcement of the community clinic. To give a little bit of historical perspective and ask the Council, and the Administration to go on record of support of keeping it where it is. That clinic wasn't just put there by mistake and Mr. President, I come here with a heavy heart. I very seldom get emotional. I used to, I don't anymore, but I'm here in the spirit of Charles Ede, who really fought for that building and my own emotional feelings about where it is and it's attributions to the community. It didn't start just by Charles Ede, it was started because there was a lack of medical services on the east side of the city and about 30 years ago, there was a committee and I know Ed Cox was Chairman of that committee that the President of Council Mr. Denczak was on that Committee and another 40 people and they tried to determine and made a study of why there needed to be some medical facilities, like a clinic on the east side. It took a long time. It took Councilman Ede with this Council, some of the members of this Council, and Mayor Watkins to realize it a dream and it also took the old Harter Bank, now Key Bank that had sold the building and had given it to the city. So, there's a lot of things that could happen and in recent years, your Council and the Administration years, had given that facility more than \$800,000. It bought property. In fact, one of the properties it bought was from a lady that didn't want to sell it and she was a lady that had been in this city for a long long time and in fact, she just moved to Atlanta, 80 years old and she still walked up and down 19<sup>th</sup> Street and she said I'll sell this for one reason; for the clinic. Now, yes she probably got a fair market value, but that was a beautiful home. You see some members of family here but that was one building they bought, and then they bought another building. There's never been any problem in that building. And then, the second part of this discussion is just as 4 or 5 community organizations, 501C3s have met with the Mayor, have met with the Councilmen to begin putting together what we call the East Tusc Corridor Improvement. Now why, why was that? Well, there's been certain things going on in that area; public things that now we need to private invest in, private invest in of the family dollar. The fire station at 4<sup>th</sup> & Belden. The new Belden School. The renovated Hartford School. The new library. Mr. Coon is planning something at, at the corner of East Tusc and Belden, that old castle. In fact, I'm glad to see that house that was torn down next to it so that you do see some vacant property. Habitat. When we talk about East, East Tusc corridor, we went from 4th Street SE.....

PRESIDENT DENCZAK: Mr. Fisher, I'm sorry, but your 3 minutes up, however, because I feel this is a very important issue for the City of Canton, under your new rules, you are allowed another 3 minutes; a total of 6 minutes. It used to be 15 but it's been changed to 6. I'm going to extend you another 3 minutes.

MR. FISHER: Thank you. I'm glad I mentioned that to Councilmember Zachary; it might take a little bit longer because I just feel so important about this city in fact, Habitat has built about 40 homes in that area between 6<sup>th</sup> Street and 4<sup>th</sup> Street between Spring Avenue and Belden. There's also been churches that have been improving in the area. This is like an anchor. This is like an asset, and to remove that asset, without a comprehensive study to 30<sup>th</sup> Street, to somebody's building is totally wrong, particularly when you're not using private people's money and you're doing, you're using taxpayers money both city money that they've used in the past. I don't know if they have any now. Medicare money for people who are getting the services and now, a Federal Grant by the Congressman. I stand here and ask you to do all you can to stop that Board, and I just didn't come here today without trying to talk to them. I talked to 2 Board members today. I called 4, I got 2 of them, and all they did, they tell me they could not talk about it yet because they're having a meeting tomorrow morning at 9:00 and I'll be there to try again and they already told me it was Executive Session. I didn't want to surprise them, I wanted to be courteous enough and being a former Service Director, one of things that you don't like is surprises. You want somebody to tell you you're comin' and that's what I wanted to do as a courtesy to them. Mr. Riley, I tried getting him Wednesday, he wasn't in office. I tried Thursday, he was not in the office. I would have tried Friday, but I followed the Bulldogs and I went this morning and I haven't been able to see him but I'd asked, I'll answer any questions anybody has but I just think that for what Dave Dougherty is doing in the 6<sup>th</sup> Ward for the northeast

end but Kelly's trying to do in the 4<sup>th</sup> Ward along with these groups that are coming together, yes, we'll be back here for some city money. We've mentioned it to the Mayor. We don't know how much yet, but we have a plan of action, and then, we have one report and, and, we just haven't cleared it up yet because we might think it's a predicated lender that wants to build 14 houses in the same area, not counting the city's plans, so please, go on record opposing this. Do all you can and join with us, in fact, coming from the basketball game on Friday, at the basketball game, whatta we gonna do about the clinic? All the social events and church events, this weekend, what about the clinic? What about the clinic? It ought to stay on East Tusc. I'll answer any questions anybody has. Please do something about it.

MAYOR CREIGHTON: Mr. President. If I may, let me be very clear. I spoke today with Congressman Regula. I spoke today with former Mayor Richard Watkins and the 3 of us are adamantly opposed to the move to 30<sup>th</sup> Street. We are distressed that there has been no public discussion. I will tell you that I am further distressed when I called, personally today, to try to obtain the list of the Trustees of the Canton Community Clinic. You should also know that this Body, including the Council and the Administration, does not have any appointees on that Board. We have absolutely no jurisdiction over the Community Clinic other than providing them with a free building, which we have done, through the generosity of this City for the last 10 or 12 years. So, I just want to make it clear that we will fight the move. I do not know what their final intentions are, but I have been troubled that there has been no communication and in fact, I spoke directly with Mr. Cicchini on Wednesday night and a week ago Sunday and he never shared with me that he had resigned. Not that he had to because I don't have that appointment but I find it really disconcerting that they are spending federal dollars and they have taken on no responsibility as far as giving us the reports as we've asked for them.

MR. FISHER: Mr. President. If they had been open, there are some other properties, maybe not there, but in the northeast section and southeast section, that could be seriously considered, and I think that the city owns one of them already beside the Monroe Center but, thank you very much for the time.

MEMBER WEST: Mr. President. Can I just add something for a moment. I've been working with Eric...

PRESIDENT DENCZAK: I'm... Member West, again, when we get under Miscellaneous Business, the chair will recognize you first. I'll recognize you first. Thank you Bob.

#### MISCELLANEOUS BUSINESS

PRESIDENT DENCZAK: We're now under Miscellaneous Business. Is there any miscellaneous business?.....

MEMBER WEST: As I was saying, I been working with Eric Riley on a project, Minority Health Month, which actually is April 1<sup>st</sup> which is also one of my misc, under miscellaneous business. But, I've talked with him specifically about the Canton move or the Clinic move, specifically to the 6 different articles that appeared in the paper and why there was no response. Eric will be back from Washington DC from a conference tomorrow where we had several meetings planned for our event on April 4<sup>th</sup> and subsequently on April 22<sup>nd</sup>, so he will be here to respond to people's questions and I know that their Board is also gonna meet and discuss this so I think people will get their information soon. As I had indicated into the paper and I will preface my statement because Mr. Fisher also approached me on this, Ward 2 specifically, I have not received any calls to that. My understanding is that there wasn't going to be a move. My, I understand that some people said that there was gonna be a reduced stays, I've never heard that. I did hear that they are considering all options and that they are looking to expand their, their base throughout the community because it becomes a federal clinic and they need

more space. That's what I did know and I think that I spoke that to Mr. Balient as well. In addition to that, I want everybody to know that, it's not just serving the poor but it's also serving those working poor and all the agencies that are also around it that will expand it. Now, mind you, being a strong advocate, a very strong advocate for minority health an on April 30th, I'm going up to meet with Minority Health Commission at the State level to convince them to bring an office down here to close the gap on disparities for minority health. I think it's crucial that we do have health care clinics, not just, just in one particular area but throughout the whole community. One thing that was stated at the, at the onset, I guess in the paper in reference to people can go to Timken or to Aultman, but what I do understand is that they can't go there for free, and often times, many of the people that are working poor, and everybody's losing their health care coverage left and right, and they're the ones that are actually going to the clinic, not the ones who have Medicade and medicare. So, I'm, I'm saying that and referencing a statement, so, please hold your opinions I think at least until you meet with Eric, hopefully next week and that he can get you a final decision because don't think, as of to date, that he went on public record as making statements. But, I believe that they are going to do that and I've also talked to Guy Cicchini on Saturday and he, he can't understand why they are not releasing records and you know, he's all for get, contributing whatever information he can to, as well, but I would just hold our comments and things until we actually hear from the other side. Thank you. OH, I also want to say something. I have to say before Debbie leaves, and, you know, Debbie, words cannot express how I truly feel about you leaving. You, I mean, truly you have been my right hand and I, I thank you so much because these last 2 years, being on Council, I couldn't have made it through, truly without you. You have, you brought your experience, and you gave me probably all the areas, you gave me some of Peel, you gave me some of Charles Ede, those people that I looked up to and respected and would have liked to be here to help me through this way, but you stood in the gap and I appreciate that. Thank you.

MEMBER DOUGHERTY: Yeah I'd like to take this opportunity to thank you Debbie for the last 16 years. I know you had to put up with a lot from me, and, and I'm not easy to work for, some times, however, I would appreciate if you don't tell Cindy any of those things before you leave. Let her base her decision about me on her own. (*Laughter*) But, truly, I've really enjoyed the last 16 years, we had a lot of fun and got a lot of work done and you, you always got things done and that's what we need and I never had to call you twice for anything and you got things done and I'm gonna miss you. Good luck.

PRESIDENT DENCZAK: Members of Council, the Chair wishes to remind you now, I've always been an advocate of 3 people in that office and now we only have 2 people again, so you're going to have to hire another person. We've got to have 3 people and I want to further, just take a second of your time, I know you've got something to do tonight. In, what Bob Fisher said. I want to tell you how I got involved with that East side Medical center. When my wife was gonna bear a child, a daughter, I was awakened at 2:00 in the morning. It was so foggy, I called for a police escort and they said that there wasn't any cruisers on the street, so I had to drive up East Tusc from Cornelia Avenue. I got to the Pennsylvania Railroad crossing. A crossing notorious for blocking the traffic on East Tusc.; 2:00 in the morning the gates came down and I had to get my wife to the hospital. I got out to see if I could hear the whistle by the tracks or somewhere where the train is at so, I took a chance. I had to make a decision. I ran around the gate and got to the hospital. They took her into the hospital, I drove home, still foggy, I wound up driving on the sidewalk, thought I'd stop to see where I am at, almost hit a metal pole and I finally got home to my son who was home by himself and the telephone rang and it was my wife telling me we had a baby daughter. So, that made me interested in getting the medical facility out there because of that damn railroad and that facility should stay there for that purpose. Not only for the needy, but for the fact that they need medical attention, east of that railroad track. Thanks Councilmembers. Anybody else have anything to say?

MEMBER ZACHARY: Mr. President. I would just like to, first of all, thank Mr. Fisher for coming down.

We've talked quite a bit about the clinic move and unlike some other council members, I have received a ton of phone calls since the article came out in the paper, and these phone calls are from constituents who are concerned, concerned that the clinic would move with the, with the exit of resources out of the 4<sup>th</sup> ward for whatever reasons. This is one of the last things that we can afford to see leave and I'm sure that Mr. Riley has the best intentions in the world and wants to service a larger number of people but, we really can't afford to have the clinic move and I heard it with my own ears in talking with him several weeks ago, he pretty much told me that the clinic would not close, but it would not have limited hours. I don't think that's something we can support either. It's just so necessary to the community at this point so, whatever assistance I can be to anybody in the community, Mr. Fisher, thank you. We're gonna fight the good fight on this one, I hope. Also, just real quickly, Debbie, it has only been a little over 2 years, but, I think the first time I met you guys I told you I wouldn't ask you to do anything that I couldn't do for myself and for the most part, I've stuck to that. But, you've pulled my rear end out of fire on more than one occasion, resolutions and, and just pulling things together and the amount of dedication and research you even put into things that I didn't even ask you to do, I have to say thank you. Cindy, you have some really big shoes to fill and I'm sure you will. Bear with us as we conge in this second term of mine but, Debbie, I just really want to say thank you for everything that you've done in the past 2 years. You've always been the picture of professionalism and I have to just say, I appreciate everything you've ever done, for me. Thank you.

MEMBER CASAR: Mr. President. Mr. President, I too would like to offer my wishes to Debbie and her family. I would be remiss if I didn't do so for the record. I'd like to think that I was a little part of Debbie's success here. I, I had the opportunity to vote for her back in 73 when we hired her as a legislative assistant and I think that was one of the better moves that Council has ever made. Debbie has proven through coming up through the ranks as a legislative assistant and then on to Clerk, how good she is, how qualified she is and how proficient she is at what she does. I know that Cindy will be a good person, I know that Cindy will have a hard time at first, but I feel very confident with Debbie's training that she's been given her already for the past 3 months in her position as legislative assistant, will carry on and thank God that we have a person like Deb that we're able to work for, for as many years as I've been around here, she's been more than my right hand man and I respect her for everything that she's done and I will continue and I'd like to say that she's been my friend and will continue to be my friend. Thank you very much and good luck to you and your family.

LAW DIRECTOR MARTUCCIO: On behalf of my former and current colleagues, many of whom worked closely with this office and with Debbie Vanckunas, we want to thank you for over 3 decades of quiet dignity and efficient service and lots of patience on many hundreds of Friday deadlines. It is said that a court speaks through its journal entries, it can also be said that a Council does most of City's business through its ordinances. Those ordinances have been efficiently and well done for many years because of the fact that we have a doer. Most people can be classified as a talker or doers or some kind of combination of those 2. We have a doer and we've been fortunate to work with you and appreciated your efforts and our efforts as we jointly helped our city. I want to thank you for that service and congratulate Cindy Timberlake and wish you the best. You've had an opportunity to begin to apprentice under someone who I'm sure you can emulate.

MEMBER GRIFFIN: Debbie, I'd like to thank you for what you did for me, okay. Thank you very much and enjoy your children, and the best of luck.

MEMBER PRATER: Mr. President. I too would like to take this opportunity to thank you Debbie for all your help and support over the years and wish you the best of luck in your retirement and hope that you and your family find lots of interesting things to do. For the life of me, I can't understand what would be more fun than dealing with the complex liquor permits that we had to deal with and sort through over the last 2 years, but, I guess you don't share my enthusiasm there so, thank you for your help in that, and best of luck!

MEMBER SMUCKLER: Mr. President. As one of the few former Majority Leaders around here, there was a lot of time when I was Majority Leader that I interacted with Debbie a lot. Debbie, it's tough to get through some days but I appreciated you being there and doing a heck of a job and making sure that the office did perform and I apologize to my 8 resolutions that always showed up a week in advance but you always managed to crank them out and Cindy, if you want to find out how Dave Dougherty is, don't ask me but ask the current and all former Service Directors and they'll tell you about Dave Dougherty. *(Laughter)* 

MAYOR CREIGHTON: Mr. President. Debbie, on behalf of the Cabinet, and the former Mayor's, we thank you very much for your 33 years of dedicated service to our great city but, I have to say, anyone that is dealt with 78 council members, 4 former Mayors and I lost track of how many council-at-large, you must be one saint! *(Applause)* 

PRESIDENT DENCZAK: Anybody else?

MEMBER HART: Mr. President. Just again, a quick question. Last week there was an article in the newspaper concerning the Ritz and moving up some tenants to 1700 Fulton. I want to thank the Safety Director and also the Law Director because I was given a letter today that those properties of which there are 5 to be vacated, I want to thank you for all of your due-diligence and please thank all of your staff. There are some concerns because right across from 1700 Fulton was a day care center and I didn't want to see those problems from the Ritz going up there to 1700 Fulton. Also, speaking for the minority and as the minority, that's as good as it gets from me. I want to thank you Debbie, for everything that you have done. You know, you've always been, you know, an efficient, well done, doesn't even begin to describe you. I've seen you in action with some people with so much less fortunate and you've always handled them with the greatest kindness, respect and love. You've done the same with at least me, as a Councilperson, because, I know as disorganized as I am, you've always been able to decipher my letters. You've always been able to make me look really good, and again, more than anything else, I want to thank you for all these years of friendship. You've always been super and one door closes and another one opens for you and I wish you only the best. You've been a super super person and a great public servant. Thank you.

PRESIDENT DENCZAK: And also the fact that she made you look good, I don't think you look.

MEMBER HART: I look better than you Ray. That's all.

PRESIDENT DENCZAK: Everybody does. Anybody else.

MEMBER CARBENIA: Mr. President. I would like to say that Debbie, first off, I'd like to wish you a very good and long retirement. I'd like to thank you for everything you've done for me since I've been a Councilman. I've known you longer than when I was a Councilman. I remember when I used to come, come in here and ask for little things and you used to get them. I just think that you changed that whole job, where it used to be more, you know, just an office manager, to somebody that actually is a working person, types, does, done everything. You actually caused a lot of trouble for this committee I think. (*Laughter*) Because of you doing such a good job Debbie, and, I, I mean, I'm talking' from the heart, I, you know, I don't want to tell this in front of my wife, but I love you too, you know. I just think that we're gonna miss you more than we know. I know that things have happened over the past couple of years that maybe shouldn't have, but dog gone it, you done a good job. I know that you've always taken care of me and wrote my resolutions and done all my little sidewalk things and took care of me all of the time. Just like today, um, thank you and have a great retirement!

PRESIDENT DENCZAK: Anyone else? Member Kraus.

MEMBER KRAUS: Debbie, though our term, my term on Council's been short, as Joe, I have dealt with you in the past and it's always been professional. Good luck.

CLERK VANCKUNAS: Mr. President. I would just like to say that I am really glad that I ordered these nice plaques. I've given so many of these things out and I really was beginning to despair if I would ever get one myself, but, I, I want to thank you very much for that. Congratulations and special thanks to Cindy Timberlake. Four days from now, after 32 years of service to our City, I will pass on the responsibilities of the Clerk. I believe I've taken those responsibilities seriously, since walking through that door 32 years ago, I've learned much, grown as an individual, faced many challenges, I've aged, I've been betrayed, I gave birth to 2 wonderful children and I lost my best friend. When I look back on my time with Council, ultimately, I'm sure it will be with fondness. One of my funniest recollections, and I'm sure President Denczak remembers this was many years ago, when a Councilmember was remarking about being approached while driving through a non-prostitute area and how he wondered, did they know it was his payday. Although I cannot remember the most stressful, I, I certainly remember my longest council meeting 2:05am, that was in large part to Art Cirelli. The saddest experience was attending the funeral of our former Clerk Al Artimez. To all the members of Council who voted for my appointment, I thank you for the many opportunities you have given me for public service. I hope in that service, you found some worthy things. We've been through many challenges in city government that bind us together. A bond that can never be torn apart. As I come to you with my message of farewell, I would like to share a final thought and a quote with you. "May you be ever unswerving and devotion to principal, confident but humble with power and diligent in pursuit of the city's goals." I like the way Steven Lee Koch described retirement. Have you ever been out for a late autumn walk in the closing part of the afternoon and suddenly looked up to realize the leaves have practically all gone and the sun has set and the day gone before you knew it; and with that, a cold wind blows across the landscape: That's retirement. The years pass all too quickly land there is much to do. To all of you, I wish you Godspeed and hope that the coming years will be blessed with cooperation and accomplishment for everyone. I thank you all; and to this Council and particularly Don Casar, I owe a debt of gratitude that can never be repaid. Thank you. (Applause)

PRESIDENT DENCZAK: I would have hoped that she would have talked for 22 more seconds and I could have told her that her 3 minutes were up. Not only that but she's leaving the day before the first, April 1<sup>st</sup> so I won't be able to play a April first trick on her. I had a good one in mind. Are there any other remarks?

MEMBER CASAR: Mr. President, I move that we adjourn; seconded.
