PRESIDENT PRO TEM SMUCKLER: Yep.

MEMBER ZACHARY: Mr. President, I am gonna ask, and this is on the Agenda as a communication tonight but I am going to ask our administration on their end as well as Council on our end. I've talked to Majority Leader Casar and he is willing to suspend the three readings for this to get it expedited but we have to do what we need to do administratively to get this thing done as quickly as possible. I feel horrible for this family. They have such a cute little cottage style house on this street and its really not, vacating the street is not going to affect anyone.

The road has been grown over for quite sometime and they have been taking care of it for the past seventeen years. Initially when they thought that street was vacated it was the wrong part of the street and we have put this family pretty much through hell for the past several months because we haven't stepped up to do what we were supposed to do and we just found out last Tuesday that the road wasn't vacated and it shouldn't have taken us that long to do that and as a result, she has lost the sale of her home to a potential buyer. It's not fair to her, so I would ask that we do everything in our power to expedite the situation.

SERVICE DIRECTOR CONCATTO: Mr. President.

PRESIDENT PRO TEM SMUCKLER: Service Director.

SERVICE DIRECTOR CONCATTO: Ms. Woodward, who did you contact in the City? Do you have any names that you want to share with me? This is the first time I've heard of this was when Member Zachary called me last week. This street where we are talking about is Eversole?

MS. WOODWARD: Uh huh, yes.

SERVICE DIRECTOR CONCATTO: Eversole is a dedicated street up to 25<sup>th</sup> St, anything north of that is not dedicated. Your part of the street, and there are streets in the City that are dedicated streets that are grown over.

MS. WOODWARD: Uh huh.

SERVICE DIRECTOR CONCATTO: Possibly what you're, the situation that you're in, I, again this is the first time I've heard of it, the vacations usually are applied with Council and go through Planning Commission, Um, I would have to look and see how we could rush that through because it has to get through Planning Commission, there is a fee to pay Council Clerk. It's a \$300 vacation fee. I just don't know, if you could help me even after the meeting, who would tell you this information, I don't know.

MS. WOODWARD: Well the guardrail has been there for thirty-five years.

SERVICE DIRECTOR CONCATTO: I'm sorry?

MS. WOODWARD: There is a forty-two foot guardrail right beside my property that was put there thirty-five years ago when I was a child.

SERVICE DIRECTOR CONCATTO: I understand that,

MS. WOODWARD: Right.

SERVICE DIRECTOR CONCATTO: I was just curious, you said that you've called many many people.

MS. WOODWARD: I spoke with a Bruce Williams, I spoke with a Rick.....

SERVICE DIRECTOR CONCATTO: Zengler?

MS. WOODWARD: That's it.

SERVICE DIRECTOR CONCATTO: Okay, and when did you speak with these individuals?

MS. WOODWARD: Oh, I spoke with Bruce, probably, mmmm, I'm going to say, how long has my house been on the market? Off and on for three years. We've never gotten any call backs and I just thought, when no one calls you and is trying to help you, I said "Please help me, I don't know what to do." He said oh well, I just remember what he said to me, he goes, well there's, he goes its never been vacated and he says, "Well all I'm saying to you, good luck." Just very sarcastic to me and it's like what do I do next, I mean I don't know.

PRESIDENT PRO TEM SMUCKLER: If I could just intercede here because, could I just recommend that the Service Director, the Councilperson and if need be the Mayor get together. This meeting wont last much longer.

MS WOODWARD: Sure.

PRESIDENT PRO TEM SMUCKLER: Just get together, wait for it after the meeting and instead of going through all this, we can get this taken care of.

MS. WOODWARD: That's fine.

PRESIDENT PRO TEM SMUCKLER: Alright, thank you.

SERVICE DIRECTOR CONCATTO: Just one comment if I may.....

PRESIDENT PRO TEM SMUCKLER: Yeah.

SERVICE DIRECTOR CONCATTO: .....Mr. President, is that I don't want to give any false hopes, again.....

PRESIDENT PRO TEM SMUCKLER: I understand.

SERVICE DIRECTOR CONCATTO: .... And typically, this goes through the Planning Commission and, and reviewed by the Planning Commission before it gets to Council. I just don't want to give you any false hopes.

PRESIDENT PRO TEM SMUCKLER: I understand, just, lets get the information together and see how far we can go with this to, you know, for whatever the case maybe.

MS. WOODWARD: Okay, is that all?

PRESIDENT PRO TEM SMUCKLER: That's it. Just wait for after the Council Meeting, when it's over please come up front here.

MS. WOODWARD: Okay.

PRESIDENT PRO TEM SMUCKLER: Thank you.

PRESIDENT PRO TEM SMUCKLER: Member West.

MEMBER WEST: Yes Mr. President, I would like to recognize Kathy Lopez, she owns a business, and I am going to say this in English and Spanish, Los Taquitos, did I say that right? For three minutes.

## DESIRE TO SPEAK BEFORE COUNCIL ON THE FLOOR WHICH WAS GRANTED BY COUNCIL BODY. MS. LOPEZ WAS GRANTED THE TRADITIONAL 3 MINUTES FOR PUBLIC SPEAKS)

PRESIDENT PRO TEM SMUCKLER: Um, could I get a second from someone there?

#### MEMBER CIRELLI: Seconded.

PRESIDENT PRO TEM SMUCKLER: Its been moved and seconded that we allow Kathy for public speaks. By voice vote, all those signify by saying yea. All those opposed. NO REMARKS

#### APPROVED BY UNANIMOUS VOICE VOTE

PRESIDENT PRO TEM SMUCKLER: Ayes have it. Kathy, please state your name and address for the record.

MS. LOPEZ: Thank you Mr. President and City Council, my name is Kathy Lopez, I reside in the City of Canton at 1209 Hoover Place, NW, I also own a Mexican Restaurant downtown Canton, 220 Market Ave, N., in the Millennium Building. Umm, the reason why I am here today is because umm, originally when I had applied for, or spoke with the Building Department to get an inspection done, get an occupancy permit, Uh, I was denied the permit to have a ventilation system put in that location. Umm, Mr. Gallagher with CT Consultant had advised me that the reason that we could not get the hood system was because the smell of food that would go out through the front into the street of Market Avenue would cause problems, such as grease falling on people walking by, umm, and it would be a public nuisance. I have since then been informed that there is another establishment on the same street, called Little Chicago, who has been approved a permit to have the same ventilation system installed and I have a real problem with that. I believe that as a business owner, if the rules apply to me, they should apply to everyone else, regardless of how long they have been in business, okay? I know we are trying to get downtown, more businesses to come into downtown and you know, I just think that it's only fair and I would like this, this matter to be looked into because if this is the case then the Building Department and CT Consultants is not doing their job correctly. Um and that's basically my concern and my complaint. And I just ask that everyone here today just look into this, do what they can. Um if I am wrong then I made a mistake, but I was informed by the cook from that establishment and they have been in business for two years. So for two years they have been able to do something that's not, that should not be going on and yet I cannot do that.

PRESIDENT PRO TEM SMUCKLER: Are you..... um, Bernie.

SAFETY DIRECTOR HUNT: Mr. President. If you have some time afterward, I would like to talk to you because Building rules are for everyone, we don't change the rules, Mr. Gallagher doesn't do that so if you want to talk to me afterward we'll find out what's going on.

MS. LOPEZ: Okay, thank you.

PRESIDENT PRO TEM SMUCKLER: That concludes public speaks.

#### **MISCELLANEOUS BUSINESS**

PRESIDENT PRO TEM SMUCKLER: Miscellaneous Business. Is there any Miscellaneous Business?

MEMBER WEST: Mr. President.

#### PRESIDENT PRO TEM SMUCKLER: Member West.

MEMBER WEST: On April 22<sup>nd</sup> at 10:00 am, the Hoops for Health, its Minority Health Month, Hoops for Health event will occur Malone College. I invite every Council Member to there, it's at 10:00 am. It's well attended. There's a lot of health booths there. A lot of your constituents will be there as well so please attend that. Second thing, before coming to Council I got a disturbing call and I did get a chance to speak to Chief McKimm on this. We have a number of shootings that are going on in on 9<sup>th</sup> St and Plymouth, which is in Ward 2. Um, last year we had a pretty effective kickoff campaign, if you will, to truancy and gang violence. I am hoping that we can do the same response this year and Chief McKimm has assured me that they are going to look into doing something like that. But, I just wanted to make sure that this Council is aware because one of our priorities that we had stated that we are going to improve our police presence within the neighborhood. So I wanted to bring that to bear because a number of these shootings are going on on a regular basis on 9<sup>th</sup> Street.

PRESIDENT PRO TEM SMUCKLER: Anyone else for Public Speaks? Law Director. Yeah we are under Miscellaneous, I'm sorry.

LAW DIRECTOR MARTUCCIO: Mr. President. I just wanted explain to those who are new in the audience, about the amendments. When an amendment is offered on the floor, it has been fully discussed in the committee meetings, which are also public. They are held in a meeting adjacent to chambers just before we come in here. If you are curious, you could certainly attend those meetings or ask any of us afterwards. For example, one amendment tonight was to have the Law Director pursue past tax remedies, past tax loses on the (inaudible), in other words, to add some additional funding to the federal project to purchase real estate for the federal campus that's going downtown; and the third one was to authorize a trade in, thank you, I can't see the fine print anymore. Uh to authorize a trade in of an old fire truck for a new fire truck. So again, um for those of you who aren't familiar with the process, you are always welcome to ask about that. Thank you Mr. President.

PRESIDENT PRO TEM SMUCKLER: There will be a meeting for those who would like to attend. Its an open public meeting on April 19, 2006 at 6:30 PM to discuss Charter form of Government, most of all of you should have gotten a letter. I hope you will all attend. Any other Miscellaneous Business? Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Um, I just put a paper in front of every Council member and the Mayor and the Administration. Attention Postal Customers: They were picketing the main post office today. Unfortunately, uh, thanks to Butch Kraus he had passed a Resolution here and possibly some of those fears that member Kraus had, or they.....the employees there see coming to fruition. So I just wanted everyone to know and I just wanted this to go on the record to know that there is something there that we all need to be apprized of and is asking people to contact their Congressman to see if they can prevent more or less a downsizing is the bottom line is what it comes down to and us losing the Canton City stamp of which I know the Mayor is very adamant about keeping that. So I just wanted everybody to be aware of what is going on in the community. Thank you very much sir.

ASST MAJORITY LDR CARBENIA: Mr. President.

PRESIDENT PRO TEM SMUCKLER: Member Carbenia.

ASST MAJORITY LDR CARBENIA: I would also like to mention about the Postal problems up there. I would hope that when the people drive by there, I'm an old union person. Blow your horn, let them know you're concerned and you know what they are doing because they are trying to save the jobs in this city. And the other thing I have if I may, is I like to smell food downtown, that would be good for me. I'll make a

motion to adjourn; seconded.

PRESIDENT PRO TEM SMUCKLER: Its been moved and seconded to adjourn Canton City Council. Any discussion? Roll Call.
