PAMELA PUDUBCHONSKI: My name is Pamela Pudubchonski, I live at 313 Millview Place SW.

PRESIDENT SCHULMAN: Thank you Ma'am.

PAMELA PUDUBCHONSKI: Which is zone 4. Um...the first I knew of any of this was when we received the letter. Um....stating exactly what your proposal is stating here for a rezoning and it is in regards to a auto situation, an auto store, of some sort and I'm a little confused. If someone could help me out on what you guys are planning on this or if this is not the time to do this, that's fine, just let me know when, where and how to find out what's going on.

And as always, we appreciate your interest in the community. We appreciate your being here as we said to the other speakers, if you would could you give us

your name and your residential address please. Thanks Ma'am.

RHONDA SMITH: Thank you, um.....my name is Rhonda Smith and I'm at 1663 Gibbs Avenue and ah...I'm a lifetime resident of the City of Canton and um......my siblings and I grew up right here off ah....Belden Avenue, uh......on 4th St NE and we were just as law abiding hard working citizens and one of the reasons that I'm here today, I'm here this evening to address the idea of Mayor Creighton to beef up the security forces in minority neighborhoods. Ah....such as the 7th St NE and the far NE neighborhoods and any other areas. And what I'm asking is that the Mayor would please, not impose a plan but to allow the community to build a plan that encourages police officers to have a positive interaction with our young people, young youth, well the youth and the young adults. And to implement ideas such as perhaps, ah something where monthly, you know where the officers are helping to mentor ah....maybe some type of ah, monthly benefit whether it would be um......some type of something where the officers versus the youth, like maybe basketball, something like that where they can exert this energy so it wont be negative energy so it wont be negative energy. Ah, these are just some of the things that you know, that I am asking that some of these ideas be put into place and that they....they are put into place through a networking in the neighboring communities and as responsible tax paying citizens, we do care about communities. So we ask that you take that into consideration and we thank you.

PRESIDENT SCHULMAN: Thank you very much Ms. Smith. Our next speaker is Richard Kendig. Mr. Kendig, would you step forward. Good evening sir. Could you give us your name and your residential address please.

RICHARD KENDIG: My name is Richard Kendig, I live at 1226 Valleyview SW, Canton, Ohio. I came to congratulate the City tonight for the wonderful job the City Health Department along with the County Health Department did over at the Fairgrounds for the flu shots. Uh....if anybody was over there, they saw how well it was handled, they had people at the gate to tell you where to go. Ah....plenty of parking, people inside there was enough people inside to handle everything very smoothly. They had paramedics units there, they had ah...the ah......Sheriff's Department had people there and even the...ah Red Cross had a...a van giving out coffee to the people because of the raining and the cold weather. I would love to see this be used again maybe in the years in the future because of the amount of parking there and easy access to it. Completely wonderful for the handicapped because the building is level and there's no ramps or nothing to worry about and I appreciate that. And I also want to thank the Mayor for getting me the speaker for the ah....my organization for the ah.....I'm President of the CAC, which is Citizens Advisory Council to the Regional Planning Commission and we had asked the Mayor to get us a speaker on, from the Health Department on, on uh....pollution and monitoring and they did an excellent job. She can be proud of them for that. Thank you.

PRESIDENT SCHULMAN: I know we all appreciate the compliments. Thanks sir for coming down and thank you Ms. Smith. Appreciate your remarks.

If you give me the addresses of drug houses, I have been very um......I've received a very good response from the gang task force and the vice unit. They usually get these guys off the street pretty quickly. I do know one of the things that they try to do is build cases, so um....instead of just going out and doing jump outs and arresting someone and their back on the street like a couple hours or a couple days later. They like to build cases where they can put them away for a long time. And it takes time and it takes patience to do that. I ask that um.... the residents of the City as a whole bare with us because we have some very hard working officers who are doing an extremely tremendous job for what they do everyday. But a lot of times they get beat up and say the police aren't doing anything and that's simply not true. I also caution residents when the police are doing there jobs, to stay out of the way. Um, don't interfere in that process because then the next thing you know, we have people coming down here saying the police beat my kid up and that may not be factual. So those are my words of wisdom, I guess for tonight but um...if you would like to talk after the meeting I will get you some more information on what's going on. Thank you.

MEMBER HART: It um...on Resolution ah...84 ah......Honoring Julie Herman, she was a student of mine, my ah....first years of teaching in Canton City Schools, you know that was awhile ago and ah.....but ah......Julie's one of those young, young ladies that ah.....was just very special and just a very, very brilliant...ah....child and grew up to be a...is a brilliant woman and has just done very, very well and ah....it was unfortunately inconvenient for her to be tonight for the presentation but I would like to ah.....ah...have that presented to her next week......and ah....ah....like you said, just a fantastic woman and whatever she would have done, if she was in law, she would become a Supreme Court Justice and......and she chose education and is just a superb teacher.
