PRESIDENT PRO TEM CASAR: We are now under Public Speaks, Open Forum. We have 2 speakers, Bob Griffin, Gifford, Gifford, I'm sorry. Bob Gifford, is he in the audience?... Our next speaker is Janie Franks. Come up to.....

MS. FRANKS: My name is Janie Franks. I live at 703 13th Street NW. I currently started neighborhood, um, the neighborhood association within the ah, 1300 block, 1200 block northwest Canton, ah, McKinley Ward Neighborhood Association. I'm standing before you in, with concerns of this neighborhood with problems that have arised with our gang violence. Ah, from this, I think stems from with our Weed & Seed Program, ah, that has chased, I think, a lot of problems from that area to our area. Thank you Mr. Hawk. Um, my biggest concern is last night. Last night, I had a very difficult problem outside of my home with the home, um, I don't know if I'm allowed to give that address or not, ah, 606 13<sup>th</sup> Street NW. This has been a concern, ah, with our area, ah, with a lot of activity at this home, it looks like drug activity that has been observed, ah, daytime and night time. There is a lot of curfew violation also at that home with, ah, I would say, high school children, um, and young adults and I've also seen um, gang color what's in there. There's a lot of red that congregates here. Last night, um, I'd say about between 12 and 12:30, ah, there was between 40 and 50 people outside of my home at this house. Ah, cars riding up, stopping, people getting out. There's ah, smoking of marijuana, there's alcohol, um, I can tell, a lot of loud music, a lot of people coming and going, male and female, um, around 12, I'd say between 12, 12:15, this started at probably 9:30. At 12, 12:15, ah, once I looked out again, there was more individuals outside. Ah, there's also surveillance in this area, ah, that can back this up. Ah, at this time, the colors start moving in. There was white, as far as colors that are worn, which I don't understand what the white is, but, I don't know if that was neutral or what, but the red and white merged in the middle of 13<sup>th</sup> Street. It looked like there was a fight involved there and then suddenly there was gunfire. There was shots that rang out about 5 or 6, first time around. Ah, people started to scatter, more cars drove up, more shots run out. I have an 8 year old in my home and also my 86 year old mother that was only, I would say, 50 feet from all this happening, lying in their beds or standing at their window. I think it's a shame that I have to have bullet-proof glass in my first story windows in my home. Ah, I wanna know what can be done. Mr. Safety Director, if you can help me with this. If there's some way, how can I stop this? Each time this has happened, this is the highest time, timex that I've had with this situation. Um, there's been several reports to the police and this is throughout the neighbors that have been in our area. Um, first of all, is there a permit needed for a block party at night? They're saying, each time the police write up, I hear them say, we're having a party. The police come in, the police say what's going on here, we're having a party. Before they get there, I don't know if someone has a police radio in the house, but it scatters before the police gets there. They drive up and they say we're having a party. The police do not get out of their cars, they drive off. Then another call comes in after they congregate once again, they scatter

again and the police drive through. No one pulls out of their, comes out of their cars, they drive off. When I called at 12, 12:15 that guns were fired, prior to that I called and said that the 50, 40 or 50 people were at this address and in the streets. Before I could hang up, the shots rang out and I called once again and said you need to get someone here now, there's gunfire here. Within 5, I'd say 5, 7 minutes, the police officer came. One. One police cruiser after me panicky saying on the phone, shots are fired at this address, you could hear it in the background. One police car came out.

MEMBER SMUCKLER: Mr. President. Can I ask this.....

PRESIDENT PRO TEM CASAR: Member Smuckler.

MEMBER SMUCKLER: ...lady a question. What would you like to see ma'am?

MS. FRANKS: I'd like to see the house shut down. There's surveillance tapes on this, on this house. I have 'em in my possession and this house needs to be shuts down. They've been there less than a year. The first weekend they were there, they threw these parties.

MEMBER SMUCKLER: What else would you like to see?

MS. FRANKS: I'd at least like to see more patrol, actually come through this neighborhood and stop and maybe get out of their cars when someone calls.

MEMBER SMUCKLER: So, you'd like to see more of a police presence in the neighborhood?

MS. FRANKS: Yes I would.

MEMBER SMUCKLER: Thank you.

MS. FRANKS: I'd like to see them be more active. Thank you.

MEMBER WEST: Mr. President.

PRESIDENT PRO TEM CASAR: Member West.

MEMBER WEST: I am aware of the situation. This is actually 2 blocks from my house where we have had problems. I have also wrote a letter to the owner of the property ah, and, I am the one who talked to a group of them and talked, told them to call the police, call the police, call the police, keep screaming, keep screaming, keep screaming about this property and several properties. Um, so I think it is time, par time, we get something done over in that area of 13<sup>th</sup> Street. I know Weed & Seed goes to 12<sup>th</sup>, ah, but we do need community policing throughout our whole inner city.

MS. FRANKS: Thank you.

PRESIDENT PRO TEM CASAR: Thank you very much for coming forth this evening, we appreciate it.

MEMBER WEST: Mr. President, just one more quick question. Janie, with, with respect to this surveillance cameras, was those shown to the police officers?

MS. FRANKS: One was sent in through Acie Singleterry.....

MEMBER WEST: Okay.

MS. FRANKS: ...Singleton, at Multi Development and never heard anything else about it. He took it directly to the Police Department and said that he would turn it over to um, ah, Task Force I believe.

MEMBER WEST: The Drug Task Force?

MS. FRANKS: Yes, and I never heard anything else, but, the tapes have been collected. I think we probably have a total of about 15 tapes, ah, with 120 minutes left on each one of them.

MEMBER WEST: And, just one other question. Safety Director, um, are you familiar with this problem, this issue?

SAFETY DIRECTOR HUNT: The issue that you brought up ma'am, unfortunately, ah, that particular areas has become a hot spot here within the last year or so. AH, the information that I have is that it did not used to be that way.

MS. FRANKS: No, it wasn't.

SAFETY DIRECTOR HUNT: I will talk to the Chief. We will get more patrols in that area ma'am and if you get any more tapes, I'll, I'd like to give you my card afterwards, I'd like for you to pass those on to me so that I can make sure you....

MS. FRANKS: I can give you one tonight of last night.

SAFETY DIRECTOR HUNT: Thank you. I'd appreciate that.

MS. FRANKS: Thank you. (APPLAUSE)

## **MISCELLANEOUS BUSINESS**

PRESIDENT PRO TEM CASAR: We are now under miscellaneous business. Is there any miscellaneous business?

MEMBER CIRELLI: Mr. President.

PRESIDENT PRO TEM CASAR: Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. This is a question to the Law Director. Law Director Martuccio, our usual procedure, like Ordinance 4, is for Council to, on demolitions, to certify the costs of demolitions to the Stark County Auditor. With what we had heard in a discussion in our caucus, could this Honorable Body make it a policy that besides doing that, that we also could go after any other properties that are owned by the people that have these parcels here?

LAW DIRECTOR MARTUCCIO: Mr. President.

PRESIDENT PRO TEM CASAR: Law Director Martuccio:

LAW DIRECTOR MARTUCCIO: Member Cirelli, it is possible. We may have to re-word some of these ordinances to be more selective. For example, I know of one, pending Ordinance, has that as one of its burning issues, um, if, if we were to make that specific, we would try to do what we could in the court system first, and maybe re-word the Ordinance to say that barring any attempts to collect, unfortunately, you may have to incur the bill before you can try and collect on it. So, in these, the way the ordinance is worded, um, we could possibly, in the future, re-word them. This one says that it's to be assessed as costs.

MEMBER CARBENIA: Mr. President.

PRESIDENT PRO TEM CASAR: Member Carbenia.

MEMBER CARBENIA: I move we adjourn; seconded.

MEMBER WEST: Oh, wait a minute. Are we under Miscellaneous?

PRESIDENT PRO TEM CASAR: Roll Call. Go ahead. Roll call.
