PRESIDENT SCHULMAN: The Chair calls this meeting of Canton City Council to order. Roll call vote please Madame Clerk.

### **12 COUNCILMEMBERS PRESENT**

CLERK TIMBERLAKE: All Present Mr. President.

PRESIDENT SCHULMAN: Thank you Madame Clerk. Ah...tonight we're going to have the invocation given tonight by Councilmember Carbenia. Ah, before Member Carbenia gives the invocation tonight, I'd like ah....after his invocation for a moment of silence ah...before we say the Pledge of Allegiance. Canton lost one of its sons this last week, Heath Warner, who was 19 years old and died in, overseas in Iraq and I believe all of us share the feeling that the sooner this war is over the better. Member Carbenia.

## (Moment of Silence)

The regular meeting of Canton City Council was held on Monday, December 4, at 7:30 P.M. in the Canton City Council Chamber. The roll call was taken (see above) by Clerk of Council Cynthia Timberlake. The invocation was given by Member Carbenia, followed by the Pledge of Allegiance led by President Schulman.

PRESIDENT SCHULMAN: We have a special treat tonight. We have a group of young people from our community who are going to entertain us for awhile. They've been ah...practicing I know, long and hard and I'd like to introduce them to you. It's the....they're called, if you can't see their hats, you'll figure out the name. The Pink Zone Robotics Team and their going to do a presentation on Nanotechnology. And these young people have spent a lot of time ah.... looking at Nanotechnology, Pollution, Water Control, all the things that ah....we're gonna talk about, young people, in ah.....2007. So we'd like to welcome you and come on up and let's see what you have.

## (Applause)

CLERK TIMBERLAKE: You can take the mic out if you need the mic also.

PRESIDENT SCHULMAN: The stage is yours.

TEAM PINK ZONE ROBOTICS TEAM: We're Team Pink Zone Robotics Team and this year the research portion is on Nanotechnology. We decided to base our projects on Nano Recycling in Ohio and wanted to present our idea for a current solution for waste management in Stark County in the form of a rap song.

#### Lyrics:

This is 10 percent luck, 20 percent skill, 15 percent concentrated power of will, 50 percent pleasure, 5 percent pain and 100 percent reason to remember the name: Pink Zone. Proactive. Innovative. Nanotech. Kids. Coming to you live from channel 5. Nano means "dwarf" in a language of Greek and the solution to pollution is the answer we seek: We're talking microscopic gizmos that can process the trash to clear our landfills,

without costing us cash. Now cells are nature's first nano machines creating new materials - ya know what I mean? Let's take the worm and the dirt and the leaves that he chewed 'cause his gizzard's like a blizzard when it processes food. He's grinding up soil, and he aerates it too. And what he leaves behind him ain't no ordinary poo: It's ions in the earth, making nutrients for plants creating oxygen to breathe is the planet's only chance. So we took a little trip to American Landfill - The trash they got there is way more'n a handful. Five thousand tons of waste is what they take everyday 'cause we make stuff and use it then we throw it away. And in forty more years the landfill's gonna be full. Then what happens to our trash? What we gonna do? Ohio's recycling is the worst in the nation; Changing our rating is our preoccupation. We recycle our trash but only 7 percent - (pause) We should be doing 30, no, 35 percent. The US throws more waste than any place on earth; 2 tons of trash a year is what each household's worth. 25 million plastic bottles an hour; Stack 'em all together, that's a real trash tower and it ain't breakin' down for a long, long time - For thousands of years. And that's a crime. But we got a plan and it's not that hard; Other cities already doin' it in their backyards. It's called Pay as You Throw and it'll save you money 'cause they weigh all the garbage that you give them, honey. The more trash you got, the more money you pay, so cut back on that waste you create everyday. It's more cash in you stash, less trash in the holes and we're reducin' the pollution - that's our ultimate goal. The future.....our Molecular.....Nanotecular.....Machine. Richard Feynman, physicist, in '59 had a plan for molecules - ahead of his time. Using robot arms to make a smaller set ( and then a smaller set, and then a smaller set) Until a billion arms are all workin' the line to make a macro-scale product in a millionth of the time. "There's Plenty of Room at the Bottom," he said. When we called him to explain we found out: he's dead. But that ain't stoppin' us, Pink Zone's on a roll to use MNTs to solve our garbage woes. But how can we do it? What's it take? Manipulate, Assemble and Replicate! You gotta move those atoms, one at a time and place 'em in a pattern till they're all in line, like IBM did 16 years ago with a nickel crystal model and some research dough and what'll make them move? It's assemblers you need, billions and trillions - at molecular speed. They'll be programmed to manipulate and move the atoms. But assemblers ain't enough, even if you had 'em - you need replicators, lots and lots and lots of them to make more assemblers goin' to work again. We won't need big factories and I'll tell you why: You won't see MNTs with your naked eye. Trillions can fit in a cubic millimeter producin' less pollution makes our air smell sweeter. Yes, the future's coming fast and we're ready to meet it; Pink Zone's on the beat, we won't be defeated. We ain't talking trash - we gotta break it down now. Breakin' polymers to pieces we can use is the premise with the help of Jennifer Sabo, she's a chemist. We planned a prototype you won't find at a Wal-Mart but ideas become reality, so it's a start. You take a plastic bottle and you drop it in the top, Preprogrammed Nanobots is what we got. Spinning and grinding, remember the worm while the nanobots inside - all take a turn. First grindin' up collectively, each knows what to do grabbin' hydrogen, carbon and chloride too. Those manipulators move 'em to the spray dry ports. Turned into a powder - during their final sort. They're dropped into a vial at the end of the ride, done with their course, in the blink of an eye. It's the end of the line for the nanobots inside, but they're replicating more, so it will be fine. Lots of little molecules, sorted and stacked, sold to Nano, Inc. - They're on the fast track. Molecular manufacturing is the name of the game. Atoms assembled in a pattern - into a (brand new) or new chain. It's an Industrial revolution - the Nano Solution to Pollution! TEAM **PINK ZONE!** 

(APPLAUSE)

MEMBER WEST: Mr. President. How come Member Hart didn't just do the same thing. If he woulda' come out there and done that, we would understand what he's talking about.

#### (LAUGHTER)

PRESIDENT SCHULMAN: Member Hart is way ahead of his time. Thank you.

#### (LAUGHTER)

TEAM PINK ZONE: Um....some of the team members are passing out ah.....some papers on um....the "Pay as You Throw" Program. And we're also welcoming all of you to come to the ah....first robotic regional competition in ah.....Canton at the Canton Country Day School....um....that's where we'll meet. Um....the papers they're passing out has the date and time and everything.

PRESIDENT SCHULMAN: Terrific, thank you very much. Again, we really appreciate it.

#### (APPLAUSE)

PRESIDENT SCHULMAN: And don't feel bad about making mistakes, if you stick around here, you'll see me tonight make many of them.

SERVICE DIRECTOR CONCATTO: Mr. President.

PRESIDENT SCHULMAN: You're not going to agree with that are ya, Service Director Concatto?

SERVICE DIRECTOR CONCATTO: I would just like to announce for their sake that um.....next week, December 11<sup>th</sup>, we are having ah, scheduled Recycling Committee meeting with Council to uh....identify our... what CT Environmental has done for our study for recycling, curbside recycling and set it.....ah.....and have a plan for council to review and hopefully pass. So that'll be next Monday, ah.....it'll be an hour before um.....committee meetings, I'm not sure when committee meetings are.

CLERK TIMBERLAKE: 6:15 PM.

SERVICE DIRECTOR CONCATTO: So it'll be ah.....quarter till 6.

PRESIDENT SCHULMAN: So you are all invited if you'd like to come down, we'd love to have ya. And thank you again. We really appreciate it.

MEMBER CASAR: Can I ask a privileged question please.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Service Director Concatto, ah.....did you notify or ask about this..or?

SERVICE DIRECTOR CONCATTO: Yes, I talked to you about it. I talked about it.

MEMBER CASAR: When....when?

SERVICE DIRECTOR CONCATTO: Last week, and I said, "do you want us to do it on the 3<sup>rd"</sup> and ah you said "no, it would be best to do it on the 1<sup>st</sup> reading" because we would like to get passed if Council approves it on the 18<sup>th</sup> which is the last meeting......
