The trash cans were all lining the streets with the dusting of new fallen snow, in hopes that the Sanitation workers and recycling would soon be ready to go. (LAUGHTER) Then to Mary's house the pillars will rock when we pull up, we'll sound the siren so loud. Then at Bill's house, we hope to find meat so fine, set out at the curb on us to dine because at Greg's house, we find his quarter hotdogs, even though... yeah, there's still.... kinda devine. Going to Tom's house we got lost. We went east and

not west. At Jim's we'll pick up the tree, the City gave back because it fell over when the wind sent it over with a blast. At Kelly's we'll find a woman full of beauty and grace, ready to meet recycling head-on with a smiling face. At Terry's we'll find a Councilman who doesn't find recycling out of date or out of place. On to Dave's house, we've gone, he's gone early to golf, with used Tee's to play 9 holes at First Tee's, before anyone can see how badly he plays, just between you and me. On to Butch's house we go, hoping his ward takes the lead in recycling, here he goes. President Schulman an old environmentalist you see, has been recycling for generations before you and me. Down the brightly lit snow-covered street, the Mayor and her staff flew singing happiest of holidays and many happy days of recycling to you. Thank you. *(MANY APPLAUSE AND KUDOS TO MEMBER HART!)*

PRESIDENT SCHULMAN: And, I'm just glad there aren't 140 Councilmembers. Member Smuckler.

MEMBER SMUCKLER: Mr. President um, Mayor, could I ask you a question? Um, I saw that Prince was signed at the half time Super Bowl, do you think that we could get a second act in if you called the NFL up real quick?

MAYOR CREIGHTON: Um, Mr. President. If, if we can't get him there, we'll have him for Hall of Fame next year. (LAUGHTER)

MEMBER CARBENIA: Mr. President.

PRESIDENT SCHULMAN: Member Carbenia.

MEMBER CARBENIA: After that filibuster, (*LAUGHTER*) he might a lost a couple votes.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: I certainly don't wanna recycle that so, I move we adjourn; seconded.

PRESIDENT SCHULMAN: All.....moved and seconded; all in favor.... or, I'm sorry. What? Roll call vote please.
