PRESIDENT SCHULMAN: We are now under Public Speaks, and we're very very pleased and happy to have with us tonight one of the members of our Youth City Council who I know is ah, from having met Beth, is very nervous but I assured her that she would get a warm reception before us. So, Beth, would you come up to the microphone. And if you can tell the Mayor and her Administration and City Office Holders and Members of Council your name and your address.

MISS SMITH: Hi. My name is Beth Smith. I'm a member of Youth Canton City Council from early college high school.... I live at....

PRESIDENT SCHULMAN: Beth, may I interrupt you one second? We really do want to hear what you have to say, so, um, let's make sure the microphone's on and if you can speak...

MISS SMITH: Hi. My name is Beth Smith. I'm a member of Youth Canton City Council, um from early college high school. I live in, I live in Canton, Ohio, ward 7, my Councilmember is Richard Hart. Mr. President, Madame Mayor, Councilmembers, I come here tonight to propose something done about the community service deals. Um, there are many people who have problems coming up with ideas for community service and I know that students at early college high school that we have to have 30 hours of community service

by the end of the year in order to get our academic letter. I'm, I'm going to present a few ways that we could um, that we could fix, that could fix this problem. Um, the first one let me give you some reasons why this problem is a good one to address. First of all, community service hours look good on job and college applications as well as they can teach you morals and, and, as well as go through life. Um, also, if people had an easier way to find community service, they might be more um, they might be more likely to do something with them. Also, it gives, also it gives, kids in my life need to do community service, is they are told what needs to be done. It could definitely better the community and people, and I know as a fact that when you get done with your community service, you feel, you have a feeling that you can't get, you can get no other way, and the way to fix this problem I want to propose a web site. I will speak for the Canton Youth City Council that could be a link on the City Council web site. This, on the Canton Youth City Council web site, there could be a link to a community service web site. This could have links, phone numbers and other references for, for different community services. There could be descriptions and times when this needs to be done so people can find, people and students can find ah, community service that would best fit their interests and their schedule. A few other ways could be a newsletter, sent to schools so that kids can find a community service that would best fit them. Also, sending a monthly letter to school counselors and principals so that when, if kids come, to ask them questions about finding their community service, if they need the service hours as early, early college students do, they would have something as a reference that they could use to help the students find a community service that would best fit them. In front, there's a paper that I laid out at your spots before the meeting, there's a link to a Repository article. Um, this article was about volunteers, where volunteers are needed throughout the City of Canton. This could be a first place to start and as I know a lot of students don't read the newspaper, a web site that their, that's made out to them, could, could definitely help them with this issue. I thank you and I hope you take everything I say into consideration.

PRESIDENT SCHULMAN: Thank you very much. Excellent job Beth! Excellent job and your ideas are terrific and thank you very much, and, that wasn't that bad was it? (*Miss Smith made a jester from the audience saying 'no'*.) Okay.

MEMBER WEST: Hey Member Hart, could we see that? (Making reference to a poster that Miss Smith had made)

MEMBER CARBENIA: Bring it up here so I can have a look.

MEMBER HART: I didn't say anything.

PRESIDENT SCHULMAN: ...some really good ideas. Beth, that was excellent. Great job! (*Time taken to look at Beth Smith's poster*) Beth, terrific job again, congratulations. And, I'm sure that the Mayor and other Members of Council made comment on this because I think it's a great idea you have. Um, we're now.... we have no other public speakers tonight

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: And, we're now under Miscellaneous Business. Is there any miscellaneous business?

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: I have a couple things. First, first and foremost, I want to thank Council for passing the junk dealer ordinance. A lotta work went into that. I'd like to thank ah, Joe Carbenia, ah, Member Kraus, um, Member Casar for being on that Committee and really serving, along with ah, Dan, Dan Heaton who is the officer who is there and of course, Joe ah, Joe Martuccio who is of course, the mastermind of words. Ah, and I think that we have really done a great service for our city today. The second thing I wanted to talk about was um, I'm not certain, I think this would be going to the Law Department or, yeah, the Law Department. The signs that are up all over town that have the houses on it for financing that's in the strips throughout the city, did you see that on McKinley and 12th, bright yellow signs, they're not mine, but the ones that look like houses? But, what is the, well there's the bright yellow signs that look like houses all through the inner city and then also, we have some of the signs posted on our telephone polls. And I know, I didn't know if that had anything to do with the new ordinance that we passed with the poll um, or not, or if that's even legal.

PRESIDENT SCHULMAN: Yes, Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Member West, our ordinances declaring where signs can be posted, ah, primarily deals with private properties by consent. Anything in a city-owned space, anything on a utility pole, anything on a tree unless it's privately owned um, is forbidden and the city has the right to collect these signs from rights of ways and from what you might call um, the ah, the strip, ah, the devil's strip, anything that is under the easement or right of way of the city is a forbidden spot and can be collected by the city.

MAYOR CREIGHTON: Um, Mr. President.

PRESIDENT SCHULMAN: Madame Mayor.

MAYOR CREIGHTON: Um, tomorrow in between their snow plowing, I'll have them pick up the illegal signs around the city. They're an eye-soar and I'll be glad to get rid of them.

MEMBER WEST: Thank you Mayor.

PRESIDENT SCHULMAN: Thank you Mayor.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Yeah, speaking of eye-soars, I think it would be a good point to ah, bring it up. I, ah, drove around the city a couple weeks ago and took, ah, no, it's 15, 16 photos of ah, what I call eye-soars around carry-outs, food markets, mini marts, there were beer signs, cigarette signs and I gave those pictures to ah, Joe Martuccio and I want, ah, we want to review our areas because those are really eye-soars. If there's a property next to a drive-thru, they have signs the whole length and ah, at, at different ah, Speed D Foods or whatever, mini-marts, call them whatever, the ah, big cigarette signs that are tore down or are half down and ah, ah, I, I, I got with Member Martuccio, I mean Law Director Martuccio, and we're going to be coming through to straighten that up because ah, you know, this Council, this Administration has done ah, a yeoman's job trying to clean the city up and, and, we're permitting those signs to be the way they are and I think we have to change our zoning, to eliminate them and only have one or two per, ah, location so, we're working on that right now.

PRESIDENT SCHULMAN: Madame Mayor.

MAYOR CREIGHTON: Mr. President. I, I concur with ah, um, ah Member Casar. I just want to remind us all that, you know, we all have to stick together on this because we'll get a lot of calls from a lot of different companies that will complain that we are invading their privacy or that their signs should be there for advertising and I'm with ya because it, it has really, um, I've had complaints from people that it, it, it really just demoralizes people that, in our community and in our neighborhoods so, I, I applaud ya and, and we'll, we'll get 'em picked up.

PRESIDENT SCHULMAN: Thank you Madame Mayor....

MEMBER CARBENIA: Mr. President.

PRESIDENT SCHULMAN: thank you Member Casar. Yes, I'm sorry. Member Carbenia.

MEMBER CARBENIA: (CHUCKLE) Ah, I'd like to....

PRESIDENT SCHULMAN: Well I oughtta 'hawk' you guys.

MEMBER CARBENIA: I'd like to ask the Mayor....she said she was gonna have the fellows pick 'em up ah, between snow plowing. I, I would rather see somebody from like, ah, our Law Department, call that, that number. I mean, it's, it's all one number on them homes, call them and say that that's illegal and that they say it's illegal and tell them that there's, there's possibly could be a fine to this and ah, it's violating a city ordinance. This way, we can save our guys who's gonna be ragged from plowing if the stories are correct.

MAYOR CREIGHTON: Mr. President.

PRESIDENT SCHULMAN: Madame Mayor.

MAYOR CREIGHTON: I really meant that tongue-and cheek for tomorrow. I doubt that they really will pick 'em up tomorrow because of the snow.

MEMBER CARBENIA: I wasn't tryin' to ah, ah, hit ya on it, I just thought that the thing would be better to call.

PRESIDENT SCHULMAN: Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Mr. President. Member Carbenia. Thank you. Ah, we will attempt, if we can, through those phone numbers, to find out who has custody or ownership of those signs; some manager and send them a notification they're in violation of the law in addition to telling them over the telephone if we can. Um, thank you, that would be a good way of affecting due process before we take their property.

PRESIDENT SCHULMAN: Member Kraus.

MEMBER KRAUS: Yes, I just wanted to thank yourself and Timken High School for ah, inviting us last week and I met with Glenoak's new Superintendent for about an hour and half with the engineers and I'm, I'm, I'm working on something that they, they would be willing to bring our show to Glenoak, 44th Street campus um, and,

also, they're gonna wanna come in and be partner with the City Council. Everybody keeps forgettin' ward 8, parts of 6, 7 though we're in the city, our kids go to Glenoak and they keep puttin' levies out there. My phone keeps ringin' off the hook. So, I'm gonna bring them and in and we're gonna become partners. Thank you.

PRESIDENT SCHULMAN: Great. Thank you. I wanted to publicly thank the Mayor and her Administration and Law Director Martuccio, particularly, and our Majority Leader and you the Members of Council for our road meeting last week at Timken High School. I thought it went extraordinarily well and I just want to make a plight here. Everything we do, I'm proud to say, having served here not very long, is a collective enterprise, and, everything we do is for the betterment of this city and I really want to thank you Members of Council, for agreeing to take our City Council meetings on the road, so to speak. I think we deserve the recognition, I think it's a good idea, it, it was somewhat unfortunate that we had the weather we had last week but I can assure you we will be going on the road in the spring time. We'll be back at Timken. I think we oughtta go to McKinley. I think we should go to Glenoak. I think we oughtta hit the schools first and ah, I wanna thank you again for your supporting that effort. I also would be remiss if I didn't say that it was a monumental task and that Cindy Timberlake and Michelle and Beverly did a spectacular job and they really deserve, I think, a round of applause from us. (APPLAUSE FOR THE COUNCIL STAFF)

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Since we're gonna be traveling so much, ah, maybe we can rent this facility out and get a little bit of money for this, for the golfers. (*LAUGHTER*)

PRESIDENT SCHULMAN: Member Casar. I think that's a very good idea. Um, also, I'd like to say that I think that one of our members had a birthday on Saturday and (*LAUGHTER*) you, you can tell her it was because of the groan but I'd like to wish Bill Smuckler a healthy, happy birthday and many healthy and happy returns. Congratulations!

MEMBER CASAR: Mr. President.

DIRECTOR CONCATTO: Mr. President. Can I, just one....

PRESIDENT SCHULMAN: Yes, Service Director Concatto.

DIRECTOR CONCATTO: Just, um, for Council's, for Council, you passed 2937's contract, ah, a couple weeks ago, they passed it on Saturday.

PRESIDENT SCHULMAN: Great. Thank you. Before.....

SERVICE DIRECTOR HUNT: Mr. President.

PRESIDENT SCHULMAN: Yes, ah, Service Director Hunt.

SERVICE DIRECTOR HUNT: I'd just like to say that I'd like to thank ah, Law Director Martuccio. Chief Building Official John Labriola today brought me some color pictures of 1018 McKinley Avenue. They just

started to tear it down and so, hopefully, within the next several days, we'll get that, ah, that eye-soar torn down.

PRESIDENT SCHULMAN: Great. Thank you.

MEMBER CASAR: Mr. President. I'd just like to say.....

PRESIDENT SCHULMAN: Yes, Member Casar.

MEMBER CASAR: ... in regards to 1018, I would like to thank this Council for not acting on that ordinance that we would expended taxpayers money without doing what we did do and now it's coming down, not at taxpayers money.

PRESIDENT SCHULMAN: Great. That's good news. Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Ah, last, Cindy's there, she'll have to refresh my memory, one of the instructors from McKinley High School's out in the audience and some of us Council people went to McKinley High School and met with the students, I think the Youth Council and was very productive, and I just wanna thank the gentleman and acknowledge him that he's here tonight. So, if you would stand.

CLERK TIMBERLAKE: Mike Freeland.

PRESIDENT SCHULMAN: Mike, please stand up.

MEMBER CIRELLI: We appreciate you very much. (APPLAUSE)

PRESIDENT SCHULMAN: Thank you very much. Thank you Member Cirelli and before we adjourn, I just wanna say as we always try to do, thank you folks in the audience for braving the weather and coming out tonight. We always appreciate your attendance. Ah, we appreciate your interest and we're always available, certainly after this meeting or any time, to answer any questions or listen to any advice you might have. So, thank you. Member Casasr.

MEMBER CASAR: Mr. President. Are you through?

PRESIDENT SCHULMAN: Yes.

MEMBER CASAR: Mr. President, I move we adjourn;

PRESIDENT SCHULMAN: Thank you Member Casar.

MEMBER CARBENIA: .. if you are, seconded.

PRESIDENT SCHULMAN: Moved and seconded that we adjourn. Are there any... oh, there are, there can't be any remarks. Madame Clerk, roll call vote please.

CLERK TIMBERLAKE: Twelve yeas Mr. President.

NO REMARKS ROLL CALL: 12 YEAS, 0 NAYS

PRESIDENT SCHULMAN: The meeting is adjourned. (Gavel falls)
