Mr. Hankins, thank you very much for being with us tonight.

ROBB HANKINS: Thank you so much for having us and for allowing us to speak before the passes of our Informal Resolution. My name is Robb Hankins ah....(inaudible) of ArtsinStark. As some of you know, for nearly 40 years the Cultural Center for the Arts up on Market next to the Civic Center was and still is a fabulous 330,000 square foot building with five wonderful organizations, The Canton Symphony, The Canton Museum, The Canton Ballet, Voices of Canton, Inc. and The Players Guild Theater. Well two years ago, we decided that we needed a new job description, County wide. We are now ArtsinStark, The County Arts Council. I'm here tonight with one of my board members, Mr. John Kristoff, whose the Vice President of Communication at the Diebold Company. We have a Resolution that we'd like you to pass, you know it's an Informal Resolution. But I've sworn to only take two minutes more to talk about it so you can get on with your regular business. Um.....this year we will give out \$850,000.00 to the Canton Symphony, the Canton Ballet, The Canton Museum, The Voices of Canton, Inc. and the Players Guild Theater. In the last 18 months as we moved to ArtsinStark, and I've given you a list on page 2, we will give out another \$300,000.00 to 70 different organizations, most of which have never, ever received money from us before. I'm quickly, very quickly going to mention a couple of those special project grants. Number 8 on your list, The Canton Calvary Mission applied through us because they wanted to partner with the North Canton Playhouse to produce a neighborhood production of the Wizard of Oz. Number 10, Canton City Schools, ah....the group that's in bloodline, that many of you may know is one of the best jazz groups in the entire world, they're also school teachers and this summer they're doing a summer jazz camp for Canton kids. Number 20....Number 36, Living Fountain Dance, um....incredible modern dance company and I went to their performance where they had Ca....it was a celebration of cancer survivors and not only did they choreograph pieces about cancer survivors but they had cancer survivors dancing with them on stage, absolutely incredible. 48, Piece T.V., Mari Moss is here, what more can I say, an alternative ah...for kids and chance to make television. 51, Quest Recovery Services, recently had their world premier of a movie about why not to use drugs and alcohol and they came to us for a grant. Um....and finally, Stark Arts Coming Together, 61, that's why I'm here tonight. This is a volunteer grass roots organization that from April 13th to the 22nd wants everyone in the County to recognize we have 500 artists and craftsmen here and 100 artistry and cultural organizations. My 30 seconds that are left, this flier encourages you to pass the Resolution. We also urge you to come to the finale, Sunday, April the 22nd, free, 5 hours, happens to be at GlenOak School, one of the best art schools in America. Um...we're inviting everyone to come to enjoy that. Um...we ask you to pass this Resolution and we ask you to join us in future in supporting our mission, which is growing the arts to create smarter kids, new jobs and help your communities. Thank you very much.

PRESIDENT SCHULMAN: Thank you very much. I'm not sure we realize since we're such a sports town but the arts has more attendance then every sport in the United States combined. So when Mr. Hankins talks about the economic benefits of a great art program. We should listen very carefully to that if for no other reasons, for jobs and economic development.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: We are now under Public Speaks, Open Forum. We have one (1) speaker signed up this evening. The first speaker tonight is Mr. Roy Barr. Mr. Barr, good evening. If you'll step forward to the microphone Mr. Barr. Welcome and thank you for coming down tonight. Ah... would you tell us your name and your residential address and Mr. Barr, let me caution you, ah...The City Council has adopted a rule that public speaks is limited to 3 minutes so if you could please keep your remarks within that time we'd appreciate it. Good evening and you...you have the floor.

ROY BARR: Thank you President Schulman. I was the second on the list, did the first gentleman cancel or what was the....

PRESIDENT SCHULMAN: No, Mr. Hankins spoke on the Arts Program.

ROY BARR: Thank you sir and I appreciate the time given to me and ah....I understood that it was 6 minutes but have they changed the rules?

PRESIDENT SCHULMAN: 3 minutes.

ROY BARR: I sent a package down to ah....the ah...let me introduce myself first.

PRESIDENT SCHULMAN: Thank you.

ROY BARR: My name is Roy Barr, I own and operate Meadowlake Golf Course located at 1211 39th Street NE in Canton and that's in Plain Township.

PRESIDENT SCHULMAN: And your residential address, sir?

ROY BARR: It's the same, I live on the property.

PRESIDENT SCHULMAN: Thank you.

ROY BARR: Um.... I sent a packet down to ah......I believe it was the Mayor and does anybody have any idea where that packet is or what the status is of what's ah... happening up there about the flooding on our golf course?

PRESIDENT SCHULMAN: Well, that's what I think you're going to address tonight and we'll get....I know the Service Director will have some comments in Miscellaneous Business but if you could give us what you're here to tell us, we'd appreciate it.

ROY BARR: Sure...ah...we're in the process of ah.....obtaining bids to replace the 48" culvert that deteriorating on the golf course. We ah...find out that there's another project west of us in the City of Canton to ah...install curbs, gutters and storm banks and catch basins. Are any provisions made to retain that water before they send it down on our golf course? If there's no provisions on that, to my knowledge there's no easements granted to anyone in the way of flooding. No to Plain Township, not to the City of Canton or by the County Commissioners. And without an easement I believe there needs to be an agreement and what were doing is addressing Council tonight, Commissioners tomorrow and the Trustees about the possibility of entering some type of obtaining a grant from the Ohio Public Works Commission. This has to be done through an entity, it can't be done by an individual. Now the only easement that goes through Meadowlake is for a 12" sanitary sewer and if we can work it out, that we could come up with some type of a joint effort by the City of Canton, the County Commissioners and the Plain Township Trustees to apply for a public works grant so that we could replace this culvert with a 60" culvert and possibly ah....this flooding situation will be resolved with some type of agreement, so that's the reason for our coming down here. We want to know, you know, what's happened. We sent this package down here, we've received nothing from anybody. The problem continues to be a problem and we'd like to get this resolved before the culvert collapses. The culvert is deteriorating because of all of the salt that comes off the streets and the salt primarily coming from Canton and off of State Route 43. So, I appreciate your time to mentioning this to you and if you have any questions, we'd be happy to answer your questions at this time or at some future time if you'd like to have us come into one of your meetings, just let us know.

PRESIDENT SCHULMAN: I did want to say, our meeting is almost over and your more than welcome to stay. I can assure you that ah...Councilmembers are very sensitive to the public's needs and they'll be here to answer any questions or talk to you if they have any questions. But we appreciate you're coming down. Thank you.

ROY BARR: Thank you very much.

PRESIDENT SCHULMAN: Thank you. That concludes ah.....public speaks, open forum.

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: We are now under Miscellaneous Business, is there any miscellaneous business, Mr. Service Director?

SERVICE DIRECTOR CONCATTO: Mr. President. Um...concerning Mr. Barr's um request, I've....I've never seen a packet. The only information that I've ah....ever received and...I'm not sure if the Mayor has received it or not, I have not. The only information that I have received is from Mr. Regula's office that's saying that Mr. Barr was at his office complaining about...or questioning the 38th Street project and what it would do about flooding. Uh...and the culvert and his...his property. Ah....we had Chris Barnes, our Engineer, review that very extensively. He has written a letter concerning that, I have that on file, we'd be glad to present that to Council at any time, his information. Ah...this has been 6 months ah....since this has been done. I don't recall everything, I do recall that the 38th Street project should not interfere with the ah...storm water issue that....that ah...Mr. Barr is speaking of. I'd be glad to review that..ah...that with you Mr. Barr. I'd be glad to send you ah...Mr. Barr's remarks and concerns, our Engineer about this project, we'd be glad to do that, in fact I will do that, I will send you his....his letter to me concerning this project. Ah...also, I can only say that with OPWC, Ohio Public Works Commission Funds, um....normally are not done on ah....private property. Ah...those funds would normally not be used for private property and if you are in Plain Township that would probably be the entity that would have to then go to OPWC to secure those grants but I would be glad to....I will look into this more thoroughly and I'll be glad to send you, Mr. Barr, a copy of Chris Barnes, our Engineer's comments about your concerns about your culvert.
