PRESIDENT SCHULMAN: Ordinance #15 has been adopted....and I have a frog in my throat.

ORDINANCE #15 ADOPTED AS ORDINANCE #210/2007

ANNOUNCEMENT OF COMMITTEE MEETINGS

PRESIDENT SCHULMAN: We're now under Announcement of Committee Meetings.

MEMBER KRAUS: Mr. Chairman.

PRESIDENT SCHULMAN: Member Kraus.

MEMBER KRAUS: Public Safety and Thoroughfares will meet 11/19/07, 6:45.

PRESIDENT SCHULMAN: Thank you, Member Kraus.

MEMBER CARBENIA: Mr. President.

PRESIDENT SCHULMAN: Member Carbenia.

MEMBER CARBENIA: Community and Economic Committee will meet on November 19th at 6:45.

PRESIDENT SCHULMAN: Thank you. Any other committee meetings? If not.....

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN:we're now under Public Speaks, open forum. We have 2 speakers signed up this evening. Our first speaker ah, is Monique Conner. Ah, Ms. Conner, if you'll come forward. We know who you are. If you'll give us your ah, name and your residential address, we'd appreciate it. Good evening, and again, I caution people, only 3 minutes please. We'll all be here to handle any ah, problems afterwards. Go ahead.

MS. CONNER: Monique Conner, 1823 Tuscarawas East, Canton, Ohio, 44707. Um, President Schulman, Mayor Creighton and everyone else in their respective places. Of course, being NAACP President I get a lotta calls and today, I've got millions of calls um, concerning the debate and I, one of the things I would like to find out today is, cuz I don't know it to be true, I was not there, if our Mayor felt that she needed protection down in the African community at the Canton Negro Oldertimers, alleged that she had her own personal off-duty officer to escort her down there for whatever the reasons may be. But, I would like to have um, an answer to that and I also was lookin' here at the post office being moved and of course, we all know that's more jobs that will be leaving Canton, so, I, wanted to find out a little more about that and I, before I do sit down, I'd like to thank everyone for the comments they made about the Monroe Center because it is a program that is definitely needed in our community.

PRESIDENT SCHULMAN: Thank you Ms. Conner. Thank you for coming. Our next speaker is Edythe Stinson. Ah, Ms. Stinson, if you'll come forward and I had a conversation with Ms. Stinson before the meeting and I want to publicly apologize if you think I've treated you in ah, any fashion other than as a, a citizen and a friend. So, with that said, would you give us your name and your residential address please.

MS. STINSON: It's Edythe Elaine Stinson. Um, my concern is the post office leaving the City of Canton and my mail being directed from Akron back to Canton. Right now, I have a, which I use a P O Box out of that main branch there, so, it would be nice if we could keep that here and hopefully the mail does not have to go to Akron and then be re-routed back to Canton. So, that was my concern, that our postal service remain in the City of

Canton and not Akron and then back to Canton.

PRESIDENT SCHULMAN: Well, we all agree with that. Thank you very much. Ah, there are no other public speakers tonight. Thank you Ms. Stinson. Thank you Ms. Conner.

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: Ah, we're now under Miscellaneous Business.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Mr. President. I'd like to just ah, say there's ah, one of us, one of our members of this Council's having a birthday next week. I don't wanna say how old he is but, it's a 6 and an 0 and he's not a member of Council, he a, sets up in the front there and I just wanna say about Allen Schulman. Since Allen's a, became our President, he has brought leadership, he has brought intelligence and integrity to that seat. I, as a member of this Council, a, really applaud him for doing what he's doing as far as being a, ah, President of our Council and I wanna wish him a happy birthday, and many many more, but there's a, there's just a, he's an individual that I think we all got to know and like and, and a, I really appreciate everything you done for you and a, it's too bad you have a big case tomorrow, I'd buy you a coke tonight, but...(LAUGHTER) but happy birthday.

PRESIDENT SCHULMAN: And believe me, I'd take more than one. Thank you. *(APPLAUSE)* Thank you. Thank you.

MEMBER CARBENIA: Mr. President.

PRESIDENT SCHULMAN: Member Carbenia.

MEMBER CARBENIA: Yes, Mr. Casar, thank you for that paid advertisement (LAUGHTER). Ah, I had a couple of things I'd like to cover in a short time here. One, um, we are dedicating a, a, a, a new park on November 1st at 12:30 at a, um, at the end of a, Raff Road, 500 Raff Road North and I'd like everybody, if they would like to come, to come a, and I'm hoping the Mayor's gonna be there. I sent an invitation to the Mayor and so has the school, and Joe and, and all, the Mayor's cabinet and all of Council that would be there and, a, I want them to be there to see that a, the work that was done, it was done by volunteer, a, people in this city who are our trades people. They laid, they done the cement work for nothing, they put the roof on, they graded the property. We had people donate things, a, a, to make it cheaper and a, we're gonna have a nice park there with the ball park and a pavilion and everything else. They don't have a park out in that area. At that, I'd like to mention on the communications tonight, I have a communication, the first one, a, which is a, I sent a letter to the postal people inviting them to come to City Council and explain exactly what they're, what they're doing. What they're movement is. Um, today, I was up there on the picket line and I will be up there tomorrow on the picket line. I wasn't on there the whole time, but I was on there a little while a, and I will be going to the meeting Tuesday night. We're hoping that anybody, everybody here goes to the meeting because we're all concerned. We don't know what if, what they're gonna be doing. All I know is they're taking the people, the mail from there and as far as I know, the money that they run the postal service with is self-generating from the stamps and, and the mailings that they do. I don't think they get much money from the government. So, I'm not sure what they're

doin'. I, I, I know that a, the workers are concerned because they were out there with informational picketing and we need to get out there and support those people and let them see us. Now they were pretty happy to see me. (LAUGHTER) Tomorrow, tomorrow's, gonna be 9:30 in the morning 'til, I think noon they're gonna be picketing and the meeting is at McKinley High School on, 6:00 on ah, what's tomorrow, the 29th? Seven o'clock? Well, be there at 6 to get a good seat. (LAUGHTER) Make them pull it up, make them eyes open up a little bit because we are concerned. You know, the last time we had a meeting, and I'm sorry I'm runnin' over, Mr. President, but, the last time we had a meeting about, with the mail, is when they wanted to put those conglomeration boxes all around and we turned them around so, we need to go and we need to put the pressure and show them that City Council and the Administration are definitely against this. A, I guess that's all I have to say to you. Just try to be there. (APPLAUSE)

MAYOR CREIGHTON: Mr. President.

PRESIDENT SCHULMAN: Madame Mayor.

MAYOR CREIGHTON: Thank you. I'm going to go in order. First of all, thank you Monique for asking the question. This Mayor drives her own car, pumps her own gas, and buys her own gas and I have gone in every section of this community by myself. I do not have a body guard nor have I ever had a body guard and nor do I ever expect to have a body guard. Um, I, you know, I try to watch what I'm doin' at all times but I was at that center last night by myself. I did have supporters there. If you'd like to talk more about it afterwards, I would be glad to answer your question. Next question. Edythe, I want you to know that on behalf of the City, I did send a letter to State, I'm sorry, to United States Senators George Voinovich and Sherrod Brown as well as Congressman Ralph Regula, asking them to intervene on behalf of the city to stop the, a, post mark leaving, the loss of jobs, and the fact that they're gonna save a million dollars, I think you saw the quote in the paper, I wanna know if my stamps are gonna go down, and we all know what that answer is. So, I will be at the meeting tomorrow night and we have already taken that action and the third one is to Councilman West. Um, I just wanna make sure that, you know, last week, he talked about Schreiber School and I'm sure that um, we're happy to announce and I'm sure that you got an invitation, that they are indeed their PTO is having a fund raiser to replace the playground property on their school. (APPLAUSE)

PRESIDENT SCHULMAN: Thank you Madame Mayor.

DIRECTOR CONCATTO: Mr. President.

PRESIDENT SCHULMAN: Service Director Concatto.

DIRECTOR CONCATTO: I'd just like to thank Member Carbenia for his efforts at the park. Um as a Service Director, we had a lot to do, or, had some part at the park and Joe was a, instrumental in getting local unions, local, local trades to come in there free of charge um, to do that work there and a, and a, Joe, I just think that was great and I thank you for it and I think a, Members of Council should thank you for that effort and it saved us, not only did it save us some money, but it also showed a cooperation with the trades and what we're tryin' to do at the parks and you're to be commended. (APPLAUSE)

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Thank you.

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: Um, last week when I talked about Schreiber School, it wasn't just so much with the playground equipment, but it was throughout the whole City of Canton. It appears to me like, that the Y, they had indicated that a number of our playgrounds, in the city, in our city schools, were not like, I mean, could not meet ODJFS State Standards um, and one of the things that I'm happy to hear at Schreiber, I knew that they were gonna have a fund raiser, but I'm thinking, we still need a partnership to make certain that every playground in the city that serves our children are up to standards and up to codes and I think the other thing I wanted to in reference to that is when we look at, I mean, let me back up. When it comes down to, a, Schreiber School specifically. I did get a call and they did put mulch down as a result of us speaking here last week. So, that was one good move in the right direction. But, all of our playgrounds have to, we must make certain that they're accountable to our children and our tax dollars. Thank you.

PRESIDENT SCHULMAN: Thank you Member West. It's safety..... Ah, Member Hart, and then we'll get back to you Safety Director hunt.

MEMBER HART: Ah, I just wanna say in speaking for the minority and as a minority, I, I too wanna wish you the happiest birthday and ah,....

PRESIDENT SCHULMAN: Okay, that's enough, thank you. Next, ah...... (LAUGHTER)

MEMBER HART: And for your service to the community. I know when he took this position, there were a lot of people that were very surprised but I'm grateful that you did and I am very thankful in looking at Canton's future also in sustainability you know, what you've been able to achieve in a short time as a well you know, as a visionary will help, you know, future generations.

PRESIDENT SCHULMAN: Thank you very much. Thank you.

MEMBER KRAUS: Mr. President.

PRESIDENT SCHULMAN: Member Kraus.

MEMBER KRAUS: I just wanna remind everyone that when this came about, with the post office and we were contacted from the Mayor's office to myself to Joe, and Richard and everybody, we, we were right there. I mean, we had the resolution and, and I think we invited them down to speak at that time and we're gonna keep the doors open and Joe, I will try to be on the picket tomorrow if I'm not out knocking on doors.

MEMBER CARBENIA: I know you will be.

PRESIDENT SCHULMAN: Thank you Member Kraus.

MEMBER KRAUS: But, I think we, we, we gotta stick together on this. We've been in on the start.

PRESIDENT SCHULMAN: Um, Member Carbenia, if I could ask when are the pickets gonna be out other than

tomorrow? Do you know? Do we know?

MEMBER CARBENIA: No. All I know is that they were out today from um, 2:30 'till 5 or something, I had to leave early. Ah, but, I think tomorrow it's only 9:30 to 12 or something.

PRESIDENT SCHULMAN: Okay.

MEMBER CARBENIA: They didn't tell me any more.

PRESIDENT SCHULMAN: But, tomorrow night at McKinley....

MAYOR CREIGHTON: McKinley at 7:00 and I do be.... and I'm sorry Mr. President, I didn't mean to interrupt you.

PRESIDENT SCHULMAN: That's all right Madame Mayor.

MAYOR CREIGHTON: ...but, ah, I think, Carmine told me, who's President of the Union, that it's just the 2 days of information picketing.

PRESIDENT SCHULMAN: All right. Thank you. Assi.....

MEMBER CARBENIA: Yes, and....

PRESIDENT SCHULMAN: I'm sorry, Member Carbenia.

MEMBER CARBENIA: I'm sorry and....

PRESIDENT SCHULMAN: That's all right.

MEMBER CARBENIA:the only other thing I'd like to add to that. The only news media that was there was ah, ah, camera man from Channel 3 I believe. I, I would hope that ah, our news media could get into ah, that, at the school anyway and, and cover that so our citizens would know. They, they had an article in the paper about, you know, about the meeting, so, I just hope that they carry out that.

PRESIDENT SCHULMAN: Madame Mayor. Just a point of information. How many jobs are we losing?

MAYOR CREIGHTON: Mr. President. They said 10 and he's tol.... and what he said is that they'll not be, ah, they won't lose their jobs, it'll be through attrition and they'll offer them jobs in other areas. But, we all know that once they start the ball, then there's no stopping it.

PRESIDENT SCHULMAN: Okay, thank you.

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: Um, does anyone know if they even had consideration of moving Akron to Cleveland keeping Canton's post? Does anyone know?

PRESIDENT SCHULMAN: Doesn't sound like it. Ah, Safety Director Hunt.

DIRECTOR OF PUBLIC SAFETY: (Sigh) Thank you Mr. President.

PRESIDENT SCHULMAN: You're welcome.

DIRECTOR OF PUBLIC SAFETY: I want to take this opportunity to thank ah, Councilmember Hawk for ah, information resolution #77. He and I spoke ah, concerning this Resolution and the need to put it possibly on our police sub-station. I think it's well worth it. Councilmember Hawk not only has been helpful to our substation for this, but also for funding for Weed and Seed and I just want to go on record to thank him for ah, his help.

PRESIDENT SCHULMAN: Thank you Safety Director Hunt. Ah, Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Thank you Mr. President. A few reminders, for those of us who are elected officials. I've checked with the AG's office, the Attorney General's Office, and even though our terms are up, most of us, December 31st, we have to get our Public Records Training in before the end of the year and again, some time during your next term, or your designee. It could be you, as an elected official, or your designee and the web site has listed, lists of training sites. Um, I wanted to commend John Labriola for staying over and talking with a concerned citizen who's here tonight who didn't get to sign up quite in time, but shared some good opinions about ah, the inconsistency of application of duplexing laws and the reversion time back. Ah, Mr. Labriola will be talking with Mr. Tressel as will we in the Law Department. Thank you for coming. And lastly, um, I've already met my quota for wearing tights this year...(*LAUGHTER*) in a Shakespearian production so I won't dawn a blonde wig and sing to you as someone did 40....7 years ago to our President... but.... (*SINGINGLY*) happy birthday, Mr. President....

PRESIDENT SCHULMAN: Thank you ah.....

LAW DIRECTOR MARTUCCIO: ...happy birthday....

PRESIDENT SCHULMAN: Thank you.

LAW DIRECTOR MARTUCCIO:to you.

PRESIDENT SCHULMAN: Thank you. (OVERWHELMING APPLAUSE & LAUGHTER) That's why I love having Joe sitting next to me during these meetings. You don't know what... you don't know what happens before the

MEMBER CARBENIA: That's Italian style.

PRESIDENT SCHULMAN: motion and the second. Um, I just wanna say one thing if I might, take some ah, Presidential prerogative if I might. First, thank you very much for the kind words. I appreciate it. I love working with all of you. You are an extraordinary group of people. I really mean that, um, from our great leader to our minority leader to our Mayor and her Administration. It's been a joy working with all of you and nothing

happens by itself. I do wanna commend all of you as I did the other day, at the sustainability meeting and I know some of you simply couldn't attend because you're working and you have other things to do, but, the ah, outpouring of support for this is incredible and you're all to be commended. It takes, and I commended the Mayor, also, obviously and her Administration, it takes incredible leadership, and ah, I think thinking about the future, some fore-thought here, ah, in this effort, I made 2 comments when I spoke and had the privilege to speak the other day and that is, in Georgia, in Atlanta, they have 3 months of water supply left, and they keep saying well, this is just a very unusual drought. It's just a, it's just the worse drought we've ever had. Climatologists say it's not the drought that is going to be your climate. And then we saw, in the last week, the ravaging of California with the worse fires in the history of the United States displacing 750,000 people, 750,000 people and burning millions of acres and this is not by accident. So, we need to, not only come out with reports such as this, en, en, enlist your support, we need to make things happen and I know the Mayor and I know the leadership of City Council is committed to do the very thing. Finally, in that regard I note tonight we had an Informal Resolution about our water supply, which comes of course, in light of what we've seen throughout the country but, I'm not sure we understand just one aspect of bottled water. Bottled plastic water. In the United States the plastic bottles produced for water, require 1.5 million barrels of oil a year, enough to generate electricity for 250,000 homes or fuel 100,000 cars for a year. Bottled water has now become the most, not recycled, the greatest product in our landfills and there's no excuse for it and Member Casar has been preachin' this for 30 years. Almost all of it comes from Municipal tap water and there's no excuse for it and we've asked the Law Director to look into whether we should pass an Ordinance prohibiting bottled water from being sold in Canton. It's a courageous step. We should think about it. We should investigate it and ah, we should vote on that eventually. Ah, but in any case, I wanna congratulate all of you for your leadership. Apparently, people ah, people, they may not be ready to ah, stop bottled water in Canton but I think we should look into it. But, thank you for your leadership.

SERVICE DIRECTOR CONCATTO: (INAUDIBLE COMMENTS) (LAUGHTER)

PRESIDENT SCHULMAN: Member ah, or, I'm sorry, Service Director Concatto's gonna be arrested after the meeting tonight. Member Hawk.

MEMBER HAWK: Mr. President. There's some very, reading through the Mount Vernon Neighborhood News, they've given us a wonderful piece of advice, a wonderful reminder. It says, take your right, take your right, take the right idea to the polls. So, in other words, they're asking you to, you must, this is law, you must present identification in order to vote, so, as a reminder from the Mount Vernon People, please..... take an ID with you to the polls when you vote next week. Thank you.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Mr. President. I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: Madame Clerk, roll call vote please.

NO REMARKS ROLL CALL: 12 YEAS, 0 NAYS

CLERK TIMBERLAKE: Twelve yeas Mr. President.

PRESIDENT SCHULMAN: Meeting adjourned. (GAVEL FALLS)
