PRESIDENT SCHULMAN: It's been moved and seconded that you postpone ah, a hearing on Ordinance #14 until November 26, 2007. Are there any remarks?... Roll call vote please, Madame Clerk.

ANNOUNCEMENT OF COMMITTEE MEETINGS

PRESIDENT SCHULMAN: We're now under Announcement of Committee Meetings.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: The Parks and Recreation Committee will meet November 26th at 6:45.

PRESIDENT SCHULMAN: Thank you.

MEMBER HAWK: Mr. President.

PRESIDENT SCHULMAN: Member Hawk.

MEMBER HAWK: Finance Committee will meet Monday, November 26th at 6:45.

PRESIDENT SCHULMAN: Thank you. Is that it?

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: We're now under Public Speaks, open forum. We have 1 speaker this evening. Ah, it's Philip Papadopulos. Mr. Papadopulos. Good evening. If you'd step forward. I, I think you have been here before, so you are familiar with our ground rules. Could you give us your name and your residential address please, sir?

MR. PAPADOPULOS: Yes. My name is ah, Philip V. Papadopulos.

PRESIDENT SCHULMAN: Would you do me a favor? I don't know if that microphone is on, Member Kraus or.... you're gonna have to speak louder. Sorry, the sound system is not really that good here.....except it is when the Clerk tells me I did something wrong, then it's perfect.

MR. PAPADOPULOS: Hello?

PRESIDENT SCHULMAN: Go ahead sir.

MR. PAPADOPULOS: Yes. My name is Philip Papadopulos and ah, I reside at 1042 25th Street NW, Canton, Ohio.

PRESIDENT SCHULMAN: Good evening.

MR. PAPADOPULOS: I would like to ah, I would like to thank Canton City Council for the opportunity to speak. I am asking Canton City Council to reconsider the proposal to build a Fire Department Training Center at Walsh Park located at 25th and Cleveland Avenue NW. This facility would be adjacent to the Canton Christian Home, a home for the seniors and elderly and would create a nuisance for the elderly with the added noise at this location. Additionally, it would involve the destruction of the soccer field there which Canton City Council built for the Canton Invaders, a number of years ago, which is still in use, contrary to what, you know, many people's perception. In addition, and this is a little known fact. Just west of the soccer field fence, there are 4 oak trees, first old growth oak trees. Two of them are 9 feet in circumference, the other 2 are 11 feet in circumference. They are huge trees. It's hard to notice them like, when you just drive by but if you walk near them, they are there. They are between 125 and 150 years old. Just north of the soccer field, within a few feet is another old oak tree, which is 16 feet in circumference which means it's close to 300 years old. It was there before the United States Constitution was ratified. This tree would also be placed in jeopardy if this location was used to build this facility, and, I'm asking ah, the City Council Members to consider ah, these facts and perhaps, consider another location which would not involve destroying the trees and destroying part of one of Canton's parks. Thank you.

PRESIDENT SCHULMAN: Thank you Mr. Papadopulos, very much. Thank you sir and have a happy Thanksgiving. We have no other speakers so...

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: We are now under Miscellaneous Business. Is there any miscellaneous business? Member Hawk.

MEMBER HAWK: Mr. Chairman. I'd like to thank Mr... Councilmember Griffin for donating the City's Christmas tree again this year. (*APPLAUSE*) That's the second year in a row, and I.....

MEMBER GRIFFIN: My pleasure.

MEMBER HAWK: ...and I believe that we will be sending you a bill for the landscaping for removing that tree because we can use it.

MEMBER GRIFFIN: And mowing the lawn, that they, the grass seed that they plant.

MEMBER HAWK: Yeah, we're billing you for that. In other wards, you're paying us. (LAUGHTER)

PRESIDENT SCHULMAN: Thank you Member Griffin.

MEMBER GRIFFIN: I'm going to complain because, you know, without that tree there, there's extra light coming into my bedroom and I don't know if I'm gonna be able to sleep. So, I'll be calling them tomorrow morning to see what we can do about that. *(LAUGHTER)*

MEMBER KRAUS: Mr. President.

PRESIDENT SCHULMAN: Member Carbenia..... ah, I'm sorry. Would.... Member Kraus.

MEMBER KRAUS: I just wanted to remind everybody that ah, the Canton Ex-Newsboys things are coming up um, Wednesday, the 12th of December, we have a ah, kick-off banquet. Tickets are \$20.00 a piece, guest speaker's Denny Saunier. It's at Moonlight Ballroom. I have tickets for that and the following Friday we'll be out selling newspapers. I'll be in city hall so bring your, bring your money. Thank you.

PRESIDENT SCHULMAN: Thank you Member Kraus. Member Carbenia.

MEMBER CARBENIA: First, Member Griffin. Um, call your Councilman if you want to complain about light coming in your window. *(LAUGHTER)* Secondly, ah, as you know, I sent a letter to the post office asking them to come to this meeting and explain their issues. Ah, we got a call today, from a Victor Dubina, who refused to come for whatever reason saying that he already had a meeting with the public. Sounds like, you know, sounds like this is a done deal. But, I just would ah, like to say that you know, there's some things that, that, that go on at those um, that, at that Akron post office that ah, somebody had called me and told me about years ago, a few years ago, somebody was caught changing the color code so they could work overtime or, the company was changing, the ah, postage mark, the color, to show what day it came in, so, just what we were saying, that it's going to delay our mail. But, if they change the color or the post mark, it's gonna look like they, the mail's not delayed. But, ah, eventually, they're gonna move this place and ah, I don't know what we can do to stop them other than blockade 77 North. Another thing that goes to Akron and Akron does not deserve this and we don't deserve them moving out of Canton as they did in Mansfield, not too long ago. Thank you.

PRESIDENT SCHULMAN: Thank you Member Carbenia. Member Cirelli.

MEMBER CIRELLI: Mr. President. Thank you sir. Questions to the Law Director. I made a phone call and maybe it didn't get through, but in today's paper was a big article and I've had some constituents who probably know what I'm talking about. So, could you maybe speak on that sir, I would appreciate it.

PRESIDENT SCHULMAN: Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Thank you Mr. President. Member Cirelli did call me today and left a voice mail. She was concerned on behalf of her constituents, all of your constituents, about an advertisement placed on A-6 of today's Repository in which ah, in very fine print, the ah, utility known as Dominion East Ohio is putting the public on notice that they have asked PUCO for permission to raise their rates. They have indicated in that ad, and in their filings with the PUCO, which you can access by the way, anyone can access, on the website. It gives you the address on page A-6 of today's Repository. Ah, you can call or write them as well. Um, essentially, what they're saying is they have had costs that they have to recover. That they're no longer in a situation where they're recovering their costs and they would like various aspects of transporting the gas, covering the gas, delivering the gas, ah, so various components of their bills to people who are on Dominion East Ohio or their sister affiliate, ah, Dominion Energy, they're asking PCO, the PUCO, the Public Utilities Commission of Ohio to grant them the right to raise their rates which is what they have to do by State law. So, it's an advertisement that's required by law and it's also a form of public relations for them as well. Um, if anyone wants to, they can write to the PCO, PUCO or attend the hearing that is scheduled to explain why they think ah, this company should not be entitled to recover what they claim are lost revenues. Thank you.

PRESIDENT SCHULMAN: Thank you Law Director Martuccio. Member Cirelli.

MEMBER CIRELLI: (INAUDIBLE)

LAW DIRECTOR MARTUCCIO: Mr. President.

PRESIDENT SCHULMAN: Law Director.

LAW DIRECTOR MARTUCCIO: It's a good question. Good follow up question. Ah, if you are in a separate aggregation program, the city's or someone else's, you've all been getting letters at home, I'm sure. Um, the, the contract price that you agreed to, \$9.99, \$9.49 for mcf, will remain the same through the period that the letter says it's supposed to be. For example, if you're locked in 'till September of 07, you're locked in 'till September of 07 at that rate. Um, what may change in the future, is the underlying costs that the utility charges to deliver the gas, if the PUCO allows them. Now, those are future costs, so they may not effect your current contract. Ah, if you don't mind, by the way, I'll give you an update on the city's program. Some of you have forwarded emails to me, um, thank you, indicating that um, some people in, in the city are not happy with what's going on with the city's aggregation program. This is what's going on. Right now and through December 31st, this year, so that's for the next 6 weeks, we, city residents, who are in that program, are paying \$10.99 for mcf, including transportation charge ah, but there's also a separate charge that, as you all know, shows up separately, from Dominion. That's the fixed price for the mcf. What is yet to be determined, is the price that we, in the aggregation program, will pay for January, February and March, the 3 cold months. Um, after that, there's good news. We have a, another broker who has arranged for some very competitive pricing and some very very good terms. We're happy to announce, that come April of 2008, and thereafter, ah, we'll have Vectron again but there

will be no fees. Let me repeat that. No cancellation fees should anyone decide to leave Vectron. They heard loud and clear. They were also concerned that because of the way that we got caught in high prices over a year ago, and having to blend out for the remainder of the year, if you recall it was going to be 11-something and by extending it more, by doing an blending-extend, it came down to \$10.99. Now, bottom line is, you're wondering, okay, what's the price gonna be for January, February and March? We don't know yet because we're hoping that um, December, this year is like December last year, when there was a glut of storage and there were no hurricanes anymore and as you all remember last year in December, you got flooded with letters at your homes for independent energy providers who were offering you great deals. We're hoping, that by holding out a little longer, we can get a better price. Now, we're at a disadvantage because we're only bidding on 3 months, the 3 coldest months. These plans you get in your mail are for a year or 10 months including the hottest months of the year, which can offer a bigger discount. So, please don't be surprised if the price per mcf is in the 10s and again, this being a free country, if you get another offer, um, and you're not good at tolerating risks, you may want to look at it. On the other hand, I, as a public official, helped to bring Vectron to this town, will stay with this program, whatever it is and wherever it goes. I hope that answers your question.

PRESIDENT SCHULMAN: Thank you Member Cirelli. Member Hart.

MEMBER HART: Um, just for all the members, I had a communication um, you know, concerning ah, developing a, a fund for students that might be low to moderate income where they might be able to use, ah, some funds to help them pay for ah, application fees and that for college because at the high school level, there's many students that ah, have the brains but even when it comes to that first hundred dollars for making an application, can't make it and the idea was to use a very small portion of inheritance tax, um, to help fund, begin to fund that program and then with the high schools, ah, notify the students at GlenOak, ah, McKinley and Timken. You know, I've talked to some of the member along here that would be willing to ah, co-sponsor that and if anybody else, if you haven't read it, the communication is in there, ah, in the box and then there was also a letter in your mailbox concerning if you'd be willing to sponsor that, and you know, please let me know if you're, if you're willing. And, also, um, for the Mayor and Service Director. I talked to the Principal at our school Bob Vero and if we need a, a, a place to ah, you know, kick off the recycling program here before the end of the year, um, you know, would be more than happy to have that done at Harter School.

PRESIDENT SCHULMAN: Thank you Member Hart. Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Thank you Mr. President. Two things. This Council had asked me to look into the possibility of doing something about plastic water bottles, perhaps banning their sale. That could be tricky. There's something known as the Interstate Commerce Clause, which, essentially says, we shouldn't mess around with Interstate Commerce unless we have a compelling reason. What I would suggest and come back to Council with, given the spirit of what you've asked me to do, is to encourage some sort of deposit program, like some cities and states have for returning ah, bottles for a nickle and/or passing a resolution to recycle their own plastic gallons by going to places like Fishers, which is a local company and putting your quarter in the machine, and you know, getting several gallons of water at a time for drinking and recycling your plastic jugs that way. Um, second issue. Um, Mr. Papadopulous, a couple of people have asked me to comment about the trees. Thank you. Mr. Papadopulous is a very conscientious citizen and a very good cook by the way. Ah, he has come to Council and has politely asked that ah, we look at alternate plans. Ah, we had discussions, he and I and, and, our Assistant Law Director Tom Burns about the, the restrictions that go with the land and the covenants and so, but, as to get to the trees, ah, when that was brought up, I called Rod Meadows, who's the architect for that particular project and Rod called back and left a voice message saying he is aware of how old these trees are

and how beautiful they are and he will do everything in his power, as the architect to make sure that we can go around them. I'm not sure if they can all be saved, perhaps, but, he will try to do what he can as the architect of the project to save these ancient and beautiful trees. Thanks for bringing that up.

PRESIDENT SCHULMAN: Thank you. Ah, just 1 comment. Ah, we have the road map to sustainability, ah, here, if you have not received it, they're in the Council Chambers and we have more copies up here. I'm gonna keep, I'm gonna keep pressing this issue we hear about the cost of gas, which is not gonna go down. We hear about 300 year old trees which ought to be saved and we should demand, frankly, that they be saved. I, I, I can't believe an architect can only say, we'll do our best. I think this Council should insist that it, that those tress be saved. Ah, they are our heritage and we need all the heritage we can get. But, I, I just wanna say, this is a great plan. I've talked to the leader, I've talked to a number of Councilmembers. I think ah, we're all in agreement, that 2008 is going to be the year of the neighborhood. That we've done a spectacular job with our city and it's time to turn to our neighborhoods. We have major problems in our community and they all stem from our neighborhoods and I think we can all assure the members of the public, I know I've talked to the leader and he is dedicated to this proposition and has been for 30 years that if we don't have neighborhoods that are vital and vibrant, and, and, really caring about each other, this city, no matter what happens downtown, we're in serious trouble. This is the road map. I'd ask each of you to read it and I think we can incorporate a number of these ideas. They're very simple and yet at the same time, um, ah, they can be very effective in saving the city. So, anything else? Member Casar.
