The special meeting of Canton City Council was held on Tuesday, January 1, 2008 in the Canton City Council Chamber following the swearing-in ceremonies held at 11:00 A.M. The meeting was called to order by President Pro Tem Casar.

PRESIDENT PRO TEM CASAR: According to Council Rules, we must appoint a Pro Term....Pro Tem Officers and I will appoint Cindy Timberlake as our Clerk of Council Pro Tem, Beverly Bevington and Michelle Senter as our Staff Pro Tem. Would you please ah....Roll call please.

OPENING REMARKS

PRESIDENT PRO TEM CASAR: We will have ah...opening remarks. Ah...I would just like to say as Majority Leader, I want to first welcome the two new Members of Council, 4th Ward, Chris Smith and 7th Ward, Pat Barton. I am looking forward to working with them. They ran a hard aggressive campaign and I'm sure that they will be.....their constituency will be proud of them and they'll do a great job in the

2008-2009 term. I'd also like to wish the Mayor good luck. Mayor Healy, ah....was elected also as we all know. I wish him ah...the best of luck in his administration. And I want to tell him that at this particular point that this Council will support and we will have ah...a good relationship, we will cooperate, we will communicate and we will do the job to the best of our ability for the City of Canton and I'm looking forward to ah...working with he and his administration, especially Thomas Bernabei, who will be the ah....Service Director and the Chief of Staff, or whatever name they come up with at that....when it comes about. But I would also like to take this time to wish you all a Happy New Year and thank you very much for coming down here and attending this Council Meeting, it means a lot to the citizens of Canton....ah...to us Council people that the citizens do get involved and I know this is a special day because of all the friends and ah..family out there but I would like to....give yourself a round of applause.

PRESIDENT PRO TEM CASAR: Mayor Healy, would you like to say a few words please.

MAYOR HEALY: Thank you. Happy New Year.

AUDIENCE: Happy New Year.

MAYOR HEALY: I'd like to ah...first begin by thanking everybody for coming down here. Oh, I have to hold it? Okay, I'm learning, it's the first day. But I would like to thank everybody for coming down here and sharing this day with us. It is a....is a monumental day for...for our family and certainly for the City of Canton. I'd like to thank ah...all the existing ah...current Councilman and the new members have...have come in...ah...Leader Casar and ah...Allen Schulman, who happens to be missing ah...but...but will join us ah...shortly. Um... I...I'm just looking so forward ah...to...to beginning our duties and working together with this wonderful Council to...to help move the City forward and continue moving the City forward. Um...I would like to ah...also...um...send a little message...ah...a little thank you ah...to Mayor Creighton as well...ah...who worked so hard and...and put her heart and soul into this City and ah...and certainly left her mark. And...and, you know, we want to make sure that...that she has a wonderful New Year and...and whatever endeavors that she wants to pursue ah...we wish her the best as well and....and is currently... Ah, also in addition to that ah...with her administration...ah who worked so hard for the City and...and we certainly ah...ah don't want to forget the work that they have done. But ah... with that being said and ah..thank her for all of her hard work. Um...we're very excited about ah....about looking at the...the challenges and opportunities ahead and um...today I'm not going to spend a lot of time about those issues, we have plenty of time to....to get into that. Ah..this is a day of celebration, a day of hope ah...and a day about preparing for our future. And so, with that, again I...I want to mention to the

Councilmembers, I look extremely forward to working very closely with you and ah...and putting our policies and ideas together and moving this City forward. Thank you for everything and um...let's get started. Have a great year. Thank you.
