They are treated with lack of human decency and no dignity. They are also degraded and afflicted with physical and psychological torture in an exchange for goods or money. Most women are lured by offers of legitimate work as shop assistants or waitresses while some are promised marriage, education and a better life. Others are sold into trafficking by boyfriends, friends and even family members. Human rights groups estimate that between 12.3 million and 27 million people are enslaved in force or bonded labor, child labor, sexual and involuntary servitude; and WHEREAS, Soroptimist International of Canton/Stark County's major project, the Women's Opportunity Award, provides women heading a household with the means to improve their education, skills and employment prospects. #### PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: We're now under Public Speaks Open Forum. We have 2 speakers signed up this evening. I know that I recognize one. I probably should recognize both, but in any case, um, for our public speakers this evening, just be reminded that Council does have a rule that limits your presentation to 3 minutes and I don't like to be rude and interrupt people so, try to hold your, ah, your remarks to that time period. As I've always said, Members of Council, the Mayor, his Administration will be here to speak with you about any of your concerns after you address us. So, the first speaker tonight is Patricia Kirk. Ms. Kirk, good evening. And, I know the last time you were here, you were... so, speak up because I know what you have to say is, is important to us. Thank you.

MS. KIRK: All right.

PRESIDENT SCHULMAN: And, would you give us your name and residential address and again good evening.

MS. KIRK: Thank you very much. Can you hear me okay? All right. I can't hear. (giggle) Um, my name's Patricia Kirk and I live at 131 5th Street NE in Canton and I'm President of Shake A Leaf which is a local citizen's environmental group and we improve neighborhoods that way. I would like to remind you tonight about the 100 to 200 year old oaks that are at the 25th and Cleveland NW area where a new fire station is being proposed. That's where the old one is right now. I took another look at the blue print at Motter and Meadows office, and the new fire station would be 2 to 3 times bigger than the old one, plus the old building, plus a large road encircling the property and what is not building or road is a sidewalk. Yes, the oaks are still standing. The other trees would be taken down, bu their green space containing their roots are gone or used in the construction of this big building. Isn't there a way to split this... and I think, ah, the Meadows, Motters and Meadows Construction Agency, or Architectural agency would listen to this but, why does everything have to be at 1 location? Isn't there a way to split this? There are enough abandoned properties. There's other city-owned properties that you can have 2 parks and the benefit of the parks can sometimes greatly outweigh other things. For instance, even downtown in the old Kresge Park. It's funny, but in the last ah, city election that we had, 1 constituent said that that was the only thing that they remembered was the park, and when people go by the park, they smile, they slow down, they look around and that's one of the ways to attract people to the city. Um, there are 248 cities in Ohio that know how to do this but, why can't Canton? Also, we'd sortta like to hear what the Council thinks about this. Shake a Leaf does have a post office now. It's number 20995, zip code 44701. Um, please let us know what you think. Thank you.

PRESIDENT SCHULMAN: Thank you very much for your concern, and I like the fact that you keep reminding us. Thank you. Sometimes ah, repetition is a good thing. Our next ah, speaker is Linda Campbell. Ah, Ms. Campbell, good evening. If you'd step forward and give us your name and residential address please.

MS. CAMPBELL: My name, can you hear me? My name is Linda Campbell. My address is 1016 Struble Avenue NE and that's Canton, 44705 is my zip. My issue is ah, we do have some railroad crossings that I, that are very dangerous and one in particular that I want to address is located in the 900 block of 10<sup>th</sup> Street NE and that number, 474394B. At this crossing, there's no indication, no flashing lights, or no cross bars. Nothing that would indicate ahead of time that ah, there's a train on the tracks and so, I was wondering what could be done on, ah, at crossings like this that could make it more safe for people traveling in these areas, um, with no lights, nothing that indicates there's a train on the tracks, you know, so, this is, this is my main issue and, it's definitely, I do have some pictures for the ones that.....

PRESIDENT SCHULMAN: Well, we'd be happy to look at them. If you want to give them to Member Kraus, he'll pass them around.

MS. CAMPBELL: Okay.

PRESIDENT SCHULMAN: Thank you.

MS. CAMPBELL: Um, basically, that's my issue.

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West

MEMBER WEST: Um, this is also one of those issues that there was a number of railroad crossings that was supposed to be closed and some was supposed to be re-done. This particular one does not have any lights. It does have a yielding sign, however, the yielding sign is behind a fence so it's kindda hard to see when you're driving up and then there's some bushes around there. Now, we did send this to the last Administration, however, in the cross-over, of course, with the change of Administrations now, we're back at this point. So, I'm not certain who to talk to about whether that was one of the railroad crossings that was supposed to close, um, or be re-done.

She was only 5'4", I mean, it was a terrible thing so, if you could, if you could lead us in.....

(A MOMENT OF SILENCE WAS TAKEN FOR VERNA BENNNING OF CARROLLTON, MOTHER OF 4, WHO WAS TRAGICALLY KILLED AT THE TIMKEN COMPANY IN AN ACCIDENT INVOLVING A STRADDLE TRUCK)
