And I continue to say that we have the right people, the right mind set, the right resources, the right size of a community to make a change and to really make a difference when it comes to crime and violence in our community and we can turn this around together if we just take a unified effort and stand as one. So thank you once again for being there and I want to thank The Repository too for the excellent coverage they gave of the event. But thank you all for at least keeping us in your prayers and thoughts. Those of you who wanted to be there and emailed me. But those of you who were there, thank you so much for being there. Thank you.
