MEMBER SMUCKLER: Um, people signed up for city business. When, when are they allowed to speak? Because, someone wanted to speak on the Pastime Inn.

We, my wife, we have not been here for about 6 or 7 months and the last time we had heard was that it was pretty much stalled down in Columbus, suspending the liquor license. The owner of the bar has appealed it and appealed it and appealed it. Already, ah, people that lived in the neighborhood had been forced to move, not because they wanted to, but because of the Pastime Inn and what goes on there. I'm 63 years old. I've lived down there since 1966, we're not going any place, regardless of what happens down there, we're not going anywhere. All I'm hoping is that you can get the place shut down permanently. Like I say, right now, it's like day and night. You cannot believe it's actually, even sitting in our house, it's enjoyable. You don't have the cars going by, the baboom, baboom, baboom, from the stereos. You don't have the prostitutes, you do not have the drug dealings. It's, like I said, day and night. Thank you very much. (APPLAUSE)

PRESIDENT SCHULMAN: Thank you sir. We appreciate your perseverance. Ah, are there any other remarks?... Member Smuckler? Okay, if not, by voice vote, all those in favor signify by saying aye. Those opposed nay. Resolution #16 has been adopted.

Now, 2 of those are vacancies that are not going to be, could potentially be filled, but are not filled right as of this present time. But, I do have a problem with the fact that ah, they'll be 2 people in the CD department, that's Community Development, with a total of \$129,260.00 would be their salaries ah, the former Administration, and that's coming in, the former Administration had 1 person in that capacity leaving at \$97,500.00 and I also am very consistent to whatever office I have held because of the benefits that are added on top of these positions in government usually takes into another 1/3 of the dollars, and, I'm only 1 person but, I'm going with my guts and I think we are at very much in a precarious financial situation, ah, our entire country is right now and I'm not comfortable um, voting for this at this time, so I'll vote no.

PRESIDENT SCHULMAN: Thank you Member Cirelli. Are there any other remarks?

MEMBER PRATER: Mr. President.

PRESIDENT SCHULMAN: Member Prater.

MEMBER PRATER: Yes, I... a question for the Law Department, some clarification please. We have in front of us the Ordinance that states amendment. Do we have to vote on the amendment first or are we voting on the whole package?

PRESIDENT SCHULMAN: No, we'll, well you'll be voting on the amendment, because Member Casar will move to amend in just a minute.

SAFETY DIRECTOR NESBITT: Yes, I'd like to address the Pastime ah, ah, situation. Ah, 7 to 10 days ago, Mr. Meola, his wife, the owners of the establishment and 2 employees came in to talk to the Mayor and myself. Ah, they had concerns, of, of what is taking place there and asked what we could do and, and how to help with this situation. The Mayor told the Meolas that the only thing that's acceptable is for the establishment to be closed down. It's a nuisance ah, to Canton and the behavior there and goings on are totally unacceptable and ah, Mr. Meola, at that time, asked that he wanted to try to close a little earlier to address the concerns there and again, the Mayor reiterated to him ah, that that was not acceptable that the establishment needed to be closed and ah, and we felt that that meeting was productive and also, the Law Department is work as well with us in, in dealing with this situation. (APPLAUSE)

PRESIDENT SCHULMAN: Thank you Safety Director.

MEMBER SMITH: Mr. President.

PRESIDENT SCHULMAN: Member Smith.

MEMBER SMITH: I also would like to say to Mr. DiGiacomo, I am glad that you're at peace with the Pastime Inn. Also, when the weather breaks, I'm gonna come over and sit on the porch with you also. (LAUGHTER) So, as soon as the weather breaks, I'll be over.

MR. DIGIACOMO: (SPOKE FROM THE AUDIENCE WHICH WAS INAUDIBLE)

MEMBER SMITH: Okay. Well, that would do just fine.

PRESIDENT SCHULMAN: With that we may all be down there. (*LAUGHTER*) Can you give us a date? I know that Member Hawk and Member Smuckler only like to go down there, you know, when there's shootings and the police are out, but.....

MR. DIGIACOMO: (FROM THE AUDIENCE) They were in the thick of it.

PRESIDENT SCHULMAN: ... and they were in the thick of it. Any other remarks?

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: Ah, several weeks ago, I put through a communication for the YMCA to ah, a communication for the YMCA to receive \$32,000.00 for the YMCA and Northeast Community Center, and um, I haven't heard anything back yet from that, but I wanna make certain that even though with that we have a tight budget, I wanted to make certain that people are, realize that we can't afford not to support water

recreation and recreation this summer. So, I don't know who, who received that Ordinance, or that communication. Was that the Law Department, or... it's you? Okay. You wanna respond to that.

MEMBER HAWK: (INAUDIBLE RESPONSE)

MEMBER WEST: What answers do you need?

PRESIDENT SCHULMAN: Member Hawk.

MEMBER HAWK: We'll discuss it in committee. I haven't received all the information I've requested from um, the YMCA. It still needs to be reviewed, ah, and it has to go through a separate Ordinance and, it's actually contingent on what we're gonna look at a budget, ah, you know, it was requested actually for \$36,000.00 not \$32,000.00. Ah, you sponsored it, you should know what the number is. I'm taking a look at it now. I did not sign that out to be turned into legislation until I get a full review of everything and see how it fits in our budget. Last year's number was \$25,000.00. I still, again, the YMCA billed us once for \$4.50 per person, they billed us the next month for \$5.75 per person, and then they billed us the third month at \$6.00 per person. So, as I look at the billing on it, I have questions on the whole process, but the Y's pool is also not open. So, I don't know how you can have an aquatics program when you do not have a pool that's even open. I have issues.

MEMBER WEST: Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: Um, actually, I think we did address those issues. There was a letter sent from the Y and yes, the secretary's did receive to give it to all Councilmembers and it discussed the issue they serve 750 youth. Those were for Y passes and Northeast Community Center gave \$40.00 per Y pass, or pass and that not only included water recreation but it also included a pass for all recreation so that they could just play basketball and do other things as well. So, I'm not sure if you got that communication, but that did come through ah, about a week or 2 weeks ago. I remember receiving that. Um, but I wanted to make certain that we are ahead of this and being pro-active to summer recreation because if we don't, we will see these kids in the community creating havoc um, so I just wanted to make certain that we're on top on it. (APPLAUSE)

PRESIDENT SCHULMAN: And from what I'm hearing, I, I don't think you 2 are at cross-purposes I think ah, Member Hawk is simply addressing the issue of the budget and that's a floor consideration and obviously you have a concern ah, for the youth of our city and I think that's probably something we all do.

MEMBER WEST: And I'm not fronting..... ah, Mr. President.

PRESIDENT SCHULMAN: Sure.

MEMBER WEST: I just wanted to make certain that, I didn't know where the process was at. I didn't know that it was in Finance and being held up. Actually, I thought it was already in the Law Department, coming down for an Ordinance. Um, I also wanted to talk about the Grant Writer. I think that's something else that we need to start looking at and more specifically, we have grant dollars at state level and federal level that we can apply for and to hold those things up is going to further delay resources coming into the city. (APPLAUSE)

PRESIDENT SCHULMAN: Okay. Thank you Member West. Ah, I have 1 remark, but, does anybody else have any miscellaneous business?... I don't know whether I had an opportunity, I wanted to thank Member Barton for our neighborhood meeting. He secured the room at Malone College, Malone University and ah, I do appreciate all your hard work and effort that went into that. You'll also, and I, I obviously would be remiss if I didn't thank the Majority Leader for ah, taking my position, when I was off. I appreciate that. I apologize for not being here. Sometimes I do have business out of town and it's actually business and not ah, pleasure. Ah, lastly, I know Sam Sliman is here and, the banner you see behind us, ah, was Sam's business that did this and I think it's a clear reminder of what we're trying to do Mr. DiGiacomo, among others, you're of the neighborhood. We need to make our neighborhoods safe and strong and vibrant and that's what we're intending to do and I know that I spoke to Mr. Balent from the Repository, as a lot of us did, and indicated to him that we were not trying to cut the public out and I know Majority Leader Casar mentioned that and I would like us, if we can, to take a look at our calendars ah, to see whether or not we might be able to have another neighborhood meeting either of the 15<sup>th</sup> of March or the 22<sup>nd</sup> of March. Member Casar.

MEMBER CASAR: Mr. President. If I may. If I may. Before we set a date, let's discuss this.

PRESIDENT SCHULMAN: Okay. Fine. Fine. But I think it is important that we do that and, I think the neighbors ah, would like the opportunity to speak and I know Majority Leader Casar is strongly in favor of that.

MEMBER CASAR: Mr. President. Mr. President. The, the Mayor has his ah, meeting this week ah, tomorrow, Wednesday night....

PRESIDENT SCHULMAN: You want to comment on that? And...

MEMBER CASAR: ... and we have to ah, set some guidelines before we establish or have another meeting or where it's gonna be and ah, we're not gonna have.. ah, ah, at least I think this is Council's position, we, we wanna have a guideline and agenda that could be followed and not just a helter-skelter type meeting.

PRESIDENT SCHULMAN: I think that's a very good idea. I agree. Ah, Mayor Healy.

MAYOR HEALY: Thank you Mr. President. Ah, I just would like to ah, remind the, the members, as well as the citizens that we have our first Mayor's Night, which is this Wednesday. It starts at 5:30 to 7:30. Anybody that comes in there at that time, will have an opportunity to sit down directly and speak with me and/or any of my Administration that you might have questions for as long as you're here by 7:30, we'll stay as long as we have to, to make sure that we speak to everybody. We'll do our best, unless there's 10,000 of you here, then we'll have to talk (CHUCKLE) but, ah, it's an opportunity ah, for people to, to, get a chance, to, to meet me without an appointment. You show up and we'll do what we can to address your concerns. If you have ideas, bring them to us. We wanna make sure that we're working for the people and that's what this is about. We'll do this every month from now on.

PRESIDENT SCHULMAN: Yes. Mayor Healy.

MAYOR HEALY: Also, thank you Mr. President. I also would like to, to just say thank you to the Council, to everybody in Council, particularly to ah, Member Hawk, Finance Chair and Member Casar, Majority Leader, all the members on the Finance and Personnel Committee who's, who's met with me off and on for the past many weeks. Ah, we had a very complicated ah, ah, Ordinance, on the personnel and I appreciate

you guys working with me and ah, and supporting that, and ah, again, showing that we can work together and put together a ah, an Ordinance that's gonna allow our, our Cabinet and our Administration to step in and ah, do what we, we promised the citizens we were gonna do. And, and, I also would like to make sure that others that were involved in the process, the Law Director extensively and Linda, ah, I know we wore you out on this one. Thank you so much for, for everything you did. Ah, you kept us sane and ah, on track and everybody was involved so, thank you all and ah, we're ready to move forward.

PRESIDENT SCHULMAN: And one other point Mayor, I think we have a new Economic Development ah, person.

MEMBER HEALY: We do. Ah, the last member of our Cabinet ah, starts today, Robert Torres. Stand up if you would. (APPLAUSE) He's the... Director... he's the Director of Development and that was a key area that we, that we talked about our needs for the city. Ah, we now have all our members in place and we're ready to move forward and start making a difference to create jobs and grow our community. Thank you very much.

PRESIDENT SCHULMAN: Thank you Mayor. Member Casar.

MEMBER CASAR: Mr. President. I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: Roll call vote, please Madame Clerk..

NO REMARKS ROLL CALL: 12 YEAS, 0 NAYS

CLERK TIMBERLAKE: Twelve yeas, Mr. President.

PRESIDENT SCHULMAN: Thank you Madame Clerk. (Gavel falls) The meeting is adjourned.
