Um, you know, we all have cars, we're all trying to get jobs, we're all trying to pay our bills and we can't seem to do that if we have to worry about our cars. Now, there are potholes, some that are enormously huge, some that are... shouldn't even happen. I drive to North Canton, I don't see that problem. You drive to Jackson, you don't see that problem, but you come to the City of Canton where we pay taxes and it's a big problem and something needs to be done, and I'm also addressing this to you as well Mr. Mayor, because this needs to be fixed. I don't know about the rest of the citizens in this community, but I am coming forward about this and this needs to be put on the agenda and be considered an emergency. Thank you.

PRESIDENT SCHULMAN: Thank you very much Ms. Lopez. (APPLAUSE)

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: We're now under Miscellaneous Business. Is there any Miscellaneous Business? Service Director Bernabei.

SERVICE DIRECTOR BERNABEI: Mr. President, Members of Council, Ms. Lopez. In response to that ah, I could tell you that it is a serious problem for all of us and the Street Department has approximately 40 employees. We've had a very difficult winter and that's an issue that we've discussed before with City Council about the plowing of streets and the amount of salt that we use each year. I can assure you that during the winter time and during the spring months, there are only 2 functions that that department performs and the first is the plowing of the streets and the salting of streets and that's primarily, you know, during the months of December, January and February and during the month of March and even prior to this in February on, on dry days. The only other function that they perform is the filling of potholes and I know that it's difficult for everyone to believe that they are working on this stuff steadfastly because there are so many potholes in the City of Canton, but I receive daily, because I've asked the Street Superintendent to do so, and I'll be glad to provide copies of those reports to you and to all Members of Council as to what they do on a daily basis and how many potholes they fill. I mean, I know that I received an email report on that

today, and I think that they probably fill something like 3 or 4 or 500 potholes a day, I don't know exactly how they keep count on this, but, I mean, our difficulties are that there are literally, as you have pointed out, thousands of them and some very large ones. As you will notice, and I noticed over the weekend, I drove across Route 62, there was very large one and then the next day I went by and I saw that somebody had put a cone out by it and marked it. Presumably, that marking was done so that of course, people would know that it was there at the edge of the roadway, but that they would come back and fill it. Um, I received reports, we attempt to fill the larger ones and the most traveled highways as much as possible, but this is something that has their priority and again, I can only assure you that that is the only function that they are performing this time of year, when they are not plowing snow and so forth. Um, I don't know whether our road paving program can do a, you know, we, again, it's a subject we discussed tonight in City Council committee meetings, ah, we will begin the annual road paving program. Our ability to pave roads, which of course, directly impacts upon potholes and their creation in the future is limited by funding by some extent. I think we have a \$4 million plus road paving program that was proposed over the next 4 years. approximately \$1 million a year. Um, once upon a time, a million dollars payed a lot of streets, for those of you who can remember and Member Kraus was a member of the Street Department for many many years. With the cost of petroleum products, the cost of asphalt as it sky-rocketed so you, you're able to asphalt fewer and fewer streets every year for the same amount of dollars. Um, the City is committed, Council is committed to putting money to these projects. We're committed to filling potholes. I recognize that it's a continuing problem and we will continue to work on it but, they are working on it. Thank you.

PRESIDENT SCHULMAN: Thank you Director Bernabei. Member Carbenia.

MEMBER CARBENIA: Yes. Mr. President. I'd like to ah, personally thank the Street Department for the job that they had been doing. Ah, last week, I had them do Maple Avenue and Harrisburg Avenues for one of the times I had them called out, they came out and they done those that was in their regular ah, 6 or 700 patches that they said that they had to do and ah, anyway, I had to call them again because they were all out. Some of this is the type of black-top that we have to use, but I know that that department is doing a great job in Ward 9. I realize ah, ah, you have to find them holes, but a lot of ah, the members go out and ah, ah, I know the Council people turn them in, but we're hoping that other city workers, when they go them, turn them in and we can get those, but ah, I think they been doin' a good job. It's just this weather is ah, lousy around here and possibly it is part of the program on how it's been put down the last few years.

PRESIDENT SCHULMAN: Thank you Member Carbenia. Member West.

MEMBER WEST: Mr. President. I'd like to recognize Steven Slesnick, our new State Representative. Would you please stand and be recognized? (APPLAUSE)

MEMBER GRIFFIN: Mr. President.

PRESIDENT SCHULMAN: Does Steve have no opponent? Oh yes, okay. I was gonna say, we wouldn't have to have your fundraiser. Congratulations! We wish you the very best as you know, and Member West, I wanna compliment you as I did, Member Cirelli, you ran an outstanding race and ah, you have nothing to be ashamed of yourself. (APPLAUSE) Good job.

MEMBER CIRELLI: Mr. President.

PRESIDENT SCHULMAN: Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. I have a question to the Mayor. Ah, Mayor Healy, in your State of the City address, you stated that we're going to put 20 new cops on the street, that would come out \$1.2 million, is that going to be in your budget that we haven't received yet or where is the monies going to come from, what have you? Can you clue us in on that?

PRESIDENT SCHULMAN: Mayor.

MAYOR HEALY: Ah, Mr. President. Thank you Councilmember Cirelli. Yes, the ah, the, numbers for that, it's, it's not coming out of the General Fund as far as additional dollars. We have ah, retiring members, that are ah leaving at \$80 and \$90 thousand a year incomes that we're going to be replacing with new, new, new officers and that allows you to bring on more. Ah, we also have um, ah, yeah, we have ah, also, um, the first, the first round of new hires is basically covered by the existing um, police officers who have retired. Um, we've had several people because of the DROP program announce their retirement, have already left and many more are leaving ah, before the first half of this year. The first 10 that we're hiring basically are using the funds from the exiting patrol officers. Ah, the second round, the second 10 that we're able to use with ah, a program that allows us to spend for first year of hires of new police officers, are forfeiture funds and so we're gonna use forfeiture funds to pay for the first year. Those officers then, when they go into their second year, ah, we'll be replacing retiring officers next year so they'll feed right back into the General Fund at that point so it allows us to go ahead and bring on 20 this year. Thank you.

PRESIDENT SCHULMAN: Thank you Mayor. Member Cirelli.

MEMBER CIRELLI: Thank you ah, Mayor Healy. Another thing you mentioned that was kindda, took me by surprise is you talked about the cameras you were going to put up. How's that going to be funded, sir?

MAYOR HEALY: Yes, thank you for asking. We're looking at a pilot program and ah, we're still ah, talking to the different companies that are out there and there's ah, some programs that allow us to do it for zero cost ah, but we might not take that program as we evaluate it further, we may want to ah, to have more ownership of them so we'll evaluate it to determine what the best method of moving forward is, and, and, Council will be included in those conversations. Thank you.

MEMBER CIRELLI: Thank you.

PRESIDENT SCHULMAN: Mayor, I know Mary, ah, Member Cirelli, has an interest in that as we all do. We had a presentation last year and there was considerable concern. Not only about the program itself but, the, the way the money was split with the private group that ah, was hired. Ah, Member Griffin, you wanted to say something?

MEMBER GRIFFIN: I just wanted to mention, I, coming in tonight, I saw ah, a crew putting up, fixing potholes. So, they're out there tonight fixing potholes Ms. Lopez. That's all.

PRESIDENT SCHULMAN: Do you want to say anything about St. Patrick's Day? (LAUGHTER)

MEMBER GRIFFIN: Ah, may we be in heaven 20 minutes before the Devil knows you're dead. (LAUGHTER)

PRESIDENT SCHULMAN: Thank you.

MEMBER KRAUS: Mr. President.

PRESIDENT SCHULMAN: Member Kraus.

MEMBER KRAUS: I, I, wanted to just also thank the Street Department. At one time, that department ran with 100 people. Their functions have stayed the same and if not, gotten larger. Their numbers have gotten smaller. They sweep the streets, they pave, they do patching, they do everything on the streets, but remember this, they're still making cold mix which means that even when they fill 'em, every time it rains or snows, it's going to pop out until they start makin' hot mix. Be a little patient with the guys, they just put the plows away, the hole's poppin' out. Just be a little careful when you're drivin'. Thank you.

PRESIDENT SCHULMAN: And I think in, in, (CHUCKLE) Ms. Lopez might feel like everyone is coming down on her but I think, for the average citizen, it is really hard to know how much work is being done when you hit the pothole. Ah, that's a pothole that shouldda been fixed, so, I, I think that we're not tryin' to respond ah, ah, in a disrespectful fashion, I hope you understand, but the Street Department does do yeoman service for the city and tries to do the best it can under very difficult circumstances and, you know, it gets back again to what I keep saying to you, we just cannot spend billions and billions and billions of dollars overseas and starve our urban areas and expect things like, just the simple things like putting, you know, filling in a pothole to occur. So, with that, Member Casar.

MEMBER CASAR: Mr. President. I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: It's been moved and seconded to adjourn, ah...Madame Clerk, roll call vote please.

NO REMARKS ROLL CALL: 12 YEAS, 0 NAYS

CLERK TIMBERLAKE: Twelve yeas, Mr. President.

PRESIDENT SCHULMAN: Meeting is adjourned. Thank you and Happy Birthday again Alice. (Gavel

falls)
