PRESIDENT PRO TEM CARBENIA: Ordinance 15 is ah....passed...ah....adopted.

PRESIDENT PRO TEM CARBENIA: Ah....Announcement of Committee Meetings and ah...we're going to move the Committee Meetings to 5:45 please.

MEMBER PRATER: Mr. President.

PRESIDENT PRO TEM CARBENIA: Mr. Prater.

MEMBER PRATER: Personnel Committee and Annexation Committee will meet April 21st at 5:45.

PRESIDENT PRO TEM CARBENIA: Thank you.

MEMBER GRIFFIN: Mr. President.

PRESIDENT PRO TEM CARBENIA: Member Griffin.

MEMBER GRIFFIN: Environmental & Public Utilities will meet at 5:45...ah...on the 21st.

PRESIDENT PRO TEM CARBENIA: Um..Community & Economic Development Committee will meet at 5:45 on 9/21...or 4/21. Judiciary. Some body call Judiciary. Mary.

CLERK TIMBERLAKE: Member Cirelli.

MEMBER CIRELLI: Ah....Mr. Chairman....(Inaudible)

PRESIDENT PRO TEM CARBENIA: 5:45. Thank you, that's Judiciary. Okay...um....let's see, public speaks, announcements, committees, that's all.

CLERK TIMBERLAKE: Yep...yep, we're okay.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT PRO TEM CARBENIA: Okay, we're up to Public Speaks. We are now under Public Speaks and we have....ah...four people have signed up. First is....ah...Christine Peterson, if you would come forward to the mic and um...give your name and address please. And ah....as...as Allen usually says, "you have three minutes."

CHRISTINE PETERSON: My name is Christine Peterson, my address is 1319 - 14th St NE in Canton. And Mr. President, Mayor Healy, Administration and Council Members, I want to thank you for this opportunity to speak. Um...I would like to introduce myself first and foremost as a resident and a homeowner in the City of Canton for seven years. Secondly, I am the chairperson for G.A.I.N., Gibbs Area Involved Neighbors Association. And G.A.I.N. is the new kid on the block. I want to thank Marilyn Thomas Jones, Stark Community Foundation, the City of Canton, Chase Bank and the Repository for their support of this Association. My reasons for speaking are first to commend the numerous Associations for the work they have accomplished in their community. Second, to commend Council and Administration for addressing the many concerns and issues that have come before them for the betterment of our neighborhoods and our City as a whole. And thirdly, and I feel the most important, I am looking forward to the opportunity to work with each of these entities in building Gibbs Areas Involved Neighbors to be an involved, positive and productive neighborhood. But most important, is that it will be a safe neighborhood, where families will want to live and feel safe allowing their children to play in their yards and to sit on the furniture in the home above window lines. As you can see, there are numerous concerns to address with crime and safety being the first to discuss. In neighborhood meeting, with Councilman Thomas West, Safety Director Thomas Nesbitt, representatives from the Gang Task Force and a representative from the Crime Prevention Specialist Office has been scheduled. Residents from G.A.I.N. area will be invited and encouraged to attend. I have hope and a vision that in the end, our joined efforts to achieve reasonable and mutual goals and solutions and to build off of these solutions will benefit our neighborhood, our community and our City as a whole. Thank you for your attention and this opportunity to serve G.A.I.N. and Canton, Ohio.

(APPLAUSE)

PRESIDENT PRO TEM CARBENIA: Thank you. Next we have...um...Diane...ah...Wissuchek. If you could step forward please, I probably chopped your name up but...uh...give your name and address please and you have three minutes.

DIANE WISSUCHEK: Thank Mr. President, I am Diane Wissuchek and I live at 2029 Franklin Place NW in the Mount Vernon Neighborhood and I am a member of Neighborhood Leadership Council. Mr. President, Mayor Healy, Mr. Service Director, Councilmembers, I am addressing the proposed increase in the ch...charge for Canton City refuge pickup. Currently, every resident of the City of Canton is required to use the City utility services, which include water, sewage and refuge pick-up. We have no options. If we want water and sewage, we also paid for the pickup. The charge for water and sewage is based on usage but what we pay for refuge pickup is a flat rate. No matter how much or how little is placed at the curb. As a retired single person a diminishing income, I do everything I can to control my spending to keep

within my budget I limited how much electricity and natural gas I use by setting the thermostat at a controlled level and turning off lights and appliances when not necessary. I limit my driving to reduce the cost of gasoline. I limit my shopping to more...to more necessary things. I even watch the amount of water I use in and around the house to control that bill but there seems to be nothing that I can do to control or reduce the cost of my refuge pick-up. As many of you are, I have been recycling for many years and have been doing this at a cost to myself. At this point, especially to during the fall, winter and spring I reduced the amount of pick-up at the curb to one small bag, I estimate to be about eight to ten gallons in size per week. During the growing season, sometimes there is more due to yard waste, so I could recycle more but again, it would require an additional cost to me to buy a composter or haul the yard waste away. I know the City is on the verge of starting Recycling and this is good and it will help in..with the need in transporting some of the recyclables to other locations. But I also know the cost for the refuge pickup, not only includes the cost of labor in transportation around the City but the cost of transporting to and dumping at the landfill. So some people who have reduced their garbage footprint, putting out little trash, are still subsidizing those who have not, or who generate much

more garbage because their household contains many more persons. We have talked about this in the past and I have been told that it would be difficult to charge other than a flat rate for refuge pickup. But with the amount of the proposed rate increase, I am asking again for you to think outside the box and see if you can't find a way to make the fee for this service more equitable to the service actually being used.

PRESIDENT PRO TEM CARBENIA: Ma'am.

DIANE WISSUCHEK: It is....

PRESIDENT PRO TEM CARBENIA: Ma'am.

DIANE WISSUCHEK: Yes.

PRESIDENT PRO TEM CARBENIA: If you could go ahead and bring your remarks to an end if you could, the three minutes are up.

DIANE WISSUCHEK: Okay, I will just say basically, I think that...that other Cities have done this and..and come up with other solutions and I would like to have some suggestions. I have some suggestions here if you would like to hear them but there...that I think we should be able to do this to help the people in the City and make the people who use a lot more responsible for what their doing.

PRESIDENT PRO TEM CARBENIA: If you would ah...I'm the..the Safety Director would speak to you after the meeting with all your suggestions, he's the...the man that takes care of Sanitation for us.

DIANE WISSUCHEK: Alright.

PRESIDENT PRO TEM CARBENIA: Thank you .

DIANE WISSUCHEK: Thank you.

(APPLAUSE)

PRESIDENT PRO TEM CARBENIA: Okay, the next speaker is Veronica Callahan. Would you step foward please, give your name and address and you have three minutes starting now...run....(Laughter) Thank

you.

VERONICA CALLAHAN: Thank you. My name is Veronica Callahan, I reside at 3406 - 34th St NE in the City of Canton. And good evening Mr. Carbenia, I ain't gonna call you Council President, and Mayor Healy and all the um...Councilmen and all the...the Service p....ah...people that are here. I am Veronica Callahan like I stated and many of you are no stranger. I'm really...um...pleased to say that I'm...um...standing today as the President of N.A.V.E. Um...and if all of our N.A.V.E. representatives would please stand up real guick, I know we did this before but...and stay standing up with me. We're just here tonight to encourage you guys..um...as our Councilpeople, as our um...City representatives...Oh Butch hold it up. (Laughter) (Applause) We're not here to...um..bring any bad flavor to the table or aroma but what we are here to say is, I think we all agree on the problems, the gangs, the drugs, the violence. We know that there's multiple homicides being committed in the City and I'm glad to see...um...even Chief McKimm here, who works a lot with a lot of our organizations. We're here to support you. We hope that we don't want until just once or twice a year to see you guys out. We are happy to say we're going to be hosting our event in October again at the Civic Center. We have been approved for those dollars. There's gonna be some twists and some turns to it, it's not just about candidates and issues but it's about neighborhoods and our families. We encourage you guys to come out this summer. Many of us are going to have block parties and beautification parties. We're going to be doing things all in our neighborhoods. Please, come out and join in with us, don't just, you know, commend us for what we're doing. We're here to work with you. Um...another thing that we would like to say is...um...um...thank you to Marilyn Thomas Jones and...um...the Stark Community Foundation (Applause) because without them, we wouldn't be here and to just...just seriously consider...um...I appreciate that sign and I miss City Council for our numerous...ah...ah...personal reasons. But the year of our neighborhoods....guys it's getting worse out here and don't wait until it knocks on your door, it's knocking on all of our doors...um...again, I'm not going to badger you with lists because you guys read the papers and your aware of it. But can we please look at enforcing the curfew laws, the children are younger and younger that are committing these crimes. These homicides, they're not going to go away unless we start getting these kids off the streets, so please, not just come to our monthly meetings, knock on my door, knock on some of these doors, sit on the porch and see what's really happening in the communities cause it is in pretty bad shape. But we do appreciate your support and we're here to help you and thank you.

(APPLAUSE)

PRESIDENT PRO TEM CARBENIA: Thank you. Last...ah...Sharon Skelly, if you could come forward please and give your name address and you have three minutes.

SHARON SKELLY: Good evening, my name is Sharon Skelly, I'm with North Lehman Neighborhood Association, I'm also the secretary of the N.A.V.E. Committee and I'm on Neighborhood Leadership Council. Um...I want to tell you a pleasant good evening. Um...it's good to see you. Um...always good to be here. My address is 1010 -16th St NW...um...and that's what I want to talk about. I have a question for you, what happens when you have a dead elephant in your living room? A dead elephant....it rots because...you...you it's kinda hard to move one of those. Um...we've got that in the North Lehman Area, it's called, Lehman High School...um...the situation there is getting worse and worse and it's systematically becoming a venue for vandalism and other crimes. This is sad, it's a beautiful historic building, it's got a lot of nice features to it....Um...there's so many things we could use it for...for everything like afternoon...after school programs cause we've got an awful lot of latchkey kids in our neighborhood and they need something to do to keep them out of trouble. We also could...um...we have activities for senior citizens, there's so many things we could do with that building and...I mean, the

possibilities are endless. Ah...we'd like to see some things done about that because it's just getting worse and if we don't do something soon, it's going to deteriorate so badly...um...it....it wouldn't be...we won't be able to fix it if we don't do something now. And that's pretty much what I have to say today. Thank you so much.

(APPLAUSE)

PRESIDENT PRO TEM CARBENIA: Thank you. Thank all of you for coming tonight and especially the four that ah...that thought enough to come up and speak and let us know their mind. And...ah...everybody, there'll be....Council will be milling around after the meeting is over tonight.

MISCELLANEOUS BUSINESS

PRESIDENT PRO TEM CARBENIA: We're...now we're under...ah... miscellaneous business. Do we have any miscellaneous business?

MEMBER CIRELLI: Mr. President.

PRESIDENT PRO TEM CARBENIA: Mary.

MEMBER CIRELLI: Thank you Mr. President. Uh...this question I guess would probably go to...ah...Mr. Bernabei, the Service Director. I had a call last week and fortunately I was in my car when I got the call and someone asked me to go out and watch how they were putting...filling the chuck holes...ah...and this was on Wertz Avenue, close by the fairgrounds and there was two trucks and then I saw another crew further so I observed what they were doing, because of what the person had told me. And they were filling the chuck holes and...uh...they didn't do any stamping or rolling. And so after they filled the chuck holes and they pulled away and as I sat and I watched the next car that came, and it was raining, it started to rain. They went shoosh and it came out. And so the question they were asking me, is it possible that they can stamp after they put that, you know cold patch in or possibly roll it to give it some kind of..ah...a grip in there instead of just filling the chuck holes and then going away. And they even suggested possibly could they put horses up and let it kinda maybe dry and you know, what have you. So I don't know, I've never filled the chuck holes, I've just observed.

SERVICE DIRECTOR BERNABEI: Mr. President.

PRESIDENT PRO TEM CARBENIA: Mr. Director Bernabei.

SERVICE DIRECTOR BERNABEI: Could I refer the ah...answer to this question to ah...Assistant ah...Public Service Director Kraus.

(LAUGHTER)

PRESIDENT PRO TEM CARBENIA: Yes you can. Mr. Kraus, tell him we can....we can answer that can't we Butch.

MEMBER KRAUS: Thank you Director. Mary, it...you can tamp it with a shovel or a tamper but it's temporary. There's not enough heat adhesion or...or a emulsion put down to hold that. That's why it only lasts till the first rain or the first snow. Once they start using hot mix, they'll put an emulsion down then put it in and tamp them and roll them. It...I mean you could ask them to tamp it but to be honest with you, the cars are

rolling it a whole lot better than a tamper would do on cold mix. And they'll probably start making hot mix this week.

- MEMBER CIRELLI: Thank you Mr. President and thank you Member Kraus, so I can at least pass onto the people what...ah...the reason why they don't do it. Thank you.
- PRESIDENT PRO TEM CARBENIA: Okay, and just a little piggyback on that..that the reason that they can't do that is because it's cold mix...ah..ah I mean even though it looks like it's hot mix, it's just...it's not going to stay in them holes...ah..if you...if you walk on it three hours later, you're....you're foots going to go down in it, so, that's just the way it is and we can't get them to give us any hot mix until a certain day that they decide that it's going to be above 40 all the time which, we seen the bottom fell out again, so, just ah...ah..piggyback on that. Any other miscellaneous? If not, I'll entertain...oh...Mayor.
- MAYOR HEALY: Yes, thank you Mr. President. Ah...first of all, I'd like to thank...ah...the N.A.V.E. organization and all the members that are here...Ah...obviously, ah...we've seen a significant ah...improvement because of the presence of the neighborhood associations...and...and we applaud everything that you're doing and everything that you've done so far. I...I appreciate that. Ah...I just wanted to also....ah...let you know, we're doing what we can to get to the neighborhood meetings, or sending representatives there. Ah...we're trying...we don't have notice from everybody, every organization of when your meetings are. So if you have a way to get that information...ah...to the Administration...ah...we'll have a better change of making sure...ah...we can attend those meetings. Ah...and also if you haven't attended...ah...we are doing once a month, a Mayor's Night...um...the next Mayor's night is April 30th, it's going to be here in the Council Chambers and...ah...it's ...it's an opportunity for..for everyone to come in and...ah...meet directly with myself or my administration, depending on what your issue is. The Police Chief...ah...Fire Chief, others attend. So, whatever your issue..ah..we can hook you up directly with that Department or person that's responsible to...to...address it. Uh...but it's a great opportunity for to...for you to bring your ideas ah...and thoughts to the...to the administration as well. So, I welcome all of you and..ah..it just gives us an opportunity to...to...mention when the next one is. Um....there was a comment also in reference to the Lehman School and uh....and I can tell you that...ah..we have met with the Superintendent um...and addressed that issue, our development team and Robert Torres, whose sitting here with us, the Director of Development, ah...is working on some issues as well on...ah...potential options...ah..for us to address that school and to...to help that neighborhood. Ah...so..ah...we are working on it and...and your...your words are not falling on deaf ears. We're...we're trying to do something for ya and..and help that neighborhood as well. Ah...so if you have any other particular issues like that, feel free to bring them to us anytime but...but the Mayor's Night is a good time to bring those specific issues to us and...and let us...ah...get the information so we can get back to ya. Again, thank you all for coming and...ah....keep doing what you're doing. Ah...the City needs it. Thank you.
- PRESIDENT PRO TEM CARBENIA: Um...we have...ah...special privilege...ah...Cindy Timberlake, our Clerk of Council, would like to mention something to you.
- CLERK TIMBERLAKE: I would just like to announce to everybody, tonight is Beverly Bevington's last Council Meeting and I know she didn't want a fuss but I would like to take this opportunity to thank Bev for her thirty some years of service and...um...I wish I was only fortunate enough to be you Bev, at this position...at this point but...ah...I thank you very much for all your hard work you've done in the Council Office and I know all the Councilmembers appreciate all the work that you've done for us. Bev's last day will be April 28th and...ah...we are sorely going to miss you Beverly and good luck in your retirement.

(APPLAUSE)

CLERK TIMBERLAKE: Do you want to say something?

PRESIDENT PRO TEM CARBENIA: Oh, wait a minute, you didn't get permission to talk. (Laughter)

CLERK TIMBERLAKE: Tell him you don't care.

PRESIDENT PRO TEM CARBENIA: Yeah, try to stop a lady from talking.

BEVERLY BEVINGTON: Mr. President.

PRESIDENT PRO TEM CARBENIA: Please Bev.

BEVERLY BEVINGTON: Thank you...ah...very much for giving me the privilege of working for Canton City Council. I'll tell ya, Canton has one of the best Councils that probably anywhere in the Country. They're a very hard working group of people, they have the best interest of Canton...each and everyone of them have the best interest of Canton at heart. Believe me, they...they work us to death. Just in their best interests and...ah...thank you very, very much for accepting me. Thank you for giving me the opportunity. It was a pleasure, an honor and I'm gonna have fun now. Thank you.

(STANDING OVATION)

PRESIDENT PRO TEM CARBENIA: Thank Bev for that paid advertisement. (Laughter) Ah...any other miscellaneous business? If not, I will entertain a motion to adjourn.

MEMBER CIRELLI: Mr. President. I move we adjourn.

MEMBER HAWK: Seconded.

PRESIDENT PRO TEM CARBENIA: It's been moved and seconded to adjourn. It's not debatable. Roll call vote please.

NO REMARKS ROLL CALL: 8 YEAS, 0 NAYS

CLERK TIMBERLAKE: Eight yeas, Mr. President.

PRESIDENT PRO TEM CARBENIA: (Gavel falls) Dismissed.
