MEMBER HAWK: Mr. President.

PRESIDENT PRO TEM CASAR: Member Hawk.

MEMBER HAWK: Finance Committee will meet May 12<sup>th</sup> at 6:45.

PRESIDENT PRO TEM CASAR: Member Cirelli, do you want to announce your Sidewalk Committee again?

MEMBER CIRELLI: Yes sir. Thank you Mr. President. ## PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT PRO TEM CASAR: We're now under Public Speaks, open forum. We have one speaker signed up to speak this evening. Elaine Irwin. Would you please give your name and address.

ELAINE IRWIN: Elaine Irwin, 4020 Faircrest Street, Canton....Canton, Ohio, Perry Township. I um...I know there are a couple left handed Councilmembers and so, I'm not picking on you but I'm using you as a illustration. Um..so your left handed, let's say for a moment that I've lost my right hand and I've decided to take yours to replace it. Not to worry, I'm going to tell you because you've got your whole body and your other hand to still use. So...ah....I'm going to pay you \$8,000.00 for your hand because that's what I think it's worth. And since I'll be performing services for the City Council and the City of Canton with my new right hand, I'll have their undivided support, after all, it would be for the greater good. And just think of the money the City Council would save by only paying me...giving you \$8,000.00 for your hand. Ah...at any rate, um...would you vote for that? Do you think that sounds fair to put a value on your hand, for me to put a value on your hand because I need it? Um...seriously, we need to think about how we treat other people and their property. Think long and hard about the decisions you make with raising of a hand, decisions that can destroy or change a life, a livelihood, a business. Victims of natural disasters accept that their lives were ruined by acts of God or the forces of nature. People do not accept that Government or City Council can inflict that same kind of damage on individuals who just want to live, work and pay taxes on their land. Thank you.

PRESIDENT PRO TEM CASAR: Thank you Madame Irwin.

## **MISCELLANEOUS BUSINESS**

PRESIDENT PRO TEM CASAR: We are now under Miscellaneous Business. Is there any miscellaneous business?

MEMBER CIRELLI: Mr. President.

PRESIDENT PRO TEM CASAR: Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Mr. President, this question goes to the Mayor...um...I've had...I've been besieged, as well as I think some other Councilmembers have been by an incident that happened over the weekend concerning the ballpark. Thurman Munson Ballpark, and the question, I was of the understanding that you of course appoint people and then we approve them.....(Inaudible..the microphone system was accidentally turned off)

MEMBER WEST: All of them are off....

PRESIDENT PRO TEM CASAR: I shut you off....I shut you off.

MAYOR HEALY: Are we on now? Okay and that's my answer. The ah...Recreation Department is a joint Recreation Department with the...ah... Canton City School and the City of Canton. The Mayor appoints three Members to the Board and the Superintendent appoints the other two. It's a five member board.

MEMBER CIRELLI: Okay...um... Mr. President, thank you Mayor and how about the Park Board? Can you tell me exactly the scenario there sir?

MAYOR HEALY: Mr. President.

PRESIDENT PRO TEM CASAR: Member Healy...I mean Mayor Healy.

MAYOR HEALY: Thank you, I got a demotion. The..ah...Park Board is made up of three Members, all three are appointed by the Mayor and the funding for the Park is...ah...is... through the City or City Council.

MEMBER CIRELLI: Ah... Mr. President, thank you Mayor ah ...Healy. Ah...what is the possibility, sir, of merging these two Boards and having just one Board? Do you ever see that in the future possibly happening...ah...and getting better control over what we're doing with these two boards sir?

PRESIDENT PRO TEM CASAR: Mayor.

MAYOR HEALY: Thank you. The...um...the...the logic of merging them makes a lot of sense. The...the complications however, are that the...the way that these Boards were created....ah...they were both created by votes of the people. Ah...the Parks..um...is...is through as Statutory Law that allows us to created the Board. There is no...ah...written Law currently that allows us to...um..to dissolve the current Park Board. So we would have to go to the Legislature and create a system. The Recreation Board...ah...again was created...ah...ah... by a vote of the people and...um...if we dissolve that Board or try to change that Board, we also dissolve the funding that goes with that because of the levy...ah... that was put past, so you...you risk losing those funds...ah...by changing that Board. So, it's...it's...um...going to be very difficult for us to just re-do the whole thing and join them together but...ah...there are other avenues that we can pursue.

MEMBER CIRELLI: Okay....excuse me Mr. President. Thank you Mayor Healy and uh...I'm sure you're aware of what the incident that I'm speaking about because I sent you emails and what have you. Ah...do you believe that you can find some resolve to assist the...the people out there with the teams that want to play and what have you and with porta potties at the fields and perhaps....um...reevaluate the monies that we're spending at...ah...one of the parks and maybe we could do it cheaper, putting toilets in one of the parks and give some consideration.

PRESIDENT PRO TEM CASAR: Mayor Healy.

MAYOR HEALY: Thank you. Um...yeah, we...we had a meeting today...ah..with the Park and the Recreation..ah...Directors...um...as well as some of the Board Members and...ah...we are putting together our...our...ah... plans to address those questions that were brought up...ah..so that we can avoid these problems in the future and I think we're...we're on the right path and we should be seeing some sort of resolve on this over the next thirty to sixty days as they meet with their Members.

MEMBER CIRELLI: Okay...Um...Mr. President. Thank you Mayor Healy for your answers, I appreciate

that.

PRESIDENT PRO TEM CASAR: Is there any other Miscellaneous Business?

MEMBER WEST: Mr. President.

MEMBER SMITH: Mr. President.

MEMBER WEST: Ladies first, by all means.

PRESIDENT PRO TEM CASAR: 4th Ward Councilperson, Smith.

MEMBER SMITH: Ah...yes, Mayor, ah...regarding the incident that happened on Saturday...ah...two things. Ah... you know, we had you down to throw out the first ball, although the weather, you know, did permit us to..um...a couple hours for some nice weather, did you...um...forget you was supposed to throw out the first ball? The little kids was waiting on you. Also...um...Malone College, they has precedence over anybody else that has paid the \$500.00 to rent the..ah...field?

PRESIDENT PRO TEM CASAR: Mayor.

MAYOR HEALY: Thank you. The um...the incident on the...ah.. weekend, obviously we had rain issues and...ah...and I was with my son...ah...at his soccer game, which was delayed because of the rain. Uh...and again because of the rain situation, soccer does play in the rain but baseball typically doesn't. Uh...when...uh..so...so that's where my delay was. But in reference to the first pitch, no I was not to throw out the first...ah...Senator Boccieri...uh...from what I understood, was throwing out the first pitch. Uh...so that was what was...ah...told to me. Um...and again, there maybe some confusion in that but that's where that was. But thank you for...for bringing that up. Third, in reference to the tarp...um...the Malone College put the tarp down to protect the field and ah...they were determining whether...ah...whether...when the rain stopped and the conditions changed, that it be appropriate to move the tarp. And...ah...again, because of the rain...ah..they decided that...ah...that was not the proper time to un...to unveil the tarp. And...ah...and therefore that didn't happen. Ah...again, I do not run the Recreation Department, we have a Director who does that. I do not fund the Recreation Department...uh...they have separate funding and there is a Board that oversees that. And so for you, or for the Little League or for anybody else out there that believes that I have control of this, they need to clearly understand that is an independent Board that handles this and their the ones who have to get the phone call when they want to make changes on what...what's happening out on those fields. Thank you.

MEMBER WEST: Mr. President.

MEMBER WEST: Ah...yes, ah...I just want to be very clear to this Council as well as to the community, that with the MLK, I was a sponsor along with...ah...several other people. But more so, I wanted the people that worked on this diligently over the last couple years, they're in the audience, some of them...um...please stand and...and be recognized because it truly was a community effort to pass that legislation for the ah....Martin Luther King Corridor. Would you please stand, all those who were in...involved in that process.
