PRESIDENT SCHULMAN: Member Griffin.

MEMBER GRIFFIN: You know, spring sports are different than your fall and winter sports where the teams are still associated. Poor coach is here without a team. (Laughter). But his kids are out there playing ball. But ah...so I'd like to present this to you coach and a copy for each one of the players. And I'll give you some statistics, you know, earned run average is very important in baseball and in 30 games.....34 games, their earned run average for the pitching staff was 236, another words, they gave up less than three runs an inning. And you know what happens to the Indians when they hit more than three runs a game, they loose. (Laughter) Okay, um...out of the 30 victories, there were only 2 saves, that tells you that they beat the crap out of them. Um...also, I wanted...oh yeah, on base percentage, 495 %, so their kids were on base almost half the time. Slugging percentage, 508 and ah...they're...they're just fantastic record this year. So, I'd like to thank...ah...Coach Miller. And another thing, they keep these kids around, you know, when I used to umpire, I'd say how many kids are on...seniors are on the team? "Two, three." What eight? They had eight guys, and that's...that's standard for them, so...ah...aye, good luck. Oh...and one other thing, hey Doug is a standard walker in our neighborhood and I always say, "Hey Doug, trash bags in the garage." He doesn't come past my house anymore, (Member Griffin hands Doug Miller a trash bag) (Laughter) So Dougy, down around Fawcett and Roslyn and...and you know, you know...okay....

PRESIDENT SCHULMAN: Coach, congratulations and we'd love to hear ah...if you have any remarks.

COACH DOUG MILLER: Well, thank you very much, it's an honor to receive...ah...this honor from City Council. The name of our school in the O.H.S.A. Directory is Canton Central Catholic High School, so...um...we're very proud to bring it back to Canton and to Stark County. And...ah...we appreciate everything...ah..I was raised in Canton on Roslyn Ave and I still live in Canton on Poplar Ave, about seven houses down from Councilman Griffin and that's true, I do walk the neighborhood and he says he has a trash bag all the time. we're going to be asked to pass this tonight, I....I'd like an answer to that too. I know it happened a few years ago with this whole thing.

PRESIDENT SCHULMAN: Well, for the benefit of the audience who is here, who may not have attended Caucus...ah...you want to explain what question you want the Law Director to answer?

MEMBER SMUCKLER: Can the City get back money when Abbott pays for this whole thing?

PRESIDENT SCHULMAN: Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Mr. President, Members..ah...Smuckler and Cirelli, I will find out. Please understand that um....corporation is not the same as personal assets, I believe you'll understand that. Um...the question is, can the receiver redirect some of the monies that are paid in rent for the property when it's...ah...leased and then ultimately purchased, back to the City. If we have a way to claim those funds, we'll pursue it. Um..I'll have that answer for you and ah....email it to both of you as soon as we get that.

MEMBER SMUCKLER: I understand about Corporations, I've got one, my....my question is too, and I know we can reconsider this two weeks from now if we have a problem, but I would like to know by the time the next two weeks, whether this is possible to get back any of the money that was involved in this whole thing.

LAW DIRECTOR MARTUCCIO: I understand and I'll do that but I...I would urge you not to tie the two together. Uh...this provides a remarkably, I think...ah...efficient and...and...um...fiscally prudent way to clean up what will become a major problem if it's not remediated as soon as possible. I think Mr. Connect did a very good job of explaining all the monies and all the funds that have come together...ah....to make this remediation possible. And the plume is spreading underground as we speak. Um...I will get the answer, but I would respectfully urge not tying the two together.

MEMBER SMUCKLER: Thank you.

PRESIDENT SCHULMAN: Thank you Member Smuckler. Member Cirelli, does that answer your inquiry?

MEMBER CIRELLI: Ah...yes sir and...and I want to thank Member Smuckler for asking that question because that's why I had grabbed the microphone also. Um...I will support this with the idea in mind that I'm...my understanding that the neighbors are having problems there and could potentially be...there's a lot of hazards out there. But I really think in all...whenever I hear that we're going to use in Capital Improvement monies and what have you, I think we need to see if it's possible that we can receive some of the monies back from the receivership after he sells the property to the Abbott Company.

PRESIDENT SCHULMAN: Well to comment on what the Law Director has said, if anybody has read the book or seen the movie "A Civil Action" I think you know how difficult it is to recover money when companies long ago were recklessly and intentionally polluting our soils and our Cities. So, I would have...I would concur with the Law Director here, I think it's very prudent that we move forward as quickly as possible. This could become a health...a public health emergency and if we get money fine, if we don't then we're just out the money. It's just the way things are. It's unfortunate, I can tell you I think our laws are changed today where no company would be allowed to do this without being punished including the individuals in the companies who perpetrated this kind of...ah... public health nuisance. Member Carbenia.

MEMBER CARBENIA: If I may, I have a point of order. I asked...ah...Majority.....

PRESIDENT SCHULMAN: You want to withdraw your point of order?

MEMBER CARBENIA: Yes.

PRESIDENT SCHULMAN: Okay, any other remarks? Roll call vote please Madame Clerk.

PRESIDENT SCHULMAN: Member Hawk.

MEMBER HAWK: The Finance Committee will meet Monday, June 30th at 6:00 P.M.

PRESIDENT SCHULMAN: Thank you.

MEMBER DOUGHERTY: Mr. President.

PRESIDENT SCHULMAN: Member Dougherty.

MEMBER DOUGHERTY: Public Property Capital Improvement will also meet 6:00 P.M. on the 30th.

PRESIDENT SCHULMAN: Thank you. Any other committee meetings.

MEMBER SMITH: Ah...Public Safety and Thoroughfares.....

PRESIDENT SCHULMAN: Member Smith.

MEMBER SMITH: Oh, I'm sorry.

PRESIDENT SCHULMAN: That's alright.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: Alright, we're now under Public Speaks, Open Forum. We have two speakers signed up this evening. Both are...ah...friends and have been here before, so they know the ground rules. Our first....ah...speaker this evening is Ms. Brogdon. Good evening, welcome. If you can give us for the record, your name and your address please.

RUBY BROGDON: My name is Ruby Brogdon. I lives at 1617 3rd St. I'm tired of comin' up here being heard. But you're going to hear me until you clean up next door. I would love to come and be quiet and I'm going to tell you, I was quiet for awhile. I'm back and I'm gonna stay back until something is done next door to me. Now a storm done blowed one old tree over. The front is just a mess. Until this place is cleaned up next door to me, I'm gonna talk and if you don't want to hear me talk do something about it. Mr. Healy, I wants to know from you, when are you going to send someone down there to clean that mess up next door to me?

PRESIDENT SCHULMAN: Well, the Mayor will or may answer you either in Miscellaneous or unless there's a motion but....

RUBY BROGDON: Well, I'm gonna tell ya', I'm not only just interested in my neighborhood, I'm interested in all of them. I live in the City of Canton, I been here for a long time and I think we all should be interested in our community, don't care where we live, you can be poor but you can be clean. Now this house has been vacant next door to me and a mess for over three years and I'm tired of it. When I sit down in there, I was quiet for awhile but I said "If it was another thing, I will be back." And if you don't want to see me every Council meeting that you have, you clean it up and I will sit down and I won't be heard but I'm gonna be

heard until something is done. Thank you.

(APPLAUSE)

PRESIDENT SCHULMAN: Thank you. Ms. Brogdon, we love having you here whether you talk or not, it's a pleasure to have you here. And I'm sure the Mayor will respond to you ah....appropriately. Our next speaker is Patricia Kirk and thank you by the way. Ah...Patricia would you like to come up and give us your name and your residential address. And I know you're very familiar with our ground rules.

PATRICIA KIRK: Patricia Kirk, I live at 131-5th St. And I was going to talk about the Tree Ordinance tonight. But when I was walking across Kresge Park to get here, this tree limb, this was one of Mr. Kirk's tree limbs that he trimmed and it was ripped from the tree and left hanging like that. And you can't do anything about it because you don't have a Tree Ordinance. But...ah...what I was going to show you, these pictures were taken May 21, 2008 when he truned....pruned this tree. This tree was pruned so that the wind would blow through it and not cause damage as it got older and matured. It was not just pruned, it was thinned. Also, I want to tell you that...I want to tell you tomorrow night, 6:30, there's going to be a meeting at Church of the Savior of Shake a Leaf and we are going to have this video "Managing Trees for Public Safety." It's actually written for arborists and that's going to be on the Tree Commissi...or the Tree Ordinance when you consider it. Also you will see the term "International Society of Abarraculture" that is also put out this video. I spoke with Mr. Smuckler, he's going to watch it tonight because he can't make the meeting. I'm going to pick it up early tomorrow morning, if that's alright. And also, could I have a copies of the most...the latest draft of the Tree Ordinance because there will be people there at the meeting tomorrow night who are interested in it. Um...five years ago, I spoke with the supervisor of an agency about tree, city trees and she said it was a win, win situation but she said I would never get it through Council when she heard of the steps. That person is no longer here anymore. She was a supervisor, she worked here. I don't know why she left, I just know that when people get frustrated, whether it's in the neighborhood or as with a City thing, because this is not political, this is just a smart City thing to do, they get frustrated. They leave the neighborhood or they leave the City. But this is a very positive thing that people are eager to hear about. So, Mr. Smuckler, I will leave this tape with you. I will pick it up tomorrow morning and the meetings are public, it's tomorrow night at 6:30 at Church of the Savior. And July the 10th, I am planning on having another meeting there at Church of the Savior with a disc...or with a...it's been made by the Ohio Department of Natural Resources of Actual Trees in the City of Canton, you don't want to miss this. Okay, thank you very much.

(APPLAUSE)

PRESIDENT SCHULMAN: Thank you very much. And I know you're a tireless worker on this and I know sometimes people just think, oh that's kind of stupid. It really isn't. Everything you say is....ah...right on point and we do appreciate your hard work, believe me. And I think you'll be happy to hear some things that are occurring and we'll let the Law Director tell you. And that concludes our Public Speaks portion of the meeting.

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: We're now under Miscellaneous Business. Is there any miscellaneous business?

MEMBER SMITH: Mr. President.

PRESIDENT SCHULMAN: Member Smith.

MEMBER SMITH: Ah...first of all, on June the 3rd...ah...we had a meeting with CTCC...um...pertaining to Martin School and the residents of that area. I just wanted to let you know that CTCC will not be going into Martin School. And another correspondent on ah....Saturday the 21st, we will be hosting a 4th ward residents meeting, it's an informative meeting and that's going to be the 21st, Saturday at 2:00 at the Southeast Community Center.

PRESIDENT SCHULMAN: Thank you, Member Smith. Member West.

MEMBER WEST: Mr. President...um...first I want to also congratulate Chris because I know that she diligently...ah...tried to get a lot of people there and from what I understand, it was an outstanding turnout in the 4th ward. I was pretty excited to hear that. But also, uh...on Saturday, last Saturday, there was two..ah...events that happened in ward 2 that I think everyone should know about. Ah... S.N.E.T. II, which...ah...Multi Development Services and...ah...Jesus Speaks, the Church on McKinley and 12th...or 11th um...held an event. And they went through the neighborhood and, I don't know if you seen it in the paper but they went through the neighborhood and they cut the grass and some of the lots that were really, really bad...ah..and they even went as far as to chop up trees. Uh..they had people from Riverside Church come down and a number of people and they just combed that area and really did a great job. Uh...in so much that I told them that they might want to partner with the City to help get some of their lots taken care of. Uh...the second one was we had a group...um...an amish group called "The Next Door Missions" that came down in ward 2 and helped a couple families..ah...tear down a garage. Uh...they tore down a garage because the families could not get insurance on their house and I thought that was....um...an awesome event and that happened in ward 2. Um...and I thought that that was something that was...it was a major step within our ward where people did all of these things for free and all they needed was, you know some coordination, all they needed was a little bit of donations from other people...ah...to make that happen. And I think we can go a far way with just kind of partnering...ah...with outside neighbors as well as local neighbors to get things done in our community. Thank you.

(APPLAUSE)

PRESIDENT SCHULMAN: Thank you Member West. Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Mr. President, I'm not sure who I want to...who to direct this to but...um...several constituents called me and so I went and got my paper, it was Friday's entertainment of our local newspaper, it's called the "Canton" under Canton it shows a picture of "The Canton Concert Band Returns this Summer." However, when you read the dates and where they're playing at, no where are they ever playing here in the City of Canton. It's in North Canton...ah...Perry Park...ah...Jackson Township, Louisville, North Canton again but not at all in Canton. And they were kind of concerned and said "Why is it listed under Canton, however none of the functions are here in Canton?" So if somebody maybe from the Mayor's Administration could check this out, I will be glad to give it to him. Thank you.

PRESIDENT SCHULMAN: Okay, thank you Member Cirelli. Any other....ah....Miscellaneous remarks? Safety Director Nesbitt, my good friend.

SERVICE DIRECTOR NESBITT: Thank you Mr. President. Ah...first of all, I'd like to address Ms. Brogdon...ah...Ms. Brogdon and I have talked several times and...ah...appreciate very much your perseverance on this issue and as you know, we were successful in tearing down that garage that was leaning

against your fence and that property. And...ah...my goal is to tear that and clean that property up, as I've told you in the past. And I assured you that that will be done. It is very much an eyesore but..ah..we have several concerns on the block. As we walked down that block and saw all the boarded up houses on there, it's a shame that ah....that we are at that point in your neighborhood. And...ah...we need to do something about that and I understand that and I've been working with the Building Department and John Labriola and...ah...we will be addressing that and...ah...as I've told you in the past...ah...it does take some time. I...I know that it does get...ah...kind of frustrating that..that it takes so much time but...ah..we did pass some guidelines for our building people to tear down these....ah...residences. Ah...when I came in here there was not guidelines in place...ah...of how to do this, how to bid it out and stuff and we finally have got those in place now. So..ah...I think you'll see that...ah...we'll start tearing down these...ah...buildings, we have several of them to do in the next few months. So...ah...I want to assure you Miss Brogdon that...ah...we'll address that and...ah...and..and take care of that issue. The other thing I'd like to announce is that tomorrow...ah...from 6:00 to 8:00 P.M., ah...we're going to have a reception...ah with Mayor Healy and the Administration in honoring...ah..the ten police officers...ah...we'll have a reception and it's going to be held at the "Peel" Coleman Community Center and...ah...I would...ah....welcome everybody from the Council and in the community to come down and welcome these...ah..fine...ah...new recruits that we're going to have and put in uniform and...ah...ah...it's gonna be nice...ah...reception to welcome them into the community. I sure would like to have...ah...those of you here attend and please pass that word on. Thank you.

PRESIDENT SCHULMAN: Thank you Director. Mayor Healy.

MAYOR HEALY: Thank you Mr. President. Is this thing on?

PRESIDENT SCHULMAN: Yeah, you just gotta pull it closer.

MAYOR HEALY: I also...ah...would like to announce...ah...an upcoming Mayor's Night. Ah...we have Mayor's Night coming up next Wednesday the 25th, it's going to here in the Council Chambers. I appreciate all those who have come out...ah...in the past and all those members of the Administration...ah...that have been here participating with that. Ah...it's a great opportunity for anybody in the community to sit down and talk directly with the Mayor or any of the Directors...ah...to express your concerns or give us ideas and we certainly appreciate your participation. Thank you.

PRESIDENT SCHULMAN: Thank you Mayor.

MEMBER WEST: Mr....Mr. President, one more thing.

PRESIDENT SCHULMAN: Sure, Member West.

MEMBER WEST: Ah...I also wanted to thank the Safety Director, Tom Nesbitt for coming out to..um...ward 2 and more specifically...ah...Struble Ave. We were having a lot of problems down there with kids...ah...gangs type of kids. He came down there with two officers and what I thought was really unique was, when the two officers came down there, we walked around that neighborhood and all the kids came down and they were at the one guys house and they got to see who these two officers were and to see these officers as human beings, not as people riding in cars, handcuffing people. And I thought that was very positive, I want to thank him for his...ah...for coming down and...ah...doing some walking in our neighborhood. Thank you.

PRESIDENT SCHULMAN: Thank you Member West. I'd like to through out...ah..two accolades myself.

One to the Mayor, I told him privately tonight and for the public...ah...we have a Sustainability Commission and our Service Director, who does a unbelievably fine job, along with our Safety Director is a part of that Commission, as is...ah...Member Hawk. And I complimented the Mayor this evening, I think he put together a team of people that are incredibly rich in background and experiences and we will have some very dynamic programs and suggestions for Council in...ah...no less than 60 days. I think you'll be very...ah...satisfied with our Commission. And secondly, I'd like to commend...ah..the Service Director...ah...the Safety Director and I played golf against him yesterday and all I can tell you is ah....Leader Casar, he started number 10 with a birdy, he had...ah...11, he had a birdy and then he...ah...basically, this Service Director pared out, this is the...ah..second time in three days that I've played with somebody who just shot lights out and I lost a fortune. But I do want to congratulate him, he really played well. And um...apparently, he either is working too or he's not working at all. Okay. Thank you. Director Bernabei, did you have anything you wanted to add?

SERVICE DIRECTOR BERNABEI: On...on a serious note...ah... Mr. President, yes, I wanted to announce to City Council Members that not later than two weeks and hopefully even beginning next week, so that you are not taken by surprise by phone calls from Constituents that we will begin distributing the recycling bins in various neighborhoods. The..ah...determination as to what routes we will do first or the areas that we will distribute first is...is really going to be decided by the...ah...operating personnel in the Sanitation Department, so I cannot announce that at this time. But just to let you know that the blue recycling bins will be...ah...distribution of them will be initiated within the next one to two week period of time. Thank you.

PRESIDENT SCHULMAN: Thank you on that serious note. Member Casar.

MEMBER CASAR: Mr President. I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: It's been moved and seconded to adjourn. Roll call vote please Madame Clerk.

NO REMARKS ROLL CALL: 11 YEAS, 0 NAYS

CLERK TIMBERLAKE: Eleven yeas Mr. President. .

PRESIDENT SCHULMAN: (Gavel falls) The meeting is adjourned.
