I think that this...ah...something that's well overdue. Ah...we provide...ah...water and sewer for the citizens of Canton, that should be our number one priority. And if they are...if they are contiguous to the City of Canton...ah...they will either move or...ah...or be annexed within 90 days or we'll have the right, according to the Supreme Court...ah...to...ah...take away their...ah...privilege of using our water and our sewer and I...and I just feel that this is the way to go if we want to grow the City and we have to do it with our utilities and water, which we have an abundance of good quality water, we should use that as a tool to develop the City of Canton with something I been preaching for over 20 years and I'd like to see the direction we're going on this. Thank you.

PRESIDENT SCHULMAN: Thank you Member Casar. Any other remarks? Member Smuckler.

MEMBER SMUCKLER: Mr. President, we have been running water lines outside the City and the fruits might come to bare right now. Um...because it's now hard ball. You want to continue to get the water, it gives us the opportunity or the tool to either continue servicing water or to shut it down. And that's based on a recent Ohio Supreme Court ruling in 2006 and this gives us another opportunity to help grow our City.

PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: We're now under...ah...Public Speaks, Open Forum. Ah.... we have five speakers signed up this evening. Ah...for those of you...ah...who have never been here. I would just ask that you recognize and respect the Council's wishes that you keep your remarks to three minutes...ah...the reason we do that is because we're all going to be here after the meeting if you want to follow up with us. The Administration and Councilmembers and I will all be here to hear what you have to say. So if you'll..ah recognize that we would appreciate it. Our first speaker is...ah...Mr. Kelly. Good evening sir, if you'll step up Mr. Kelly...ah..and give us your name and your residential address please.

M. JAMES KELLY: My name is Mark James Kelly, I reside at 1529 Colonial Blvd N.E., Canton, Ohio 44714.

PRESIDENT SCHULMAN: Thank you and good evening.

M. JAMES KELLY: Good evening. I'm here to...ah...talk about the Taxicab Ordinances in the City of Canton. In the City of Canton there's three taxicab companies registered with the City of Canton licensed to pick up in the City of Canton. That would be...ah...my taxicab, A Taxicab of Canton, ah....Yellow Cab Leasing and Team Taxicab Company. Um...the problem here is, is there's all these other taxicab companies popping up and their in our phonebook and they're registered with...ah...phone number for here, for the City of Canton as in their registered with the City of Canton, their not registered. I put...two years ago I put everything I had into building a taxicab company to support my family, myself and so forth to make a living. Now I got...you got these people that...that are coming from Akron and so forth, they're coming down to the City of Canton, they're stealing trips, they cruise around...they, you know, they'll go and...ah...I...I don't know, they'll just pull up and they'll see somebody, "Oh you're my cab?" "Yeah, so and so cab company sent me out." They're not registering with the City of Canton, they're...they're not doing, you know, I have...I'm paying the City of Canton per cab per driver and so forth every year to abide by the rules. These companies are coming in, they're not abiding by the rules, they're not signing up with the City of Canton. There's no enforcement whatsoever. I have complained to Ms. Shirley Moore, the license inspector, City of Canton and I believe she's put out a memo or two to the Police Department...um...to no avail. These people are still coming down into Canton. I was told to...ah...call the Police Department, you know, when I them down here picking up illegally. Uh...if...if I call the City of Canton, they...they don't have a car available to come out, you know...and ...and it's, you know, you know, a major crime. I can understand that, you know, the police department has more things to do, you know, more important business than to chase taxicabs around the City of Canton. The problem is, with all these transportation companies and so forth that are popping up. Last year there was...there was...there was...ah...excuse me, ah...last year there was a ah...there's three, one, two, three, four...four cab comp....four cab companies in the phonebook. This year there's eleven. Three of them are registered with the City of Canton. Now, you make taxicab drivers and so forth go get fingerprinted, get a tax license, register the cabs, company registered, paid them money, pay taxes and so forth, okay. Now you got all these transportation companies, You Can Travel, Bubba's Travel, you know, they're all....ah...Diversified Transportation, Cosmo Transportation, there's all these transportation

companies that are popping up that are not regulated by the City of Canton that are hauling our kids around, our children. Now they might say "Well hey yeah, we do a background check and so forth." But I don't see the point of registering me to haul drunks around and people going to and from work when you got all these other companies coming in here that are hauling our kids around and we don't know who they are, we have no idea who they are. These taxicab companies are coming down here and just...ah...ah...a week or so ago over at the Towne Manor Motel, I caught one....a checkered cab over there. And they got telephone numbers with Canton exchanges, 45....456-4441, that's a Canton land line, that's not a cell phone. Here's another one, Checkered Cab in business, City of Canton since 2005, 456-4444.

PRESIDENT SCHULMAN: If I may interrupt, you've....you've extended your three minutes.... I appreciate it...

M. JAMES KELLY: Oh I apologize.

PRESIDENT SCHULMAN: But as I said, ah...and I appreciate your remarks and I think Council and certainly the Safety Director and the Law Director have heard you, we will be here after the meeting to discuss that with you but thank you very much Mr. Kelly.

M. JAMES KELLY: I appreciate it.

PRESIDENT SCHULMAN: You've raised some very good points. Our next speaker is, and again, I apologize if I can't read your...ah...writing but I believe it's Mr....ah...Scaglione. And I think you were here a couple weeks ago and I hope I have your name right. But would you give us your name and your...ah...residential address please.

JASON SCAGLIONE: My name is Jason Scaglione, I live at 3027 Glen Place N.W., Canton, Ohio. Ah...I just wanted to address a couple issues tonight. One was the increased police presence during the Ribs Burnoff was greatly appreciated. I think it made a huge impact. However, it can't stop there, we have the fair coming up. The fair is another big huge problem...

PRESIDENT SCHULMAN: Your just never satisfied are you. (Laughter)

JASON SCAGLIONE: No we're not and we never will be I don't think. (*Laughter*) Along with the fair I...I've brought this up before is that some trash cans along Fawcett Court. Maybe we need to start issuing...ah..littering citations, maybe we can get more money for more police that way, I don't know. But we've got to do something if it's as simple as placing some trash cans and that helps, so be it. I think it'd be a cheap...ah...attempt. Ah...we gotta keep the police presence up, there's still a lot going on. Ah...I know we spoke here a couple weeks ago and...ah...we were...ah...attempt. Ah...we gotta keep the police presence up, there's still a lot going on. Ah...I know we spoke here a couple of weeks ago and...ah...we were...ah... told that we were going to have a meeting on these issues that we do have. Ah...we haven't got anything set up yet but I encourage that we get that done quickly. We don't have a lot of time to continue to watch our neighborhoods go down. We need to address this quickly. We need to...we need to get something going to get it on record so everybody knows when, where...ah...these are gonna be discussed and we can get some things going here on some of these issues. I know, as a neighborhood we've made....made some progress but we still need the City's help.

PRESIDENT SCHULMAN: Good thank you very much Mr. Scaglione. And I'm sure that...I'm sure that meeting will be set up very shortly. Ah...but thank you for coming and I was only joking with you. Um...our

next speaker is James Smith. Mr. Smith could you give us your name and your residential address.

JAMES M. SMITH, SR: James M. Smith, Sr., 118 Fawcett Court N.W., Canton, Ohio. Uh...Mr. President, Councilmembers, thank you very much. Ah...I live in the same neighborhood as Jason and...and the whole front row here. We've...we've here trying to go ahead and get help from everybody as far as straightening our neighborhood up. Uh...we had an incident the other night, we talked about Section 8 housing at the last meeting. Gentleman that lives behind me, drunk, called the Police Department at 9:54, tell them, "He's screaming, he's yelling. He had a big stick he was beating on cars going by in the alley way." Eight minutes later, I thought it was ten, looked at the wrong clock, they said "It's only been eight minutes." Five minutes later the police show up, they look at the person saying "Wait over here." The lady said "This is my husband." "You got a lease agreement?" She brings out the lease, they...the Police Officers tell him "You need to take a walk." He goes to the gas station. Comes back twenty minutes after the Police leave and raise cane until 4:00 in the morning until he passed out on his front porch. But the Police said they would be back and forth keeping an eye out because they were on duty until 3:00. They never came back through. And if I keep calling, and I don't mind it, I was in the Marine Corp., I love adversity but I don't need no one coming up on my front porch because that's not the way to do it. That's not the chain of command and that's not what we as neighborhoo...neighbors want to do, just go ahead and through out the people because we're no better than them if we do that. But if a Police Officer says "I'm on duty until 3:00, they should be back around at least two or three times within that five hour period. The man never went back into his house. Secondly, we had set up a meeting, the Safety Director was out there with our Councilman after the meeting, he said he would meet with us last Saturday at 9 A.M. on the 9th. I went into work early, I finished up everything, I lost \$25.00 to \$50.00. The Councilman drove by and waived. If the Councilman sets up a meeting with us, I'd like for it to be put in the minutes so we can make him accountable for making an appointment with us and that he would be there when he says he's going to be there. Thank you very much.

PRESIDENT SCHULMAN: Thank you sir. Our next speaker is..ah...John Swartz. John...oh...Good evening, I know you've been here before.

JOHN SWARTZ: I have nothing but nice things to say. (Laughter) I live at...ah...239 Perry Drive N.W., in Canton. And...ah..I came back from Europe after two weeks going through Cities and checking architecture and whatever. And...ah...went down for the First Friday and I was so impressed and...ah...I had guests this weekend who were really impressed. In any case, I got the article from Forbes about how the place is dving and..ah...what we had set up, now it's on the City Hall site, is Canton Greats and we've got forty five of them, really outstanding people. One of which is a Pulitzer...we have two Pulitzers and what we just finished is a display in the old K of C Ballroom. Uh...Bill Tice suggested we use that in between the glasses and we have about maybe fifty of his illustrations. He worked for the New York World for eighteen years. And...ah...just an incredible man. He has the second oldest movie, achieved movie, at...ah...The American Film Institute. He got a patten for animation...ah..in 1916 but..ah...just an outstanding man and we're hoping to build this into a venue, which...ah..eventually might even be a...ah..McSorley's Tavern, there's the same thing in New York. I want to bring up something else, this is something I found in 1892 paper. Ah...I was working on the...the...ah...Pulitzer and in the 1893 he has a cartoon of the Courthouse with four requests, January 1st. One of them is, fix the streets and that's the thing I noticed, the streets are really beautifully done. More jobs, and we'll talk about that in a minute. The third thing was paint the Courthouse, whatever that meant. And...ah...fix the clock, which, you know the old clock on there. But anyway, in this one he comes up the...this was a fifty three page addition done by the Chamber and the...it's called the industrial addition, May 1892 and in there, they say we want more manufacturers here and gives reasons why this is the place to do it. But he also says among 32 reasons why this is the best location in the Country, this...I thought this was a great remark, "Thirtieth because no City in the world can show up more pluck, enterprise and be

sure you're right and then go ahead spirit than Canton." And I thought that was marvelous but anyway, he lists all the reasons why this is the great location, one of which is our water supply, which is nothing to what it is today and several things, the Fire Department and..ah...our beautiful City Hall, which is even nicer now as Mr. Schulman knows. And in any case...uh...this is something that we ought to re-do again. If the Repository could do this again....a fifty three page addition talking about what's really great about this place and inviting other manufacturers to come here. So that's basically what I want to say and congratulations to all of you who had so much to do with making the City as beautiful as it is.

PRESIDENT SCHULMAN: Thank you John. Thank you very much. Our last speaker is Mr. James Chester. Mr. Chester, good evening. James Chester, Sr., I'm sorry. Good evening, welcome.

JAMES CHESTER, SR: Good evening sir. Yes, my name is James Chester, Sr., I live at 2921 4th St N.W., and I love the sign there "The Year of Our Neighborhood" and that's why I came here tonight. I live right, also in the fairground area. After every fair event, everyone we have in the neighborhood. Um...I like it because it's close, I can walk there, or I take my car. After every event the whole neighborhood is covered with litter. Every event, from the rib burn off to the other festival, every year after every event, litter is all over the neighborhood and no one comes by to clean it up but me and the neighbors. Come to my house at night, there's people in my yard, throwing litter and couple of times, like them, I got angry and I want to do something not very nice but I held my peace. So who do I address to this issue? Now we're in the Year of Our Neighborhood, we try to keep our neighborhood looking real nice, after every event, is it the County? Is it the City? Is it me to take care of this issue? It's getting...it's not getting better, it's getting worse. You go down to 4th St right now in the neighborhood you'll find litter from...from the Stark County...from the rib burn off that's still there. And it's...it's getting out of hand. One day my son came by last week, he's about six foot five, at the time he came by I see a guy throw out of his car into my front yard, my son is not a Christian, my son acted up really...really bad, I had to hold him back. So before my son do anything bad to some body in my neighborhood would someone please address this issue? Thank you sir very much.

PRESIDENT SCHULMAN: Thank you very much. Well as I said Mr. Chester, we'll all be here after the meeting, we'd be happy to talk to you. We hear ya.

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: We're now under Miscellaneous Business.

MEMBER CIRELLI: Mr. President.

PRESIDENT SCHULMAN: Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Mr. President, I just thank...like to thank..ah...Law Director Martuccio for all the hard work that he did concerning the Resolution tonight of...um...the utilities. Uh..the research and what have you, it war...I was very, very pleased and very impressed sir and without your...ah...you, yourself and your department it would have been very difficult to say exactly what we wanted to say for the betterment of the community. So I want to thank you personally for that sir. Thank you very much.

PRESIDENT SCHULMAN: Thank you Member Cirelli. Um...Member West.

MEMBER WEST: Mr. President, um...piggybacking off of what Mr. Swartz said, that this is a great City and we have so many different heros...ah...that came through Canton, the City of Canton, besides myself... (*Laughter*) Um...we...ah...

PRESIDENT SCHULMAN: Member Casar are you ready to adjourn? (Laughter)

MEMBER WEST: But no, I wanted to..ah...of course this past weekend we had the O'Jay's Homecoming Celebration, it was an awesome event in downtown Canton. Um...but one thing I noticed...um...about the weekend and having the Shaw High School Band here that came from the Olympics and coupled with the fact that we had Reverend Pastor Vernon...ah...and GAK's Partnership. When they came down here before the event and we took them around the City, they had nothing but positive things to say about some of our worst areas that we think are the bad areas of Canton. They loved Canton and I don't know if that's the case with some of us. We gotta love Canton just as much as when they come to see our City. But as I was saying, there was so many people at that event from out of town, from Akron, Pennsylvania, California, New York, I mean and it was just an awesome event and I tell you, all those people that came loved Canton and I think we just need to showcase that more. Um...the other thing I wanted to mention was this was from the Dr. Martin Luther King Jr. Celebration Committee...um...on August 28, 2008 at 6 P.M., they will be doing a dedi...ah...excuse me, a celebration and..ah..they're going to, when we rename the street or not rename excuse me, designate...um...Cherry and Walnut as Dr. Martin Luther King, Jr. Memorial Corridor and they would like everyone to attend...everyone to attend. So if we all could be a part of that I would very, very much appreciate that.

PRESIDENT SCHULMAN: You want to repeat that please.

MEMBER WEST: On August 28th.

PRESIDENT SCHULMAN: Do you have a time?

MEMBER WEST: At 6 P.M. at Canton Central Plaza, so if we all could attend that, that would be a wonderful event.

PRESIDENT SCHULMAN: Thank you. Anything else?

MEMBER WEST: Yeah and I just want to thank all the City Leaders, Chris, for attending...ah...Safety Director and any other...any person that I have missed who came to the event this past weekend. It was a wonderful event. Thank you.

PRESIDENT SCHULMAN: Thank you Member West. Any other remarks?

MEMBER GRIFFIN: Mr. President.

PRESIDENT SCHULMAN: Member Griffin.

MEMBER GRIFFIN: Mr. President, first of all I'd like to thank...ah...the Safety forces for the fine job they did last weekend, last week for the ribs burn off, I patrolled the Ward periodically and..ah...everybody was thanking the bicycles and the traffic tickets that they were issuing and their presence, it was very appreciated. Also...um...I did contact the Service Director in regards to the trash boxes, he's out of town until the..ah..18th I believe. Anyway...ah...he will be approached on those boxes, I don't know what we can do but he will

know about it. In regards to last Saturday, I did go past, I saw you guys around the circle and...ah...I figured you were just having a meeting. Two weeks ago, it was announced, I have a note here from...ah...Safety Director Nesbitt. It says "Jim, I will state tonight that the meeting for Fawcett folks will be organized, it won't be able to be on Saturday, the reason being, that eight City Departments will have to be in...have to be present and Saturday will not work. Now I announced it and Mr. Nesbitt announced it, I'm sorry if you folks didn't hear it but...ah...it was announced. Also, I was with my sister on an errand and I saw you there and I greeted, I didn't know I was supposed to be there and...um...that is all I have right now. Thank you.

PRESIDENT SCHULMAN: Thank you Member Griffin.

MEMBER SMITH: Mr. President.

PRESIDENT SCHULMAN: Yes, Member Smith.

MEMBER SMITH: I'd like to say...ah...if it's any 4th Ward residents out there, from 8:00 to noon on this Saturday, will be a 4th Ward cleanup, it will also be posted in the paper where the large bins will be located and on the 31st, there will be a 4th Ward Community Picnic at Crenshaw Park. Thank you.

PRESIDENT SCHULMAN: Thank you Member Smith. Any other remarks? I..I just want to say one thing...um...I'm not going to defend the City of Canton, we don't have to, we know who we are and where we're going and we should be very proud. But just for everybody's edification. Um...there will be a letter to Editor to Forbes Magazine, from not only the City of Canton but from Northeastern Ohio to express their outrage at that story. That story was so unfair and so taken out of context that...ah...not only will Canton be represented but the entire Northeastern Ohio area will answer those charges. We...this is not a dying City, this City if is in renaissance and if, you know, and I'm just sorry that Mr. Lavin didn't have the courtesy as a former resident to come back and look at the things that have been done, ask the questions of you folks and the citizens of this City to know that this City is in renaissance. So, with that, Member Casar.

MEMBER CASAR: I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: Madame Clerk roll call vote please.
