Member Casar, the Ohio Revised Code generally prescribes that when the City no longer has need has need for municipal property that it bid it to the highest bidder for lease or sale for five times in the newspaper of general circulation. So, to answer your question, if this were approved, this could be challenged. It was written for other reasons but it could be challenged.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Thank you Law Director Martuccio.

MEMBER CIRELLI: Mr. Chairman.

PRESIDENT SCHULMAN: Member Cirelli.

MEMBER CIRELLI: Mr. Martuccio, I am a member of the organization, should I vote on this or not sir?

PRESIDENT SCHULMAN: Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Mr. President, I would....are you an officer?

CRYSTAL BYRD: Oh, thank you for having me. Before I get started, I would first like to thank Council President, Allen Schulman, Honorable William J. Healy II, Mayor, the Ward Councilmembers, the citizens of Canton and Ms. Mari Moss for this great opportunity. A little bit about myself, I've been assisting with PEACE T.V. for the past two years and my experience and expertise is in media and I've had the opportunity to transition from a young leader in the PEACE T.V. program to honor talent to Board President. Ms. Moss, the former Executive Director of PEACE T.V. has recently appointment me as the new Executive Director as she will be relocating to New York. And it's an honor and privilege to serve in this capacity, I accept the position and it is my duty to uphold the mission of the organization which is to empower the youth of Stark County by utilizing the media to reach them in positive ways. PRESIDENT SCHULMAN: And I do think Ms. Byrd that you do have large shoes to fill, so we thank you for your effort, we know you're going to do a great job, as did your predecessor. Thank you. Our next speaker and last speaker is Brenda Kimbough, Kimbrough, I'm sorry. Brenda, good evening. If you would give us your name and your residential address please.

BRENDA KIMBROUGH: My name is Brenda Kimbrough, I live at 614 7th St NE in Canton, Ohio.

PRESIDENT SCHULMAN: And good evening to you again.

BRENDA KIMBROUGH: And good evening esteemed Councilmembers. I have a concern and my concern is about AEP. AEP has decided that they were...the City has allowed this, to build a substation right in my front room door. I'm assaulted daily with noise of the equipment that they are using to put in information for this particular item. Some of the things that I am concerned about, where does it all end? My question is, alright, we've torn out an entire City block, you've taken a street up, out of the ground, you put poles up. I have to travel and everyone else in my neighborhood have to go around this whole project, which is adding, what, three tenths of a mile every time you go around this area. This is between 7th Street, 8th Street and Savannah which is being taken up. Now I was told that when they talked to me that they were not going to take any streets out or block off any streets in my neighborhood. This did not happen, not only did they take the street up but they pulled up all of the bricks and they put a pole right in the middle of it. I do have

pictures of all of this that I can make sure that you can see. Now, we've seen the destruction of trees, we've seen this open space now is going to be taken for the footers and the equipment that's going to come in. One hundred and fifty foot poles have been put in my neighborhood all around. Ten trees have been cut down, that's alone in my area on 12th Street which will be along Nimissilla Park. Some of them were diseased true, but the other five were not but they were all cut down in view of running this wire to this particular substation. Where does it all end? Now, not only are one hundred and fifty foot poles put in around my neighborhood and they put in about an access of what, two or three truckloads, they're also putting in footers, which means that there is going to be at least a hundred and fifty feet down in the ground. My question is where does it all end? Now that we have gas being at \$3.49 a gallon, having to travel around this just to get to our house. The beauty will be gone because once the structure is built and I have no idea how large it's going to be but I am so sure I will not be able to look downtown every again once it's built. And to top it off, they're closing this structure in, which means this whole City block will be controlled by bricks. And so now when I look out instead of seeing the lovely trees, I get to see a nice brick wall in the front of my area. Where does it all end? What are we going to leave for the next generation, we'll have more power but more power at the sacrifice of dead trees at the sacrifice of the beauty that would be for downtown. How much power do we need and where does it all end?

MEMBER KRAUS: I'd like to thank City Council and on behalf of St. Anthony's Parish, they sent us a nice letter thanking also for the support we gave them and the add that we took out in their 100th year anniversary and it will be on display in the Council office and I'm going to pass it around.

PRESIDENT SCHULMAN: Thank you Member Kraus.

LAW DIRECTOR MARTUCCIO: Mr. President.

PRESIDENT SCHULMAN: Law Director Martuccio.

LAW DIRECTOR MARTUCCIO: Thank you. I would like to take a moment to commend those in the audience who were in the cast and crew of Ragtime for lifting us up as youth, as older people, as races, and culturally. It took us to a great place. I want to commend Mari Moss for also taking us to good places and the work she's done with our youth. *(Applause)* Our loss will be New York City's gain but you'll come back. And we want to wish you every, every good fortune Ms. Byrd in your success in succeeding a good predecessor, we know you'll do the same.

LAW DIRECTOR MARTUCCIO: Thank you Law Director Martuccio, any other Miscellaneous Business? Member Casar.
