PRESIDENT SCHULMAN: We are now under Public Speaks, Open Forum we have, I believe four speakers signed up this evening. Just an acknowledgment, we appreciate you coming down, we appreciate hearing from you, we always do. But if you would just limit your remarks please to three minutes and if you have any further comments or information, we'll all be here after the meeting. Our first speaker is Hope Collins. Hope. You want Joe to do it? Really you do? Well I know but maybe you should do it. Okay Joe, come on up. Oh, you're both together. Would you give us your names and your residential addresses please.

JOE PAYNE: Hello everybody, I'm Joe Payne and I live at 2337 Winfield Way N.E., Canton, Ohio. And...

HOPE COLLINS: I'm Hope Collins, I reside in North Canton, 1684 Fallen Timber.

PRESIDENT SCHULMAN: Welcome.

JOE PAYNE: Thank you.

PRESIDENT SCHULMAN: It's always good to see you Joe.

JOE PAYNE: Thank you Mr. Schulman. We are actually out here to talk about our event this Saturday we're trying to have at the Southeast Community Center. From either 8:00 to 12:00 or 8:00 to 1:00 P.M. that is. It's ah...we're trying to have a Thanksgiving dance, party thing for our fund raiser for P.E.A.C.E. T.V. and we were just wanted to have your guys support on that because like, as many parties as we had and they all came out pretty nice, no one never had....we never had drama at any of our parties and like no fights never broke out because we...our youth and like the cops...our police they come out there and help us and like we try...we try actually with our best efforts to keep everything peaceful and try to actually get the gangs to combine at the parties and say "Just forget it, just have a good time." So we are just asking for you guys' support on that and I want to wish everybody a happy holidays and eat nutritious. (Laughter)

PRESIDENT SCHULMAN: Thank you Joe. Hope do you have anything to say?

HOPE COLLINS: Yeah, I just wanted to say that we should have our party because I mean most of our parties keep everybody of the streets because our parties be packed, so you know everyone is off the streets, you know. Instead of someone fighting or shooting, you know, I'd rather them be at our party having a good time than be out in the streets fighting each other. You know, because I've seen people from UNIT and RAID that gets together and dance together. I've seen it happen so, I don't see why anyone would try to stop that, I mean, especially, I mean, the City of Canton should want the kids to be off the streets instead of trying to stop our positive event that keeps them off the street. So I don't understand why they're trying to do that, so, that's all I have to say.

PRESIDENT SCHULMAN: Okay, thank you very much, thank both of you. And we appreciate your citizenship. Thanks Joe, thanks Hope. Our next speaker is a good friend of mine and all of ours, Pastor David Morgan. Pastor Morgan, happy holidays, welcome, if you can give us your name and your residential address.

DAVID MORGAN: If I give a name different from the one you've just given, would that surprise us? I'm David Morgan, I live at 922 27th St N.E. We do wish you the blessings of the season, all of you. I'm here tonight basically to speak about the traffic cameras, only to say to you, and I understand that you're entering a professional contract to nail out, or to bring forth a proposal that will have some detail to it. Please remember that your obligation for public safety need not necessarily include the transfer of public monies to private business. I worry when we begin to hire subcontractors to perform the legitimate services of Government. I fear that we will go the way of black water, kellogg brown and root and quite frankly ladies and gentleman, the American people have had enough of that in the last eight years. So, I would urge you as you bring together that contract and proposal to be very sensitive to wise use of public monies so that it really does become about safety and not nearly about the enrichment of a private corporation. Thank you.

PRESIDENT SCHULMAN: It's just a quick aside, I remember that Pastor Morgan and I were both trying to get this position through the Democratic Party and he gave a tremendous speech before the precinct committee people and I got up and I said "You know it's very hard as an attorney to follow a Pastor." And he said "Oh, if you only would, if you only would." (*Laughter*) Our last speaker is Dick Deitrick. I hope I've pronounced that right. Mr. Deitrick, good evening, happy holidays and if you'd...if you could tell us your name and your professional address or your address.

DICK DEITRICK: Hi I'm Dick Deitrick, I live on 144 Park Ave S.W. in Canton. And I spoke before and I'm the one person in my neighborhood that has a job and stuff. Anyway, I wanted to say something about that proposal for the traffic, what do you call it, I've come here to the meetings to watch what happens and I've seen people complain about, told about their great breeds of dogs that they had and how they sleep with their kids and stuff. And then everybody got up in arms because a Doctor moved into their neighborhood. In my neighborhood if a hoochie mama moves in, we're kinda happy (*Laughter*) because at least she's got a job, that's a dancer.

PRESIDENT SCHULMAN: Right.

DICK DEITRICK: Anyway, I'm tellin' ya, nobody questions me what I say, I just right write this stuff down. Anyway...

PRESIDENT SCHULMAN: Dick, did you start the holidays a little early? (Laughter)

DICK DEITRICK: No, no. I don't drink or smoke or any of that stuff Mr. Schulman, Esquire. Anyway, this thing about the traffic thing, I actually got nailed up in Cleveland, I was going to an appointment at the hospital up in Cleveland and I got nailed, it was so early in the morning, there was no traffic, nothing but the thing clocked me speeding or something and I thought that was so evil that there's no cops, no policemen, no anything around and I'm going a little fast to make sure I get to this appointment, which is pretty important and yeah, I was speeding but there wasn't anybody anywhere on the street and I got nailed for, it was....it just seemed so evil and so wrong. And if you want people to come downtown Canton and you have these little scumbag things hanging on all the lights and people are going to get nailed by, you know if you go thro.....roll through a stop sign, which I've...I know a lot of people and rode with a lot of people and I know a lot of people do these things and you're going to make people hate downtown Canton. They're going to...I avoid going near that rode on Cleveland every time I go there. And I'm just telling you how much I despise these things and that's just my me and my opinion, whatever my opinion might be worth.

PRESIDENT SCHULMAN: It's worth a lot, we appreciate it. Thank you.

PRESIDENT SCHULMAN: Thank you sir. And happy holidays again.

MEMBER CIRELLI: Thank you Mr. President. Question to the Administrator, well I guess the Mayor because Service Director Bernabei is not here. I believe we were doing some things with the sewage plant, am I correct on that or not sir?

PRESIDENT SCHULMAN: Mayor Healy.

MAYOR HEALY: Be more specific on what things you are referring to.

MEMBER CIRELLI: Well, alright, I'll tell you where I'm going with this. This I thought was rather a neat thing since everybody's thinking green and saving money. Akron, one Ohio City is using a biological process to turn sewage into energy and run a waste water treatment plant on it's own power. Experts say that

what's happening to Akron could spread quickly in Ohio and lead to other sewage plants generating power, not only for their own operations but also for the community. At the Akron waste water facility a biological process using tiny bacteria that consume organic waste and emit methane gas, which is captured and converted to electricity, the power has allowed the City to save about 15% on the plants electric bill. And I think that's something maybe we ought to look at in being....somebody said that we already do that so, maybe they could speak on that.

PRESIDENT SCHULMAN: Mayor Healy.

MAYOR HEALY: Thank you Mr. President. Councilman Cirelli, I appreciate you bringing that up. We actually have been looking into this since early in the year. We've had our....Tracy Mills from the Water Treatment Plant exploring that. We're going to be required to make changes, significant changes to our system because of EPA Regulations that are coming up. We've actually went up, as a group, toured the facility in Akron last summer. We put out a bid for a contract, or a service to...to...present to us the bids are going to be due in December, in a couple weeks and then we'll be able to take the next steps towards this. But, we're also exploring any other possibilities besides this, an aerobic digester, as opposed to an incinerator process that we use now. But we have a team of people on it and they're...they're working through the process. When we get our bids in December, we'll be much closer to knowing which direction we're going to go. But I can tell you that's an area we're very interested in and we've been working on for many months.

PRESIDENT SCHULMAN: Member Cirelli.

MEMBER CIRELLI: Thank you Mr. President. Thank you Mayor Healy. And I just thought it was something worth acknowledging, if we weren't doing that we should go in that direction. And then I just have one other thing, which I have a concern on because every Saturday, I do look at the Real Estate section. And in Canton, this last week, there was 25 property homes, more or less, transferred. Of those 25, 10 were transferred to LLC's or people doing business and then we wonder why we have some many rental properties within the City of Canton and I really have some concerns over where we're going in the direction, I think we have to address that and start to try and do a reversal on that. Thank you sir.

PRESIDENT SCHULMAN: Thank you Member Cirelli. Any other Miscellaneous Business? Hearing none, Leader Casar.

MEMBER CASAR: Mr. President, I move we adjourn.

MEMBER CARBENIA: Seconded.

PRESIDENT SCHULMAN: It has been moved and seconded to adjourn. Madame Clerk, roll call vote, please.

CLERK TIMBERLAKE: Twelve yeas Mr. President.

PRESIDENT SCHULMAN: (Gavel falls) Meeting is adjourned. Thank you very much, everyone be careful and have a good holiday.
