There is an amendment, and I want to read that amendment to you cause this is the meat and potatoes of the change in the Ordinance. The purpose of the amendment is to add language authorizing the City to enter into the chain of title, briefly, for Phase 2 of the site. This is a requirement for the type of TIF that would be established for the Phase 2 site. The TIF Ordinance passed pursuant to Ohio Revised Code Section 5709.41, in brief, in order to effectuate a 41 TIF the city must acquire the parcel or parcels to be exempted when the city is engaged in urban redevelopment. Mechanically speaking, this is typically accomplished by having the city momentarily enter the chain of title for no more than a few minutes by accepting title to the property and immediately reconveying the property back to the same owner. This is the meat... meat and potatoes of this Ordinance. This particular language was left out previously, and it's very important and vital to this Ordinance that this amendment be included in the Ordinance. Thank you.

PRESIDENT SCHULMAN: Any questions? There is a motion to amend per a copy before each member of Council. Any remarks? Hearing none, by voice vote all those in favor signify by saying aye. Those opposed no.
