Uh, and it's not ending anytime soon, so I suppose if there is some ability to donate to groups, I would certainly recommend that you do that because this is going to be something I don't think we've ever seen in our lives certainly. PUBLIC SPEAKS

PRESIDENT SCHULMAN: We now turn to Public Speaks. We have two speakers this evening. Uh, our first speaker is Nick Mussulin, Nick. Oh, I'm sorry. How are you? Good evening and welcome. If you'll give us your name and residential address, please.

NICK MUSSULIN: My name is Nick Mussulin. I live at 4120 Logan Avenue NW in the city of Canton. Some of you may recall I ran unsuccessfully for Council-at-Large last spring. Don't feel bad, I got over it the next day. What I didn't get over was the survey results that I submitted while I was campaigning. Distributed over a thousand surveys to Canton residents asking them what was important, twelve different categories, everything from streets and sidewalks to the Hall of Fame Village to downtown development, arts district, city parks, crimes, drugs, you name it. Not surprisingly, of all those tabulated, and there were quite a few returned with comments, number one and two were drugs and crime. Number twelve was the Hall of Fame Village. I made a promise at that time that win or lose I wanted to do something about that, and tonight I'm here to ask for your support. I been working on a program called The Stark Reality. If I may pass these around.

PRESIDENT SCHULMAN: Sure.

NICK MUSSULIN: Stark Reality is a program; there's a drug seminar scheduled for September 21st at Timken High School, downtown at Canton. You'll find in that poster that's being submitted, being passed around, the specifics of that. There are five pec... primary categories in this program, and they start with an introduction called, if I may, It's Time to Get Real. Next it's I Never Saw it Coming by Travis Bornstein. Travis is a father of a drug overdose victim, his son. The next was An Addiction Can Change Your Brain by Dr. Jamesetta Lewis of the Mercy Medical pain center, who will talk about the affects of the brain. Next we call it I Know an Adequate Now. A good friend, Frank Forchione, Judge Frank Forchione will address that part. The last part is I Can't Fight This Alone, Keith Hochadel from CommQuest. During the last six months I've talked to school superintendents, teachers, principals, policemen, mayors, just about everybody I could. Tonight I'm asking you for your support, not just saying yes, a nice idea, but to call your constituents to get them out there to attend this seminar. There's additional flyers, same content on these flyers is on the bro... on the poster. There's an e-mail on there and a phone number on there. You can contact me if you want more of them. I can send you PDF's. I can do whatever you need. I recently talked to SARTA, and SARTA I believe is going to assist in transportation throughout the county. One particular area, Minerva, called and they said they can't get up here because it's too far to go, they have 450 middle school students who want to hear this, so arranging to address that as well. Thank you for your time, appreciate it.

PRESIDENT SCHULMAN: Thank you for your time. We really appreciate what you're doing. (*Applause*) We wish you all the best, and you know we're gonna be behind you for sure, and having our own ideas. Thank you very much. Uh, our next speaker is Stephanie Sweany. Ms. Sweany, as always, welcome to Canton City Council. It's good to see you. If you'll step forward, though, for the record and give us your name and your residential address, please.

STEPHANIE SWEANY: Stephanie Sweany, I live at 817 5th Street NW, Canton, Ohio. Um, I'm here today to... unfortunately, I have a bit of a complaint. Um, I'm usually here talking in support of some kind of legislation that you are moving forward, but I've just seen one too many incidents of this particular thing that I'm going to be speaking about. So, I'm a downtowner, I moved downtown last year, and it took me a very long time to find an apartment to move downtown. I had to break through a lot of barriers to get to downtown, to find a place that allow me to have my animals, so I take a lot of pride now in living in downtown Canton. I tell all my friends they should come move to downtown Canton. I tell all my friends, come out and visit downtown Canton. However, I have not seen incredibly great coordination between the city and the sanitation department in respects to the green space. There was an event last Saturday, and the organizers of the event, they did a really good job of making sure that all the trash was put in bins and tidally put into bins, so on their end they did a great job. However, there were at least three to four trash bins out there that were overflowing with trash and boxes that were out there until Tuesday evening. When I went by, I had a meeting downtown at 7:30 in the morning on Wednesday, and I went past and walked through the green space on Wednesday morning, they were gone. So from Saturday until that time those boxes and that trash was out there, and we're investing a lot of money into the green space, and it just seems to me if we want this to be... I mean, in my mind this project is going to be the center of... of downtown, and if we want downtown to be the center of the county with this project, we should just be a little more on the up and up with making sure that space is cleaned off. Um, I was actually out there on Monday to film a video because I'm bringing a conference to Canton, and I wanted to spotlight downtown and I had to move my location for the video because we had all this trash out there, so I'm just asking for maybe a little bit quar... a little bit more coordination from the city and the sanitation department and they're respect when there is events happening in

the Kresge lot. And that's all.

PRESIDENT SCHULMAN: Thank you very much.

STEPHANIE SWEANY: Thanks.

PRESIDENT SCHULMAN: Thank you. (*Applause*) And I take it something will be done soon rather... sooner rather than later. Uh, that concludes public speaks.
