We do have some special guests that will be introduced in a minute or two. Now, with a quorum being present, the Chair calls this meeting of Canton City Council to order. Roll call vote, please, Madame Clerk. (ADMINISTRATIVE ASSISTANT WENSEL TOOK ROLL CALL)

These are our Young Boys to Young Men Mentoring Academy. Um, they age from 10 to 16, and what we do is, we try to make sure that we want to empower our youth and we want to get them to experience everything besides just learning how to shoot a football...er, shoot a basketball, throw a football, and many of those other things. We want to exper...let them experience other types of careers and professions. We're in our third week, so we may have to leave early because they have school tomorrow, so uh, and we're going to go out in the hallway and grab a bite to eat, so we're glad to be here and thanks for having us. (*Applause*).

Uh, I'm going to talk...just a few things about the uh, the income tax that might be...er...that you're going to try to put on the ballot. Uh, how do you think this is going to affect any new businesses or businesses that are here in the city right now as to them wanting to come in and locate? Or small businesses that are just barely making it, for their employees to have to pay more tax? That's one issue. Uh, this might be for, uh, Deputy Mayor Fonda. How much money has the Canton City given away to organizations in the past two years? I'm just curious. I know there's records kept as to how much money we've given away. The uh, other item is...in order to get jobs in the city, it would be nice if we could get some big jobs, good paying jobs. And, has anybody got with the

uh, Timken Company to see if by some remote chance that if they would uh, bring some of the bearing operations back into the city of Canton. That's all. Thank you.

PRESIDENT SCHULMAN: Thank you, as always. Thank you for your remarks. *(Applause)*. Our last speaker is...er...our next speaker is John Alge. Good evening, Mr. Alge, welcome to Canton City Council. If you'll come forward and give us your name and your address please.

JOHN ALGE: Good evening, everyone. My name is John Alge and I reside at 1600 27th St. NW, here in Canton, and I would like to say that uh, I am a strong supporter of the proposed city income tax increase. It's something that our community has needed for quite a while. I believe it's been 37 years since it was last raised, and uh, and we have entities that need funded and I just want to say that I strongly support that and hope that this Council will pass it then. Thank you.

PRESIDENT SCHULMAN: Thank you very much.

JOHN ALGE: You're welcome. (Applause).

PRESIDENT SCHULMAN: Our last speaker is Brenda Alge...Kimbrough, I'm sorry. I was thinking about the last speaker...

Anyhow, I (Inaudible) talking about let down, put down, and let's get down. So, first of all, we're at the let down. We're at the let down of a very long, cold snap, that lasted quite a while with record cold, but I'm going to applaud you all for cleaning the streets and keeping them clean and making it safe, and keeping our kids okay as they went to school. That was a good thing. Now, it was let down to have to stay inside when it was that cold but that was the safe thing to do. Next thing, you have the put down. Gotta put down some salt. I know it cost us a little money, extra, because we hadn't planned on having such a snap so early, so I understand we're gonna have to have a little more cash in the till. Now I want to talk about getting down. When we get down to when you, uh, talk about things going on in the city. I have one question for you. My question is, how long is it going to take for that turn-around to be put in on the north...northeast end of town and the corridor project. Right now they've got it torn up over by Maggiore's and uh, on...right by the Cooks Lagoon, and I'm questioning it because it will be a real tremendous let down to many people if we can't have that fishing rodeo in June. So, I'm trying to get proactive early, to find out if we can find out if that's going to be a problem for our programs coming up. And, I always work with Stark Social Workers Network. We've been doing that for over 20 years. We just would not like to disappoint all those families who come down and fish for free. Thank you. (Applause).
