This is a whole lot different. Uh, vacant homes, from out of town people that own 'em, don't do nothing with them, the said they're tear them down, they're still standing. That's pretty simple, straightforward. You can't get nothing...it seems like, on that. Even though we do try, and we do a good job. But, uh, this other one here, about the...the uh, renting of houses to whoever, and I know they're gonna be checked out, but there's still a...there's still a couple flaws and a couple little cracks, and all you gotta do is let one of those happen and you're gonna have a some bad publicity on your hands, especially for Hall of Fame Week or for the Firestone Opening. Thank you.

PRESIDENT SCHULMAN: Thank you very much. *(Applause)*. Our next speaker is Jonathan Lalewicz. I hope I pronounced your name sir...

JONATHAN LALEWICZ: That was pretty close, yeah.

PRESIDENT SCHULMAN: May I...what is your name?

JONATHAN LALEWICZ: It's uh...my name is Jonathan Lalewicz.

PRESIDENT SCHULMAN: Thank you very much. Welcome.

#### JONATHAN LALEWICZ: Thanks.

PRESIDENT SCHULMAN: If you'll give us your name and your residential address, please.

It's something that a lot of the residents of Market Heights are concerned about, as we have uh...we have struggled for...not struggled, but we have successfully maintained our residential neighborhood, uh, because of the effort of the neighbors and rentals are something perhaps looked down upon, but uh, it's something that neighbors are worried about. Um, also, with the Air B&B issues, it's something just uh...this March in Cleveland, the Councilman has proposed putting a moratorium on new Air B&B houses because they found that the mechanism they have for enforcement doesn't exist. So, they have all these Air B&B houses and Cleveland laid out a plan for regulating them, but they found that actually enforcing the regulations has proven...how do you enforce them? It's complaint driven as it is right now, but that has not...uh...not worked out very well for them. So, I'd just like you to strongly consider...uh...the Air B&B issue and all the effects it'll have on the Canton neighborhoods. I realize it's 2018 and people may wish to rent out their house, but...uh...there's lots of pros and cons and I just hope that this Council will strongly consider the neighborhoods and the effect that it'll have on your constituents. Thank you.
