If everyone could please turn their cellphones to vibrate and we are still encouraging social distancing because obviously COVID is not going away any time soon. With a quorum being present, the Chair calls this meeting of Canton City Council to order. Roll call please, Madam Clerk.

MEMBER BABCOCK: Second.

PRESIDENT SHERER: It's been moved and seconded to excuse Member Hall from this evening's meemeeting. Are there any remarks? ...Hearing none, roll call vote please.

NO REMARKS ROLL CALL 11 YEAS, 0 NAYS

CLERK WOOD: Eleven yeas, Mr. President.

PRESIDENT SHERER: The motion carries and Member Hall is excused from this evening's meeting, and we want to wish him a speedy recovery. Tonight's invocation will give... be given by Ward 5 Council Member, Robert Fisher. If you would all please stand and remain standing for the Pledge of Allegiance, please.

The regular meeting of Canton City Council was held on December 20, 2021 at 7:00 P.M. in the Canton City Council Chamber. The roll call was taken (see above) by Clerk of Council, Jill M. Wood. The invocation was given by Ward 5 Council Member, Robert Fisher. The Pledge of Allegiance was led by President Sherer.

PRESIDENT SHERER: Thank you, Member Fisher. I would like to welcome Mr. Tim Dunbar to his very first meeting of Canton City Council. Welcome, Tim. No pressure, right? (*Laughter*)

ROLL CALL 11 YEAS, 0 NAYS

CLERK WOOD: Eleven yeas, Mr. President.

PRESIDENT SHERER: The motion carries and Ordinances 4 through 7 are a legal part of your agenda.

# **PUBLIC HEARINGS**

PRESIDENT SHERER: We are now under Public Hearings and we have no Public Hearings for this evening.

### **OLD BUSINESS**

PRESIDENT SHERER: We are now under Old Business and there is no Old Business for this evening.

## **PUBLIC SPEAKS**

PRESIDENT SHERER: We are now under Public Speaks and we have two speakers for this evening. And our first speaker would be Mr. Chris Mack. Mr. Mack, could you please step to the podium, and I would like to remind our speakers that you do have three minutes, but could you... Mr. Mack, could you please step to the podium, give us your name and residential address, please.

CHRIS MACK: Yes. Uh, my name is C. Mack and I am here representing my father who is Henry C. Mack who has lived at 2430 4<sup>th</sup> Street... uh for... and in Canton, Ohio for 60 years at that address. And uh... um... any more information before I address the topic?

PRESIDENT SHERER: No. No, you got the floor.

CHRIS MACK: Thank you so much. First of all, happy holidays to everyone. Uh, certainly wish everyone a tremendous holiday season. Uh, the topic that I'd like to address very briefly today is to reduce the gross vehicle weight of vehicles that are going up and down Belden Avenue NE. Uh, today, roughly every five to ten minutes during business hours, a commercial truck, including tractor trailers, go up and down that street, not only spewing diesel fumes continuously, but uh... but also going right through the middle of a residential neighborhood. Uh, as rationale for why that change would take place, it is... that is an LMI minority community. Uh, typically LMI minority communities have overborn the brunt of either commercial traffic or of highway traffic. As we're all aware, if we go back to the Cherry Avenue extension, if we go back to Route 30, uh tho... there were minority businesses in the southeast part of Canton that... uh, that have never recovered from those two projects. And so again, this will help to alleviate that burden, the environmental burden, that is carried by that neighborhood. Second, as we look at that neighborhood on Belden Avenue and Georgetown, is Belden Elementary School. Belden Elementary School, uh... is... uh, let me say it's highly unusual to have commercial trucks and industrial power lines right next to an elementary school. And so right next to the school there are industrial power lines. We're not... that's not the recommendation for tonight, but again the recommendation is to reduce gross vehicle weight to three tons or less going up and down Belden Avenue. Uh, third, just in my personal experience, and let me say that I have managed retail banks across North America, and almost in every institution I've been in there... twenty percent of those retail banks would have been in LMI minority communities. This is the first time that I have ever seen an elementary school which has both industrial power lines and tractor trailers next to an elementary school. And so as we think about the reputation of Canton, as we think about our ability to protect our kids, this is a recommendation that one, will protect the children of Canton, particularly those that attend Belden Elementary School and second, will reduce the pollution that comes from those diesel fumes that... uh, from the com... tractor trailers going up and down Belden. And so uh... that's... that's the three points of rationale for why I would ask that we move... we

move forward with that. And having done more research on this topic, even if this group were to agree to the recommendation, when I looked into the Ohio Code of Regu... uh, Regulations, in 5577 and in 4513, it also appears that the County Commissioners would also have to agree to this recommendation before it could be put into force and before it could be enforced. And so I just wanted to make sure that the... the body was aware that the Stark County Board of Commissioners, by Ohio law, would also have to agree to the recommendation. Um... uh, those... that concludes my comments. I don't know if um... if uh... Chris Smith wanted to add anything, uh... uh, but that concludes my comments.

PRESIDENT SHERER: Um, usually during Public Speaks... Speaks, Mr. Mack, there's no questions that are asked...

CHRIS MACK: Okay.

PRESIDENT SHERER: I would encourage you, if you can stay for the meeting, you're more than welcome and we'd be more than happy to point you in the right council members that represent that area.

CHRIS MACK: Thank you so much.

PRESIDENT SHERER: You know, absolutely. But I want to thank you for coming tonight.

CHRIS MACK: Thank you again and happy holidays to all.

PRESIDENT SHERER: Yeah. Happy holidays to you too. Alright, our next speaker is Mr. Ted Johnson. And Mr. Johnson, you're more than welcome to remove your mask when you're speaking. If you could please state your name and residential address, please.

TED JOHNSON: Okay. Uh, my name is Theodore Johnson. I reside at 332 Freedom Avenue NE, Canton, Ohio. I've been there over 35 years. Um, for those of you that know, Tuscarawas Avenue is really Lincoln Highway. The Lincoln Highway was one of the earliest transcontinental highway routes for automobiles across the United States of America. Conceived in 1912 by Indiana entrepreneur, Carl G. Fisher, and formally dedicated in October 31<sup>st</sup>, 1913. The Lincoln Highway runs from Times Square in New York City to Lincoln Park in San Francisco. It is officially recorded the length... uh, the entire length to be at... in 1913 to be 3,389 miles. I feel Canton is missing a fantastic opportunity to be able to generate more tourism and attract more people if they were to try to improve the look of the Lincoln Highway coming through Canton. Right now the Lincoln Highway is a blight. It's horrible looking. If you want to know what it really should look like, look at Canton Aluminum because they've got the nice lights, they got uh... um... it's landscaped nicely. I don't know if Canton did that or um... Canton Aluminum did it, but we need more of that. By updating the landscaping and the lighting, the overall look of East Canton, we can promote highway... and use the Lincoln Highway as a gateway to Canton to facilitate restaurants, shops, um... the... um, all the things that are in downtown Canton. And right now there's a lot of groups that come down the Lincoln Highway, and I just think that Canton need to promote that. And... but right now it's not suitable for that. It does not look very well. Thank you.

PRESIDENT SHERER: Thank you, Mr. Johnson, and Merry Christmas.

TED JOHNSON: Merry Christmas to you also, and all of Council.

PRESIDENT SHERER: Thank you.

CLERK WOOD: An Informal Resolution respectfully submitted by Canton City Council on this 20<sup>th</sup> day of December, 2021. WHEREAS, Christine Schulman (affectionately know to us all as "Chrissy") is a 1974 graduate of Oakwood High School. From there she attended Ohio State University where her major focus was Social Studies Education; and WHEREAS, Chrissy was employed by her family business, Can-Do-Promotions, for 20 years, and through her work with the company, met the love of her life, Allen Schulman. She also served as President of the Canton Advertising Club; and WHEREAS, Being an advocate for the welfare of her community, Chrissy served on the Aultman Women's Board and chaired the Angel Auction and Fashion Show for several years to raise money for various Aultman Hospital Projects; and WHEREAS, Chrissy was appointed by Justice Andy Douglas to the Board of Grievances and Disputing for the State of Ohio; and WHEREAS, On May 13, 2019 Chrissy was unanimously appointed as Council-at-Large for Canton City Council and won her election to the position in November that same year. MEMBER SMUCKLER: Little known facts. I went to high school with this lady. So those of you that say I'm old, go ahead and tell her. (*Laughter*) Second... second little known fact. Who introduced you to Allen?

MEMBER SCHULMAN: You did.

MEMBER SMUCKLER: Yes, I did. Allen was running for Congress, and he'll be the fir... he would have been the first one to tell you, and he got beat by a golf caddy. And I took Chrissy up to the office and they hit it off right away and I drifted away until, what was it, May 25<sup>th</sup>, 1996? Then when they were married and I was lucky enough to be at the wedding. And it's a tough job being an elected official. Uh, Chris and I drove the neighborhood several times and tried to augment what the councilman was doing in the ward, but... um, she's very proud of her neighborhood and she likes it there and plans on staying there. And we appreciate the contributions she made as a council person-at-large. And with that, I'd like to say thank you and we all need more help in this community. What you did for Aultman Hospital. I know you've helped my wife at the Domestic Violence Board. Had to say that, right? Or I'd get in trouble. But we're looking for other ways that you can help this community now. Thank you.

MEMBER SCHULMAN: I have other comments to make, but I'll wait till Miscellaneous Business 'cause I don't have my script in front of me. Thank you very much. (*Inaudible*)... all of you. (*Applause*)
