PRESIDENT BATES AYLWARD: Thank you. The motion carries and Ordinance #26 has been adopted. Leader.

MEMBER MARIOL: Madam President, I move we adopt Ordinance #27.

MEMBER BABCOCK: Second.

PRESIDENT BATES AYLWARD: It's been moved and seconded that you adopt Ordinance #27. Are there any remarks? ...Hearing none, roll call vote, please.

NO REMARKS ROLL CALL 11 YEAS, 0 NAYS

CLERK WOOD: Eleven yeas, Madam President.

#### #27 ADOPTED AS ORDINANCE NO. 6/2025

PRESIDENT BATES AYLWARD: Thank you, Madam Clerk. The motion carries and Ordinance #27 has been adopted.

#### ORDINANCES & FORMAL RESOLUTIONS FOR THIRD AND FINAL READING

PRESIDENT BATES AYLWARD: We are now under Third Readings uh ... for Ordinances and Formal Resolutions and we have none for this evening.

#### **ANNOUNCEMENT OF COMMITTEE MEETINGS**

PRESIDENT BATES AYLWARD: We are now under Announcement of Committee Meetings. Our next meeting date is January 27, 2025 and Committee will start at 6:45 P.M. We will have no meeting next Monday in remembrance of Martin Luther King Day. So, once again, our next meeting is January the 27<sup>th</sup>, 2025.

#### **PUBLIC SPEAKS**

PRESIDENT BATES AYLWARD: We are now under Public Speaks, and we have six speaker this evening. Most of you have been with us before, but please step forward, give us your name ... your full name, your residential address and um ... please speak into the microphone so that we can hear you. We would apprecitate it.

MEMBER MORRIS: Madam ... Madam President.

PRESIDENT BATES ALYWARD: Oh, I'm sorry ... oh I didn't have one, okay. Alright, before we get to that, I'm sorry, we do have one Committee Meeting next week. Which I was unaware of. Mr. Giavasis, as you've joined us just in time, what time will Finance meet next week?

MEMBER GIAVASIS: Finance will meet ...

PRESIDENT BATES ALYWARD: Or the week after.

MEMBER GIAVASIS: Madam Chairman, Finance will meet at 6:45, at that time.

PRESIDENT BATES ALYWARD: Thank you. Alright, thank you Madam Clerk and thank you Member Giavasis. Um ... our first speaker of this evening is Mr. Roger Gates. Mr. Gates

ROGER GATES: My name is Ro ... can you hear me?

PRESIDENT BATES ALYWARD: Yeah, yeah.

ROGER GATES: My names Roger Gates, my address is 611 Smith Avenue Northwest, Canton, Ohio, 44708. There you go. I come tonight, I haven't been here in a minute. Let me tell you the truth, my lawyer told me to come here and speak tonight. And the reason why he ask me to come here is because my community is afraid. Many of them are afraid because they've presented evidence to the police, the police dismiss it, even though it's on video but they say it don't exist. They tell us that our rights are not being violated, they are being violated just to keep us (inaudible) from questioning it. We the people are coming for answers for these things, just these things okay? Most people would rather side with the gang members in the neighborhood than to call the Canton City Police Department because then they end up in court. They end up with fines, they end up with cost, retaliation from speaking out or just being just ... just to be concerned. Second of all, why don't we just take all these lots here in town, instead of dragging it out over months, and why won't you just ... why don't you go to the county court house and auction them off. The \$6,000 waterlines that you guys are charging to put in, why don't you use that money for that? That is our money. Do you guys ... Are the taxes being paid on that property? Whose it being paid by? It's being paid by us right? We need help out here, we're starving, we're getting hungry out here. The houses that you're bringing in and you want to go build these houses, you're not going to bring the people in with the crime that's in the neigborhoods. You can't do it, unless if you were born and raised here & understand what's going on. You're not going to see it. My mom, Hall of Shame, my brother, my son, yeah we're all here. We've had enough, there's a reckoning coming for everybody. We're gonna start to demand these answers and you guys are going to have to answer the tough questions. Where are the jobs that's going to support us to buy these houses? I make \$15 an hour and I got sick last week and I had to miss a week of work. I have no medical insurance, I can't afford the \$500, I paid \$20 for my perscriptions, and I'm out a whole week's worth of wages. But I'm taxed to the point where my feb ... my taxes are due on Febuary 14th, doubled. And you know what's sad about it? Because we've been talking to the people in the community, this isn't coming from me. The people in the community are afraid. Not only the ... about the gang members. But to call the Canton City Police Department, and that's why your crime satistics may be down. Go out into the

neighborhood, look at me okay? I'm about to change and you're going to see a transformation in me because, I do this to survive in the hood. I've had enough of it and I'm not the only one so you guys are elected officals better realize that it's going to happen. And go head and laugh, you think it's funny? Well then, why laugh? Is it a joke? Am I a joke? Am I ignorant?

MEMBER GIAVASIS: No, I'm listening.

ROGER GATES: Thank you. We the people are coming.

PRESIDENT BATES ALYWARD: Thank you, Mr. Gates. (applause) Our next speaker is Ms. Skylark Bruce. Ms. Bruce.

SKYLARK BRUCE: My name is Skylark Bruce and I live at 2216 Bollinger Avenue Northeast. So many questions after hearing Police Chief, John Gabbard speak duing the Committee Meetings this evening. After previous Committee Meetings when he gave an update, he did not remain in the Council Chambers and thus heard none of the committee ... thus heard none of the community feedback related to his remarks. I don't see him, here now, either, which is not encouraging. Number one, homicides and felonies assaults. Does this include homicides committed by police? And dog attacks and drop kicks committed by police officers? If, or when, Officers Burch and Schoenegge are convicted of homicide in the death of Frank Tyson, will the number of homicides in 2024 be officially up to 6? Number 2, sometimes studying what crimes have in common can give clues as to how to address the issues going forward. For example, if two burglaries became homicides and the motive was fencing items to sell for funds to feed an addiction, than putting funds not into policing but into addiction recovery can prevent both future homicides and future burglaries. This is what many people mean when they say things like "defund the police". Number three, other times money put into education that includes effective training and conflict resolutions for indiviuals can prevent bar fights that end in a death. Number four, homa ... Domestic Violence Shelters and resources that keep survivors and abuser alive. Before domestic violence shelters existed, the rates of homicide to end the abusers life were more common, when the victim had not other way out. A fictionalized example is the 1980's book based on a true event, The Burning Bed. Shifting the police's focus to their core mission may help with the response times that Council Member Morris mentioned. Another way to recruit quality officers is by holding abusive officers accountable. Officers see when nothing is done and nothing is done and nothing is done to rain in the worst impluses of their colleagues. And it impacts where they choose to stay. Justice for Frank Tyson and Zachary Forenash.

PRESIDENT BATES ALYWARD: Thank you, Ms. Bruce. Our next speaker is Mr. Justin Nicely. Mr. Nicely. (applause)

JUSTIN NICELY: Hang on a second, let me get on your guys level maybe y'all will listen a little bit. My names Justin Nicely with the Canton Hall of Shame, single father, and a community advocate. Formerly a resident over at the Jackson Sherrick Community. I now reside at Massilion, Ohio. Now you've heard the famous phrase, you go around making people mad enough and you're doing them wrong, eventually you're going to run across the right one. Whelp, nice to meet you. Now, I told you had a problem before anymore lives are taken unnecessarily and you didn't listen to me. I told you that you guys had a rouge police department, several members of your highest chairs are guilty of criminal acts, you didn't listen to me. I told you that you kidnapped my children and that they were abused and trafficked and then given back to sweep everything under the rug with no follow up and to this day, not a single agency involed has let me file legitimate grievance over any of it and you still don't listen. Now, I have a trial, pro se, tomorrow to which I'm going to setting a presentate for fathers everywhere in this State, so go ahead and knock you off of your pedistools that you stand on, to think that you're to high and mighty to have a dialog with me. You guys are small potatoes in the fight

that I'm in so ... uh ... I would hope you would pray for a postive outcome because it's going to be the determining factor of what monster you're going to be facing from now on. Mark my words when that every single one of you tonight that I'm going to call out, will come to the table and you will have a dialog with me about what you did, and why you did it. Oh, I can promise you, I'll be on every single one of you guys like fly is to crap stink and you will not get a moment of peace until you do. And to put a damper on the Canton City playbook of the retaliation, I got the legal backing and an army of like minded, equally sick and tired of y'all's behavior and just as pissed off about the complaceny for y'all to do anything to change it. Every first Friday, every Town Hall, every City Council meeting, every public event, we're going to be there engaging you live for everyone to see. Every time you try to do a positive puff piece in the news we're shutting it down with the truth of how you don't care. Anytime we see your officers in the public who are on our radars a plague of being ... uh ... community to the serve ... that they serve, we're going to go ahead and hold them accountable since you won't. You're not going to be able to fart without us being able to have it on film by the time we're done and that's just the start of what we're about to bring. Jason Reece I'm letting you know, why do I need a lawyer when you're looking at the person that can sit there and hold you liable at anytime. I just wanted to see what you would do and you and your cowardest constituants did not disappoint. Conspiracy to charge, records destruction, intimidations and threats, title eighteen violations. What you think everyone that's (inaudible) just stupid to the laws and doesn't think that we can file motions of injuctive compliance to get our records that we requested? Now I wouldn't want to do man, I'll probably wreck you in court anyways. Now, um .... Andrea Perry, you're going to answer why you had me and my councils ambushed by your Gestapo and then you lied in 911 when you call out ... you know that he can call out your resignation. Chief Gabbards going to answer on why he sent his members of the public up to be attacked and why we can't file legitimate grievances with any of our offices. Madam Chair, you're going to answer for your numerous rights of violations agasint the public in filing false reports against us over it. And Mr. Mayor, you are going to hold up to your word and you're going to give me a helluva a lot better than what the hell you've been giving me right now because this ain't it. 2025 is all of y'all's year of rekoning this year and I promise you we are going to get the accountabliy that we deserve, and we the people are going to have some type of relevance. And if you don't think that's truth, just mark my words and remember this day because I'm going to show you that me, as a person, as a father and ... and ... and just as a person in general, has enough relivance that y'all should have done something. (applause).

PRESIDENT BATES ALYWARD: Thank you, Mr. Nicely. Our next speaker is uh ... doesn't have a last name but it says Brandi. Is there a Brandi here? You'll need to give us your last name please and your residential address.

BRANDI SMITH: Smith.

PRESIDENT BATES ALYWARD: Okay.

BRANDI SMITH: I live in Canton, Ohio.

PRESIDENT BATES ALYWARD: Okay.

BRANDI SMITH: I have been having police corruption and retaliation because I reported this robbery guy. Now they say I ... and this has been happening since October of '23 and now they say I'm crazy, mentally unstable and paranoid. And I have always ... the police have always refused to do nothing. Have me mentally health flagged for no reason and they have no grounds to say that and no proof and they need to take that off. You all are creating a bigger lawsuit on the city and police, have my family living in constant fear. The guy came back again the night after Christmas. I've sent many videos of this to the police and they have contradicted themselves and the police reports saying they see this is happening but I'm crazy and paranoid.

Which I am not and they cannot prove it. And reports I've made they have lied on, even made up stuff that has never happened. The Chief and Safety Director, Andrea Perry, refuse to uh ... answer to my calls and emails many times that I've left and respond or anything. Sent out the gang unit to my house without contacting me, putting my family in more danger. Been told from the police that my no trespassing and private property signs don't mean anything, and they do. Even to the police, the police don't even know the laws, but I do. (applause).

PRESIDENT BATES ALYWARD: Thank you. Thank you, Ms. Smith. Um ... our next speaker is Rich Dyer. Mr. Dyer, yes.

RICH DYER: Can I give each one of y'all a copy of these?

PRESIDENT BATES ALYWARD: Uh ... sure uh ...

RICH DYER: To look at.

PRESIDENT BATES ALYWARD: Can ... can somebody grab that for him. Thank you. Thank you. Go ahead Mr. Dyer.

RICH DYER: My name is Rich Dyer, I live at 933 Dueber Aveune here in Canton. April 30, 2023, 11:45 p.m. That's the day I want you all to remember. I dang sure do and so does my wife and then my twelve year old, austistic son. This the day that the Canton City Police Department raided my home over a Texas child support arrest warrant. Not signed by a Governer, not signed by anybody legitimate, but by a corrupt judge that sent it through some type of electronic service up here. Texas ... and she was out of Texas, Janelle Havercamp. Fifteen to twenty officers bombarded my home, threathen my wife, tramatized my family, and shot me not once but twice, from point blank, six inches away, with a twelve gage, long barrel shotgun. Not once but twice. And you know what I was wearing? And I had my hands up, I had my phone in my hand recording, um, recording them. I was in my boxers. Officer in front of me, officers behind me. You can clearly see my hands. But two cowards, Anthony P Angelo and Cody (inaudible) Smith shot me. Shot me in the back. How corrupt does that get? Now you look at the piece of paper right there, I had almost thirty officers at my house. You tell me why that police report don't have more information on it, of what happened at my house. My child is tramtized for life. Me, I'm going to survive. This right here, that's what happened, big hole through the leg right there. Guess what? I'm still standing right here and I'm coming after the City of Canton Police Department, the Legal Department, the Federal Law, I'm going to make sure I shut you down. The City of Canton Police Department needs to be shut down. They're corrupt, the ... the Chief is a coward. He wouldn't even stay here. What kind of Chief of Police is that? He come in here and preach to y'all and everything else but he won't stay here and hear the public. That's unforgivable. He shouldn't even be the Chief. If he was here I'd tell him myself, gladly, 100%. We don't put up with this crap down in Texas. I've had forty guns drawn on me before when I was a youngster. Guess what? I didn't get shot once. You want to know why, cause they're polite, they actually ask. They don't just shoot to kill and walk away. I'm coming for you city, I promise you. Remember my name, you got the piece of paper right there in front of you. Not just me, but the people that I have in Washington and the individual that you took two shots at and tried to kill, I'm coming for you. And Mr. Mayor, you still haven't returned my calls. Seven months now, you're not a Mayor.

PRESIDENT BATES ALYWARD: Thank you, Mr. Dyer. (applause) And our fin ... our final speaker tonight is Mr. Daniel Gates. Mr. Gates

DANIEL GATES: My names Daniel Gates and I live in the U.S. Consitutional Republic. Let's talk about the roads. (*laughter*) I love talking about the roads because you guys suck at them. You suck at plowing them, you

suck at salting them. I had to dig me and my neighbors section of the road out, just so we can get out of the road so we can get where we need to go, so we can supply to the people that we need to feed with the little that we have. You guys don't have any plans at all for the roads, do you? Because you guys just keep tearing them up with the plows. You let ... the winter is going to tear everything up that you guys have worked on cause you guys do shoddy work. Now the bigger issues is your police department. I've caught your police sitting in the park for hours, I've caught them in um ... Highland Park sleeping in their vehicals. You wonder why there's poor response times? This is why, because you got lazy cops that don't care because you guys won't hold them accountable. They can get away with murder, literally. The other thing is, is you guys are a bunch of red coats. You guys are a shame to the republic, dividing people with democracy, being Libertarians. It's just a real shame that ... you know ... we've come to you as a community, not with just our ... our experiences, but we speak for people that won't come and speak to you because they do not believe in you. You are the leadership they did believe in you when they voted for you but now they're not believing in you because everything you've said, you've turned your back on. You did the opposite of. You guys aren't protecting and serving. The Supreme Court has already ruled that you are not here to protect us, you're here to serve the law and we can see that with you thin blue line on your new crusiers. We see it. You guys are a low goat gang, that's what you are. You're one of the largest and now it looks like you guys are preparing to be blown up uh ... assault a on ... uh ... from us ... like it's crazy how the budget goes to show. You just follow the money and what you guys are so paranoid about. A bunch of people who want to be free, hold you accountable for the things that you guys are suppose to do, it's not unreasonable. It's what you signed up for. (inaudible). We the people. (applause)

### **MISCELLANEOUS BUSINESS**

PRESIDENT BATES AYLWARD: Thank you, Mr. Gates. We are now under Miscellaneous Business. Is there any Miscellaneous Business that any of the Members would like to bring before the body?

MEMBER COOKS: Yes, Madam President.

PRESIDENT BATES ALYWARD: Yes, absolutely.

MEMBER COOKS: I just like the commend um ... the adults or significant others for bringing the young people in today um ... the children. It was just very refreshing reciting the National Anthem with them and just staying in tune with them. So, thanks to you who brought the young people in.

PRESIDENT BATES ALYWARD: Thank you very Ms ... Member Cooks. Anybody else have anything for Miscellaneous Business? Oh, go ahead Member Chris Smith.

MEMBER SMITH: Uh ... yes I would just like to invite each and everyone of you to the um ... Dr. Martin Luther King program, which is going to be held on Monday the 20<sup>th</sup> at the Southeast Community Center at 12, noon.

PRESIDENT BATES ALYWARD: And what time is that going to be?

MEMBER SMITH: 12, noon.

PRESIDENT BATES AYLWARD: Okay, make sure I heard that. Okay, any other Miscellaneous Business? Alright, Leader Mariol.

MEMBER MARIOL: Madam President, I move we adjourn.

MEMBER BABCOCK: Second.

PRESIDENT BATES AYLWARD: It's been moved and seconded to adjourn. Um, roll call vote, please.

NO REMARKS ROLL CALL 11 YEAS, 0 NAYS

CLERK WOOD: Eleven yeas, Madam President.

PRESIDENT BATES AYLWARD: (Gavel falls) We are adjourned. Thank you.
