Re: Licensing requirement for tree cutting, removal, treating, and pruning contractors

### Attention all tree cutting, removal, treating, and pruning contractors:

Due to changes in the Canton City Codified Ordinances, Chapter 917 (Trees), all contractors performing tree cutting, removal, treating, or pruning work on any tree located in the Canton City limits on public and private property are required to be licensed by the City. This license must be renewed annually and requires the contractors provide proof of various insurances, a bond, professional certifications, references, and a fee. The application can be secured at the Engineering Department or on the city web site, www.cantonohio.gov/engineering.

This licensing requirement has been implemented to better manage our urban forest and to protect the health and safety of both Canton residents and visitors. Failure to secure this license will result in enforcement action and fines. Canton will begin enforcing the new requirement on July 1<sup>st</sup>, 2014.

While Canton does not currently require a project specific permit for contractors to cut, remove, treat, or prune trees, a project specific permit is required for anyone to plant trees in the public right-of-way along streets and sidewalks in the City of Canton. Both license and permit can be secured at the Engineering Department.

# Requirements for Tree Removal, Treating, or Pruning License

Per Canton City Ordinance (Article 917), a City of Canton Tree Trimming license is required for any person engaged in tree trimming work on cityscape trees within the Canton City limits.

License fee:

\$100.00

#### Requirements:

A performance bond in the amount of five thousand dollars (\$5,000.00).

A certificate of insurance showing the applicant is covered with liability insurance (minimum amount of five hundred thousand dollars; \$500,000.00) and property damage insurance (minimum amount of two hundred and fifty thousand dollars; \$250,000.00).

Must show evidence of Workers Compensation coverage.

Copy(ies) of any tree care certification or training documents.

All License Applicants must meet with and demonstrate to the City Arborist their ability to remove, treat, and prune trees in accordance with City Ordinance 917.09 in a safe and professional manner as recommended by ISA and ANSI standards prior to being issued a license. Demonstration of this may be required on a City owned tree at the direction of the City Arborist. Based on the contractors ability to satisfy the requirements of City Ordinance 917.09 per the City Arborist, the Applicant may be issued a license to perform all or individual functions of removal, treating, and/or pruning.

Any unauthorized pruning or negligent pruning of City owned trees or trees in the public right of way will be considered a violation, subject to a fine as codified in the City of Canton Ordinance (Article 917.99).

Penalty shall be one hundred fifty dollars (\$150.00) per offense and violators will be required to pay for tree replacement.

Each day the violation continues without being addressed shall be considered a separate offense.

A permit must be secured through the City Arborist to plant or remove a tree in the Cityscape Program District.

If the principal will do the work in compliance with Chapter 917 of Canton Codified Ordinances under the supervision of the City Arborist and to the approval of the Director of Public Service, and will guarantee his work for a period of one year (1) from and after the date of completion and will conform in all respects to the rules and regulations which may from time to time be established by the Director of Public Service, or City Council, in relation to tree cutting, pruning, treating, or removing then the above obligations shall be null and void, otherwise it shall remain in full force and effect.
